The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Frontier Electronic Systems Corp. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Frontier Electronic Systems Corp. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Frontier Electronic Systems Corp. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks.

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Frontier Electronic Systems Corp. 401(k) Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Frontier Electronic Systems Corp. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment

information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion—

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 and 2023

Note 1 – Description of the Plan

The following description of the Frontier Electronic Systems Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering eligible employees of Frontier Electronic Systems Corp. (the Company) who are 18 years of age or older. The purpose of the Plan is to encourage and assist employees in accumulating retirement savings. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

Administration: The trustee, Fidelity Management Trust Company (Fidelity), has the overall responsibility for the Plan. This includes the power to interpret the provisions of the Plan and to determine questions concerning eligibility, participation, and benefits and such other powers and duties as are necessary to the operation and administration of the Plan. The 401(k) Plan Committee determines the appropriateness of the Plan's investment offerings and monitor investment performance. The Company pays essentially all of the administrative costs of the Plan and serves as the Plan administrator.

Contributions: Participants may make voluntary contributions to the Plan, not to exceed 100 percent of a participant's total annual compensation, up to the annual limitations imposed by the Internal Revenue Service (IRS). Plan participants age 50 and older are eligible to make a catch-up contribution after maximizing the total elective deferral contributions allowed by the IRS. Rollover contributions from qualified plans are allowed by the Plan and are 100 percent vested.

The Company's matching contributions equal 100 percent of the first three percent of eligible compensation and 50 percent of the next two percent of eligible compensation for all participants who have made contributions to the Plan.

The Company may also make annual discretionary profit-sharing contributions to separately established rate groups under the terms of the Plan, subject to satisfaction of one or more nondiscrimination tests set forth under Section 401(a)(4) of the Internal Revenue Code (IRC) of 1986, as amended from time to time and the regulations promulgated there under. To qualify for the discretionary profit-sharing contribution, the participant must earn at least 1,000 hours of service and be an employee on the last day of the plan year. The Company declared a discretionary profit-sharing contribution of \$147,485 and \$108,420 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts: Each participant's account is credited with the participant's contributions, the Company's matching contributions, and an allocation of (a) the Company's discretionary profit-sharing contribution, if any, and (b) investments results. Participant accounts are charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant

earnings or account balances, as defined. The benefit to which a participant is entitled is limited to that benefit which can be provided from the participant's vested account balance.

Investment options: Participants are allowed to invest in a variety of investment choices, as more fully described in the Plan's literature. All choices vary in types of investments, rates of return, and investment risk. Participants may elect to have all or part of their account balances and future contributions transferred from one fund to another or in any combination. Participants may change their investment options at any time. Participants may also elect to invest all or a portion of their account balances in self-directed brokerage accounts offered through the trustee. A self-directed brokerage account receives all the income it earns and bears all the expense or loss it incurs.

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms may not exceed five years unless the loan is for the purchase of a primary residence. Loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 2 percent. The interest rates on the notes at December 31, 2024 ranged from 5.25 to 10.50 percent. Principal and interest are paid ratably through payroll deductions. Participants should refer to the summary plan description for more information.

Vesting: All participants are immediately vested in their own voluntary contributions and Company matching contributions plus actual earnings or losses thereon. Participants vest in discretionary profit-sharing contributions at a rate of 20 percent per year of service and are 100 percent vested after six years of service. Participants should refer to the summary plan description for more information.

Benefits paid to participants: Upon termination, death, retirement, or other reasons, a participant will receive a distribution equal to the value of his or her vested account balance, as defined in the Plan, in the form of a lump-sum distribution or in installments over varying periods. Hardship withdrawals are available, subject to restrictions as defined by the Plan. If, at the time a participant is terminated, their account balance is less than \$1,000, it will be automatically distributed to the participant in a lump sum. If a terminated participant has a balance between \$1,000 and \$5,000, it will be transferred in a qualified individual retirement account for that participant. Participants should refer to the summary plan description for more information.

Forfeited accounts: Forfeited non-vested accounts are used to either reduce employer contributions or pay administrative expenses of the Plan. Forfeited non-vested accounts were \$7,758 and \$609 at December 31, 2024 and 2023, respectively. During 2024, employer contributions were not reduced from forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's Executive Committee to make estimates and assumptions that affect the reported

amounts of assets and liabilities, and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the participants account and are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Participant notes receivable considered to be in default are reclassified as distributions based upon the terms of the Plan document.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule of Assets (held at end of year).

Benefits paid to participants

Benefits are recorded when paid.

Administrative expenses

Administrative expenses of the Plan are paid by the Company or, at the discretion of the Company, may be paid with forfeitures. The expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

Risk and Uncertainties

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Management has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

Note 3 – Information Certified or Provided by the Trustee

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the Fidelity Management Trust Company, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate.

Fidelity also certified to the completeness and accuracy of \$3,110,184 of net appreciation in fair value of investments, \$1,367,973 of interest and dividends related to the aforementioned investments, and \$23,874 of interest income on notes receivable from participants for the year ended December 31, 2024.

Note 4 – Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value.

The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Registered investment companies are valued at the quoted market prices for identical assets in active markets for the shares held by the Plan at year end.

Self-directed brokerage accounts: Self-directed brokerage accounts are valued at the closing price reported for each respective account, which approximates fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 – Income Tax Status

The Plan adopted a volume submitter profit sharing plan with a cash or deferral arrangement sponsored by Fidelity. The volume submitter plan has received an opinion letter dated June 30, 2020, from the IRS as to the volume submitter plan's qualified status. The volume submitter plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income examination for years prior to 2021.

Note 6 – Plan Termination

The Employer may amend or terminate the Plan at any time. Any such termination or amendment shall be effective at such dates, as the Employer shall determine. In the event of termination of the Plan, the value of the participants' accounts attributable to the Employer's contributions become fully vested to the participants.

An amendment may affect participants' interests in the Plan at the time thereof as well as future participants' interests, but may not diminish the interests of participants' accrued benefits as of the effective date of such an amendment.

Note 7 – Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and self-directed brokerage accounts managed by Fidelity, who serves as the Plan's trustee. These transactions qualify as exempt party-in-interest transactions.
