Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Eagle Painting & Drywall, Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Eagle Painting & Drywall, Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Supplemental Schedule Required by ERISA**

The supplemental schedule of Form 5500, Schedule H, Line 4i is presented for purposes of additional analysis and is not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to

the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**A. Plan Description**

The Eagle Painting & Drywall, Inc. (the "Company") established Eagle Painting & Drywall, Inc. 401(k) Profit Sharing Plan (the "Plan") for the exclusive benefit of all eligible employees and their beneficiaries with the intention to provide a measure of retirement security. The effective date of the Plan and Trust is January 1, 2019 with the effective date for the cash or deferral portion of the Plan October 1, 2019. The participants should refer to the Adoption Agreement of Non-Standardized Profit-Sharing Plan for a more complete description of the Plan's provisions. A pre-approved plan was adopted by the provider Siegel Actuarial Consulting, Inc. and approved by the IRS on March 31, 2014.

*General* – The Plan is a defined contribution plan covering all employees of the Company including employees of Eagle Lath and Plaster, Inc. who have attained age 21 and is credited with at least 1,000 hours of service. The participants entry date is semiannual coincident with or next following satisfaction of the eligibility requirements. The union employees and nonresident aliens with no U.S. source income are not eligible to join the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA).

*Contributions* – Each year, participants may elect to reduce their compensation by a specific percentage or dollar amount and have that amount contributed to the Plan on a pre-tax basis as a salary deferral. Such election will also apply to irregular pay (e.g., bonuses). The employee deferrals in any taxable year may not exceed a dollar limit which is set by law. The contribution limit for employees who participate in the plan is \$23,000 and \$22,500 for 2024 and 2023, respectively. The law imposes a maximum limit on the amount of contributions (excluding "catch-up contributions") that may be made to the account and any other amounts allocated to any of participants' accounts during the Plan Year, excluding earnings. Beginning in 2024, this total cannot exceed the lesser of \$69,000 or 100% of the annual compensation and \$66,000 during 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution Plans. Participants direct the investment of his or her contributions into various investment options offered by the Plan. The Company's maximum elective deferral is based on a discretionary percentage, determined by the Company in a nondiscriminatory manner, of each tier of a Participant's Elective Deferrals or flat dollar amount allocated on a uniform basis to all Participants, as determined by the Company. The maximum elective deferral that is matched cannot exceed 4% of compensation per Plan Year.

*Participant accounts and allocation* – Each participant's account details the following contributions and allocations: (1) Participant's contribution; (2) the Company's contribution; (3) Plan earnings, including the allocation of associated administrative expenses. These allocations are based upon the respective contributions. The basis of the participant's benefit involves the participant's vested account. Any discretionary or profit-sharing contribution is made annually to participants employed on the last day of the Plan year.

*Vesting* – Participants are vested immediately in his or her contributions plus actual earnings. The Company vesting is based upon the number of years of continuous service. After 5 years of continuous service, the participant is fully vested.

Payment of Benefits – Upon termination, based on death, disability, or retirement – the participant will receive a lump-sum amount distribution. Termination of service for other reasons, the participant with a vested interest may receive a lump-sum distribution. The participants are allowed to withdraw the account balance prior to their employment termination under certain conditions specified in the Plan. The plan will make a mandatory distribution if the account balance is \$1,000 or less. The distribution will be made as soon as administratively feasible. The participants become 100% vested in all their accounts under the Plan if they die or become disabled while still an employee. If the participant remains employed past the Normal Retirement Age of 65, they may generally defer the receipt of benefits until actual employment termination. In such an event, benefit payments will begin as soon as feasible at the participant’s request, but generally not later than age 70 ½ year of age.

Forfeitures – Upon termination, the non-vested portion of a participant’s account balance is forfeited. The non-vested portion of your account will be forfeited and used to offset plan expenses or may be used to reduce the employer or matching contribution. The forfeiture takes place as of the end of the plan year, in which participants receive the final (complete) distribution of distributable benefits. The balance of forfeited nonvested accounts totaled \$6,820 and \$11,864 and were used to offset employer contribution to the plan for the year ended December 31, 2024 and 2023, respectively.

Plan Termination – The Company may elect to terminate the Plan or termination may occur based on certain business transactions. Upon termination, the Plan provides for the immediate one hundred percent (100%) vesting of the nonforfeitable interest in all of an affected Participant’s account balance. Notwithstanding the effective date of the termination, the Trust will continue until the entire Distributable Benefit of each Participant has been distributed.

Participant Loans – The plan does not permit loans from any source.

Expenses – Certain expenses of maintaining the Plan are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investments-related expenses are included in the net appreciation of the fair value of investments.

**B. Summary of Significant Accounting Policies**

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”)

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value. Quoted market prices are used to value investments. Mutual fund share prices are required by law to be determined each business day to reflect the current market price of the fund’s securities. Mutual fund share prices are released to wire services for publication through NASDAQ. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the ex-dividend date. See note H for discussion of fair value measurements.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Litigation matters – The Plan sponsor is a defendant in a number of legal actions. Although there can be no assurance as to the ultimate disposition of these matters, it is the opinion of management, based upon the information available at this time, that the expected outcome of these matters, individually or in the aggregate, will not have a material adverse effect on the results of operations or financial condition of the Plan sponsor or the Plan.

Payment of Benefits – Benefit payments are recorded when paid.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The amount of excess contribution liability at the end of the years December 31, 2024 and 2023, amounted to \$14,172 and \$24,126 respectively. The Plan distributed the 2023 excess contributions to the applicable participants during the year 2024.

**C. Tax Status**

The Internal Revenue Service (IRS) determined that the Company’s Non-Standardized Prototype Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). On March 31, 2014, the IRS informed the provider Siegel Actuarial Consulting, Inc. by letter regarding the determination. The Plan’s administrator believe the Plan is in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan’s financial statements. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**D. Parties-in-Interest**

The parties-in-interest include fiduciaries or employees of the Plan and any person who provides services to the Plan, or an employer whose employees are covered by the Plan. The Company is a party-in-interest and the contributions remitted by the Employer are considered party-in-interest transactions. The Plan's assets are held by Capital Group American Funds, and Capital Bank and Trust Company (CB&T) provides directed trustee and custodial services to the Plan. Wilshire Advisors LLC and Primerica provided investment advisory services to the Plan and Siegel Actuarial Consulting is the third plan administrator. Certain administrative functions are performed by employees of the Plan Sponsor, who receive no compensation from the Plan. The total administrative and advisory services expenses amounted to \$7,369 and \$6,679 during the years ended December 31, 2024, and 2023, respectively, and are paid by the Company on behalf of the Plan.

**E. Information prepared and certified by the custodian**

Under the Department of Labor's regulations, certain assets and related information held by a bank, trust company or similar institution, or an insurance company, that is regulated and subject to periodic examination by a state or federal agency does not have to be audited, provided the Plan administrator exercises this option and the institution holding the assets certifies the required information. Capital Bank and Trust Company (CB&T) has provided certification as to the completeness and accuracy of the investments presented in the accompanying statements of net assets available for Plan benefits as of December 31, 2024 and 2023, and in the statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023. The accompanying supplemental schedule also includes investments information certified by Capital Bank and Trust Company (CB&T) as being complete and accurate.

**F. Fair Value Measurements**

Generally accepted accounting principles establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Capital Bank and Trust Company (CB&T) is a federal savings bank with trust powers formed for the primary purpose of providing directed trustee or custodial services to a variety of retirement plans that invest primarily in American Funds. CB&T is a non-depository bank and provides no commercial banking services.

CB&T employs a market approach — using price and other relevant information generated by market transactions — to value each of the investments held in a plan’s trust account and included on trust statements.

The plan may invest in mutual fund shares. Mutual fund share prices are required by law to be determined each business day to reflect the current market price of the fund’s securities. Mutual fund share prices are released to wire services for publication through NASDAQ.

Capital Bank and Trust Company investment in American Funds mutual fund(s) is classified as Level 1 according to ASC 820 hierarchy.
