## Independent Auditor's Report

### The Board of Directors Watts Healthcare Corporation Money Purchase Plan

#### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Watts Healthcare Corporation Money Purchase Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).



- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTE 1      DESCRIPTION OF THE PLAN**

The following description of the Watts Healthcare Corporation Money Purchase Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**

The Plan, which became effective April 1, 2003, is a defined contribution pension plan covering all employees of Watts Healthcare Corporation (WHC) who have completed at least 1,000 hours of service during a consecutive twelve-month period and attained a minimum age of 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The amount of annual contributions to be made with respect to any particular participant by WHC shall be equal to 5% of the participant's eligible compensation, as defined in the Plan agreement. WHC is the sole contributor to the Plan, and all of the Plan's administrative costs are paid by WHC as the Plan Administrator. Contributions by WHC are designed to fund the Plan on a current basis.

Annual additions, as defined, to each participant's account may not exceed the lesser of \$69,000 or 100% of the participant's compensation for 2024 and \$66,000 or 100% of the participant's compensation for 2023.

**Participant Accounts**

Each participant's account is charged or credited with the contributions, net earnings, gains, losses and expenses as well as any appreciation or depreciation in the fair value of investments. For assets in a participant's account that are accounted for as pooled assets or investments, the allocation of earnings, gains and losses of each participant's account shall be based upon the total amount of funds so invested in a manner proportionate to the participant's share of such pooled asset or investment. For assets in the participant's account that are accounted for as segregated assets, the allocation of earnings, gains and losses from such assets shall be made on a separate and distinct basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

A Plan participant shall become vested in his or her participant account under the following vesting schedule:

**Vesting (Continued)**

A participant is 100% vested after five years of service or upon death, disability, or retirement.

**Payment of Benefits**

Participants are entitled to receive 100% of their account under the Plan upon reaching the normal retirement age of 65. Participants are also entitled to 100% of their account when they become disabled.

On the distribution of benefits due to retirement, termination, or any other event, benefits may be distributed to the participant in various methods. The methods depend on the participant's marital status, as well as the election the participant and the participant's spouse make. All methods of distribution have equivalent values.

**Investment Options**

Participants may direct employer contributions, as desired, in any of several investment options held by the trustee and may change their investment options anytime.

**Forfeitures**

If a participant's employment with WHC is terminated under certain conditions, the participant will forfeit the non-vested portion of his or her account. Amounts forfeited by participants will be recorded in the forfeited non-vested accounts, which will be used to offset future employer contributions.

The changes in the Plan's forfeiture account balance for the years ended December 31, 2024 and 2023 are as follows:

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**NOTE 2      SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of its assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates made.

**Investment Valuation and Income Recognition**

The Plan's investments in pooled separate accounts are stated at fair value. Fair value is the price that would be received if an asset is sold or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurement.

The annuity contract is stated at contract value. Contract value is the relevant measurement attribute for fully benefit-responsive investment contracts. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 4 for discussion of investments at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on accrual basis.

**Net Appreciation (Depreciation) in Fair Value of Investments**

Realized and unrealized appreciation (depreciation) in the fair value of investments is calculated based on the difference between the fair value of the assets at the beginning of the year, or at the time of purchase for assets purchased during the year, and the related fair value on the day investments are sold with respect to realized appreciation (depreciation), or on the last day of the year for unrealized appreciation (depreciation).

Realized and unrealized appreciation (depreciation) is recorded in the accompanying Statements of Changes in Net Assets Available for Benefits as net appreciation (depreciation) in fair value of investments.

**Benefits Paid to Participants**

Benefits are recorded when paid.

**Administrative Expenses**

Non-investment costs and administrative expenses are paid by WHC, which is a party-in-interest. These expenses, which are not reflected in the accompanying financial statements, constitute exempt party-in-interest transactions under ERISA. Fees paid by the Plan participants to the third-party administrators for administrative expenses amounted to \$6,225 and \$4,611 for the years ended December 31, 2024 and 2023, respectively.

**NOTE 3      FAIR VALUE MEASUREMENT**

The Plan has adopted Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. This framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**NOTE 3 FAIR VALUE MEASUREMENT (CONTINUED)**

Pooled separate accounts: Valued on a net unit value basis as determined by the custodian on the last business day of the Plan year. Net asset value is quoted by the funds as derived from the fair value of the funds' underlying investments. In 2024 and 2023, the underlying investments of the Plan's pooled separate accounts consist solely of investments in mutual funds registered with the Securities and Exchange Commission. The trustee may make adjustments to achieve a price believed to be more reflective of fair value.

The preceding method described above may produce a fair value calculation that may not be indicative of a net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 INVESTMENTS AT CONTRACT VALUE**

The Plan has an annuity contract with Mutual of America Life Insurance Company (Mutual of America). The funds held in the Interest Accumulation Account of Mutual of America's General Account are credited with the Current Rate of Interest as determined by Mutual of America. Mutual of America reserved the right to change the interest rates applicable to the amounts held in the annuity contract at its discretion. The annuity contract meets the definition of a fully benefit-responsive investment contract and, accordingly, is reported at contract value. The contract value equals the accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals.

The investments in annuity contract are presented in the Statements of Net Assets Available for Benefits at contract value. As of December 31, 2024 and 2023, the Plan's investments in annuity contract amounted to \$1,529,655 and \$1,699,973, respectively.

**NOTE 5 FINANCIAL INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified by Mutual of America, the custodian of the Plan. The Plan Administrator has obtained certifications from the custodian that information provided to the Plan Administrator by the custodian related to the Plan's assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule related to the following:

- Investments, as reflected in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023;
- Investment activity, as reflected in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023;
- Investment information disclosed in Notes 3 and 4 to the Plan's financial statements; and,
- Investments, as reflected in Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024.

**NOTE 6 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Plan investments consist of pooled separate accounts and an annuity contract issued and managed by Mutual of America. Mutual of America is the custodian and third-party administrator of the Plan and, therefore, the transactions in these investments, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

WHC provides to the Plan certain accounting and administrative services for which no fees are charged.

**NOTE 7 INCOME TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed WHC by a letter dated December 27, 2004, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**NOTE 7 INCOME TAX STATUS (CONTINUED)**

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 RISKS AND UNCERTAINTIES**

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**NOTE 9 PLAN TERMINATION**

Although it has not expressed any intent to do so, WHC has the right under the Plan to discontinue its contribution at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become one hundred percent (100%) vested in their accounts and the net assets of the Plan will be allocated among the participants and their beneficiaries after payment of any expenses chargeable to the Plan, in accordance with the provisions of ERISA.

**NOTE 10 NEW LAWS AND REGULATIONS**

On December 29, 2022, the Setting Every Community Up for Retirement Enhancement 2.0 Act of 2022 (SECURE 2.0 Act) became law. The new law makes changes to include provisions intended to expand coverage, increase retirement savings, and simplify and clarify retirement plan rules. SECURE 2.0 changed the retirement plan rules for long-term, part-time employees. The 401(k) plan requirement to allow employees to contribute elective deferral was expanded to 403(b) plans.

For plan years beginning in 2024, if an employee has three consecutive 12-month periods with more than 500 hours of service in each, the employee must be eligible to enter the plan, and the period of service was reduced from three to two consecutive 12-month periods, for plan years beginning after December 31, 2024. The Plan will implement this legislative change and plans to formally execute the required plan amendments reflecting their implementation by the deadline, which is December 31, 2026.

**NOTE 11      REGULATORY MATTERS**

On December 8, 2023, the DOL concluded a review of the Plan covering plan years 2018 through 2022. As a result of the review, a penalty was assessed in connection with those plan years. Management implemented corrective actions during the applicable years to address the issues identified. Based on its evaluation, management has determined that the matter has no impact on the Plan's financial statements as of and for the years ended December 31, 2024 and 2023.

**NOTE 12      SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events to December 31, 2024 to assess the need for potential recognition and/or disclosure in the financial statements. Such events were evaluated through August 26, 2025, the date on which the accompanying financial statements were available to be issued. Based upon this evaluation, management determined that no subsequent events required disclosure or adjustment to the accompanying financial statements.
