To the Plan Administrator of the Milton CAT 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed audits of the accompanying financial statements of the Milton CAT 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 - Description of the Plan:

The following description of the Milton CAT 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a. **General** - The Plan is a defined contribution plan covering all employees of Southworth-Milton, Inc. and its commonly controlled affiliate, Milton Rents, Inc. (collectively the "Corporation") who are age eighteen or older and who are not covered by certain collective bargaining agreements, or who are co-op or temporary employees. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

As further discussed in Note 11, effective February 1, 2023, Tri Point Construction Layout, Inc. 401(k) Plan merged with and into the Plan and ceased to exist as separate plans. In addition effective August 15, 2023, The Duke Company Inc. 401(k) Plan merged with and into the Plan and ceased to exist as separate plans.

- b. **Contributions** - Participants may make contributions to the Plan based on a percentage of compensation up to the maximum percentage of compensation permitted by law. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a common/collective trust fund as investment options for participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 6 percent of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. Employer contributions to the Plan are based on the Plan document and vary according to the group that the individual employee belongs to.
- c. **Participant Accounts** - Each participant's account is credited with the participant's contribution and allocations of (a) the company's contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or fund balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. **Vesting** - Participants of the Plan are immediately vested in their contributions plus actual earnings thereon.
- e. **Benefit Payments** - On termination of service due to death, disability, or retirement, participants may elect to receive either a lump-sum distribution or annual installments if the participant's account is greater than \$7,000. A participant may also request a withdrawal upon attainment of age 59½. The Plan allows for hardship withdrawals.
- f. **Notes Receivable from Participants** - Under the terms of a loan provision, participants may borrow up to 50 percent of their vested account balance up to a maximum of \$50,000. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Notes fund. Loan terms range up to five years, unless it is for the purchase of a primary residence, in which case it can be up to ten years. The loans are secured by the balance in the participant's account and bear interest at rates varying from 5.25 to 10.50 percent. Principal and interest are paid ratably through payroll deductions.
- g. **Forfeited Accounts** - At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$-0-, respectively. At the option of the Company, forfeitures may be used to reduce future Company contributions to the Plan or for the payment of Plan administrative expenses. During the years ended December 31, 2024 and 2023, \$-0- of forfeitures were used to reduce employer contributions, respectively.

Note 2 - Summary of Significant Accounting Policies:

- a. **Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting, as required by Accounting Standards Codification ("ASC") 962, Plan Accounting - Defined Contribution Pension Plans, including investment valuation and income recognition. The Plan year is January 1 through December 31.
- b. **Investment Valuation and Income Recognition** - The Plan's Investments are reported at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. The change in the difference between market value and cost of investment is reflected as net appreciation (depreciation) in fair value of investments in the periods in which such changes occur. Gains or losses from the sale of investments are determined on the average cost basis.

Note 2 - Summary of Significant Accounting Policies - Continued:

- c. **Use of Estimates** - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.
- d. **Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.
- e. **Payment of Benefits** - Benefit payments to participants are recorded when paid. There were no participants or beneficiaries, who have elected to withdraw from the Plan, but have not been paid as of December 31, 2024 and 2023.
- f. **Operating Expenses** - All expenses of maintaining the Plan are paid by the Corporation. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.
- g. **Subsequent Events** - The Plan has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

Note 3 - Fair Value Measurements:

Financial Accounting Standards Board ("FASB") *Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted market prices for similar assets or liabilities in active markets; quoted prices for similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are used to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 3 - Fair Value Measurements - Continued:

Mutual funds: Valued at the daily closing price as reported by the fund. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and categorized as Level 1.

Common collective trust fund: Valued at the net asset value ("NAV") of the units held by the Plan. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The portfolio strives to maintain a stable NAV of \$1 per share although there is no guarantee it will be able to do so. See Note 4, "Common Collective Trust Fund" for more information on the Fund. NAV is determined to be contract value, the value at which participants ordinarily transact. This practical expedient would not be used if it is determined to be probable that the Fund will sell the investment for an amount different from reported net asset value.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no unfunded commitments as of December 31, 2024. Participant level transactions take place daily. Plan level liquidations require notice to Fidelity and could result in the Plan's investment in MIP being placed into an investment only account for up to 12 months.

- (b) Common collective trust fund strategy seeks to invest in fixed-income securities and/or bonds to maintain a net asset value of \$1 per unit.

Note 4 - Common Collective Trust Fund:

The Fidelity Managed Income Portfolio ("MIP") investment is a collective trust fund sponsored by Fidelity Management Trust Company ("Fidelity"). The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant NAV of \$1 per unit. Distribution to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable net asset value of \$1 per unit; although there is no guarantee that the Fund will be able to maintain this value.

Participants ordinarily may direct the withdrawal or transfer of all or a portion of their investment at contract value. Contract value represents contributions made to the Fund, plus earnings, less participant withdrawals and administrative expenses. The Fund imposes certain restrictions on the Plan, and the Fund itself may be subject to circumstances that affect its ability to transact at contract value as described in the following paragraphs. Plan management believes that the occurrence of events that would cause the Fund to transact at less than contract value is not probable.

Restrictions on the Plan - Participant-initiated transactions are those transactions allowed by the Plan, including withdrawals for benefits, loans, or transfers to noncompeting funds within a plan, but excluding withdrawals that are deemed to be caused by the actions of the Plan Sponsor. The following employer-initiated events may limit the ability of the Fund to transact at contract value:

- A failure of the Plan or its trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
- Any communication given to Plan participants designed to influence a participant not to invest in the Fund or to transfer assets out of the Fund.
- Any transfer of assets from the Fund directly into a competing investment option.
- The establishment of a defined contribution plan that competes with the Plan for employee contributions.
- Complete or partial termination of the Plan or its merger with another plan.

Note 7 - Tax Status:

The Plan is a standardized prototype plan. The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan satisfies the requirements of Section 401(a) of the Internal Revenue Code of 1986, as amended ("IRC") and therefore, is tax-exempt. The Plan has been amended since the latest determination letter. However, the Company and Plan Sponsor believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Note 8 - Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts of reported in the Statements of Net Assets Available for Plan Benefits.

Note 9 - Transactions with Parties-in-Interest:

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company or its affiliates. Fidelity Management Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest.

Fees for legal, accounting and other services rendered during the year by parties-in-interest were based on customary and reasonable rates for such services and were paid by the Corporation.

Notes receivable from participants are also considered party-in-interest transactions.

Note 10 - Plan Termination:

Although it has not expressed any intent to do so, the Corporation has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 11 - Plan Mergers:

Effective February 1, 2023, Tri Point Construction Layout, Inc. 401(k) Plan merged with and into the Plan and ceased to exist as separate plans. The total value of assets merged in from Tri Point Construction Layout, Inc. 401(k) Plan was \$930,470.

Effective August 15, 2023, The Duke Company Inc. 401(k) Plan merged with and into the Plan and ceased to exist as separate plans. The total value of assets merged in from The Duke Company 401(k) Plan was \$4,048,762
