Note 1 – Plan Description and Basis of Presentation

The following description of the Control Air & Affiliates 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Eligibility and Coverage – The Plan was established on January 1, 1994 and was amended and restated as of January 1, 2019 as the Control Air & Affiliates 401(k) Plan to become a multiemployer plan. The Plan is a multiemployer defined 401(k) profit sharing plan covering all eligible employees of Control Air Enterprises LLC and affiliates (the “Company” and “Plan Sponsor”) who have completed three months of service and are age eighteen or older. Participants, once eligible, may begin deferring a portion of their compensation into the Plan on the first day of the Plan year and the first day of the fourth, seventh and tenth month of the plan year. The Plan was amended during the year ended December 31, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and Section 401(a) of the Internal Revenue Code (“IRC”). The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance.

Contributions – Participants – Participants can contribute up to 100% of their salaries. In 2024, not more than \$23,000 may be contributed. Participants ages 50 or older may elect to defer additional amounts (called “catch-up” contributions) to the Plan. The maximum “catch-up” contribution that can be made in 2024 is \$7,500. The additional amount can be deferred regardless of any other limitations on the amounts that can be deferred to the Plan. Participants also have the option to make elective after-tax contributions to a Roth 401(k). Total Roth contributions for the year ended December 31, 2024 were approximately \$178,000. In addition, participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (“rollover”).

Employer – The Company may make a discretionary matching contribution, subject to certain Internal Revenue Service limitations. During the year ended December 31, 2024, the Company’s contributions, including contributions to the Roth 401(k), totaled approximately \$16,300.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

All contributions made on a participant’s behalf are deposited in the trust and allocated among the investment funds in accordance with the participant’s investment elections. A participant may elect to transfer investments from any investment fund to any other investment fund on a daily basis.

Participant Accounts – Each participant’s account is credited with the participant’s contributions and allocations of the Plan Sponsor’s contributions and Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1 – Plan Description and Basis of Presentation (Continued)

Vesting – Participants are immediately vested in their contributions and related investment activity thereon. Participants vest in Plan Sponsor contributions in annual ratable installments of 20% after the second year of service. Participants are fully vested in the event of death, disability, or attaining normal retirement age (age 65).

Forfeitures – If a participant terminates prior to vesting 100% in the employer contributions, the forfeited balance will be used to reduce future employer contributions and administrative expenses. In 2024, employer contributions and administrative expenses were reduced by \$19,482. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,708 and \$1,283, respectively.

Payment of Benefits – The Plan provides for the payment of benefits to the participant (or, if applicable, the beneficiary) at retirement, disability, death, financial hardship, or termination of employment. In-service distributions are also available to those participants who are disabled or are age 59½ or older. Participants who qualify for retirement benefits and withdrawals will receive their benefits as a lump sum in cash. The benefit to which a participant is entitled is the benefit that can be provided solely from the participant's vested account balance. Participants who separate from service and have vested account balances of \$5,000 or less are subject to an administrative lump sum distribution.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan repayment terms shall be no greater than five years except when loan proceeds are used for the purchase of a primary residence. The loans are secured by the vested balance in the participant's account and bear interest at the prime rate at the time the loan is taken. At December 31, 2024, outstanding loans had interest rates ranging from 3.25% to 8.50%. Principal and interest is paid at least weekly over the term of the loan through payroll deductions.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting – The accompanying financial statements are prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results may differ from those estimates.

Investment Valuation and Income Recognition – Investments are stated at fair value as determined by Ascensus Trust Company, Trustee of the Plan. Mutual funds and collective investment trusts are valued based on the quoted market prices on the last business day of the plan year. The carrying value of interest bearing money market accounts equal their fair value. Increases or decreases in fair value are recognized currently. Plan management determines the Plan’s valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits – Benefits are recorded when paid.

Risk and Uncertainties – The Plan provides for various investment securities. These investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities and the level of uncertainty related to changes in value, it is at least reasonably possible that changes in the various risk factors in the near term would materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

Note 3 – Trustee Certification

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company and Newport Trust Company, LLC (the trustee of the Plan).

Note 4 – Fair Value Measurements

The accounting standards regarding fair value measurements define fair value, establish a framework for measuring fair value, and provide for enhanced disclosures about fair value measurements. Fair value is defined as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

The standard describes three levels of inputs that may be used to measure fair value:

Level 1 Valuation is based upon quoted prices in active markets for identical securities.

Level 2 Valuation is based upon other observable inputs (including quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.).

Level 3 Valuation is based upon unobservable inputs significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following is a description of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds

These are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts

These investments invest in collective trust funds as well as a variety of pooled separate accounts and mutual funds. The fair value of all these investments are used in determining the net asset value ("NAV"), which is not publicly quoted but is available to current investors. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. As the investments can be redeemed at NAV as of the measurement date, the administrator of the fund believes the investments have a "Readily Determinable Fair Value".

Note 5 – Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Vanguard, an affiliate of Ascensus Trust Company, and qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor directly pays any other fees related to the Plan's operations.

Transactions involving participant loans also qualify as party-in-interest transactions.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants' rights to their accrued benefits are non-forfeitable.

Note 7 – Income Tax Status

The Plan has adopted the provisions of a prototype 401(k) Plan. The Plan obtained its latest opinion letter from the Internal Revenue Service dated January 1, 2018, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
