### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of the Trinidad Benham Corp. Qualified Employee Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). ## Notes to Financial Statements

December 31, 2024 and 2023

1. Summary of Significant Plan Provisions

The following description of the Trinidad Benham Corp. Qualified Employee Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreements for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of employees of Trinidad/Benham Corp. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – All employees, except union, nonresident alien, consulting employees covered under a written consulting agreement, and leased employees, are eligible to participate in the Plan with no waiting period. Entry dates are the first day of each calendar month.
- c. **Contributions** – Participants may contribute to the Plan through payroll deductions and eligible rollover contributions. New employees are automatically enrolled in the Plan and set to contribute 2% of eligible compensation unless the eligible employee affirmatively elects otherwise. Effective January 1, 2024, the deferral percentage will automatically increase by 1% every year to a maximum of 4%. Participants can contribute from 1% to 60% of their eligible compensation. The Plan allows participants who are eligible to make deferrals and who have attained age 50 before the close of any given Plan year to make catch-up contributions. The Employer matches contributions in an amount equal to 50% of a participant’s contribution up to a maximum of 4% of their eligible compensation. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earning/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – At all times, each participant has fully vested rights in their own contributions, plus earnings/losses thereon. A participant shall be fully vested in contributions made by the Employer, plus earnings/losses thereon, when the participant attains retirement age, becomes disabled or upon death. If a participant terminates employment other than because of retirement, disability, or death, they are entitled to the vested portion of their account balance. The Plan’s vesting schedule is as follows:

- f. **Investment options** – The investment of all contributions made to the Plan is directed by the participants. Participants may change their investment selections at any time.

**Notes to Financial Statements****December 31, 2024 and 2023****1. Summary of Significant Plan Provisions (cont.)**

- g. **Forfeitures** – Forfeitures arise from the portion of the participant’s account to which they are not entitled upon termination. Forfeitures are used to offset the Employer’s matching contributions or to pay administrative expenses of the Plan. All forfeitures available at year-end are utilized to reduce the Employer’s matching contribution. The Employer’s matching contributions for the years ended December 31, 2024 and 2023 were reduced by forfeitures of \$35,598 and \$64,948, respectively. Forfeitures of \$18,723 were utilized to pay administrative expenses for the year ended December 31, 2024.
- h. **Notes receivable from participants** – Participants may borrow from their Plan accounts in amounts ranging from \$1,000 to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or up to ten years if for the purchase of a primary residence. The notes are secured by the participant’s account. Notes bear interest at a rate based on the prevailing market interest rates. Principal and interest are paid through payroll deductions.
- i. **Payment of benefits** – Participants or their beneficiaries, as applicable, are entitled to receive a distribution of their account balance when they retire at age 65 or later, if they become permanently disabled, upon death, or upon separation from service with the Employer. Participants may elect upon termination of employment to defer payment of their account balance if it exceeds \$7,000. If a participant’s account balance is equal to or less than \$1,000, the account will be automatically distributed in the form of a lump sum payment. Any distribution greater than \$1,000 that is made to a participant without the participant’s consent and before the participant’s normal retirement age will be rolled over to an individual retirement account designated by the Plan administrator. The Plan also allows for in-service withdrawals for participants meeting certain age or hardship requirements.
- j. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. Summary of Significant Accounting Policies**

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for discussion of fair value measurements.

**Notes to Financial Statements****December 31, 2024 and 2023****2. Summary of Significant Accounting Policies (cont.)**

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Certain administrative expenses of the Plan were voluntarily paid by the Employer and are not included in the Plan's financial statements. Fees related to loans are charged directly to the participant's account. Other administrative expenses are allocated to participants' accounts.

**3. Investments**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedules:

- a. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$37,133,962 and \$34,169,050 as of December 31, 2024 and 2023, respectively.
- b. Interest and dividends as shown on the accompanying statement of changes in net assets available for benefits of \$946,797 (excluding \$73,190 in interest from notes receivable from participants) for the year ended December 31, 2024.
- c. Net change in fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$3,622,200 for the year ended December 31, 2024.
- d. All investment transactions that occurred during the year ended December 31, 2024.
- e. All information included in the supplemental schedules, excluding participant loans.

The Plan provides for investment in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

**Notes to Financial Statements****December 31, 2024 and 2023****4. Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023:

*Money market fund:* This investment is valued at the fair value of the underlying investments, which are valued based on quoted market prices at the end of the Plan year. The underlying investments' objective is to achieve a \$1 per share value.

*Mutual funds:* These investments are valued at quoted market prices on the last business day of the Plan year.

*Common collective trust fund:* This investment is stated at fair value based on the net asset value ("NAV") of units held by the Plan at year-end, as calculated by the issuer. The NAV is calculated based on the fair value of the underlying assets owned by the fund, minus its liabilities, divided by the number of units outstanding. The NAV is used as a practical expedient to estimate fair value.

4. Fair Value Measurements (cont.)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Notes to Financial Statements****December 31, 2024 and 2023****5. Tax Status**

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Parties-in-Interest Transactions**

Fidelity is the trustee and third-party administrator of the Plan. The Plan pays Fidelity for its services. Inasmuch as Fidelity serves as trustee and third-party administrator of the Plan’s assets, Fidelity is by definition a party-in-interest and, as a result, all investments and investment transactions with Fidelity Investments were with a party-in-interest. Frost, PLLC (“Frost”) serves as auditor of the Plan. The Plan pays Frost for its services. Inasmuch as Frost serves as auditor of the Plan, Frost is by definition a party-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

**7. Delinquent Participant Contributions**

The Plan sponsor determined that during the 2024 Plan year, certain participant contributions and loan repayments were not remitted within the required time frame specified by the DOL’s regulations, which have been reported on the accompanying Schedule H, line 4a – Schedule of Delinquent Participant Contributions in the amount of \$89,481. The Plan sponsor is in the process of finalizing lost earnings and will make corrections outside of the Voluntary Fiduciary Correction Program.

**8. Subsequent Events Evaluation Date**

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through September 9, 2025, which is the financial statement issuance date.
