We have performed audits of the financial statements of Lyon Management Group, Inc. 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **Lyon Management Group, Inc. 401(k) Plan Notes to Financial Statements**

### **1. DESCRIPTION OF PLAN**

The following description of Lyon Management Group, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan effective January 1, 1990, and most recently amended and restated effective November 26, 2021, under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of Lyon Management Group, Inc. (the Company, Plan Sponsor or Employer) and Rock Creek Golf Idaho dba The Club at Rock Creek as a participating employer. Employees, who have completed one month of service and attained age 18, become eligible to participate and are automatically enrolled in the Plan. Nonresident aliens, leased employees and employees covered by a collective bargaining agreement are excluded from the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Contributions

Participants are automatically enrolled in the plan at a minimum deferral rate of 2% of eligible compensation. Participants who have attained age 50 before the Plan year-end are also eligible to make additional catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company may make a discretionary matching contribution related to the participant's salary deferral, as determined by the Company's Board of Directors. Participants are eligible for the discretionary matching contribution if they are employed on December 31st and completed 1000 hours of service. For the year ended December 31, 2024, the Company made an employer matching contribution on the first 2% of compensation deferred by each eligible participant. The Company may, at its discretion, make additional contributions. Contributions are subject to certain limitations.

#### Participant Accounts

The Plan maintains an individual account for each participant, wherein each participant directs the investment of his or her account in one or more of the available investment fund options. Each participant's account is credited with the participant's contribution, the Company's matching contribution, if any, and an allocation of Plan earnings and administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid within five years, except in the case of the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. Interest rates ranged from 4.25% to 9.50% at December 31, 2024 and 2023. Principal and interest are normally paid ratably through payroll deductions.

**1. DESCRIPTION OF PLAN (Continued)**

Payments of Benefits

Upon retirement, disability, death or termination of employment, a participant may elect to receive a lump-sum distribution in an amount equivalent to their vested account balance. In-service withdrawals are permitted under certain circumstances.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings. Vesting in the Company's matching contribution and related earnings is based on years of service. Participants vest 20% upon completion of the first year of credited service, and 20% each year of service thereafter; thus becoming 100% vested after five years of credited service. Participant accounts are deemed 100% vested upon death, disability or at retirement.

Forfeited Accounts

The nonvested portion of terminated participants' accounts is deemed forfeited upon the participant separating from service. At December 31, 2024 and 2023, forfeited accounts totaled \$31,351 and \$33,921, respectively. These accounts are used to reduce future employer contributions or to pay Plan administrative expenses. During the year ending December 31, 2024, the Plan applied \$18,713 of forfeited nonvested accounts to administrative expenses and \$46,460 to the employer matching contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company is under no obligation or liability to continue its contributions and may discontinue such contributions or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES**

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING PRINCIPLES (Continued)**

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosures regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Notes Receivable from Participants

Notes receivable from participants are stated at the unpaid principal balance plus any accrued but unpaid interest. Interest income associated with the notes receivable is recorded when interest payments are received, usually bi-weekly. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability, with a corresponding decrease to participant contributions. Excess contributions are distributed to participants subsequent to year-end.

Payment of Benefits

Benefits are recorded when paid or upon distribution.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company, at its option, and are excluded from these financial statements. Fees related to participant account maintenance and to participant loans, are charged directly to the participant's account and are included in administrative expenses.

**3. FINANCIAL INFORMATION CERTIFIED BY THE TRUSTEE**

Certain information related to investments and notes receivable from participants reflected in the accompanying financial statements and supplemental schedule, which include investments and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest from investments, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan, in accordance with Section 2520.103-5(c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**4. INVESTMENTS AND FAIR VALUE MEASUREMENTS**

Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under ASC 820 with the related inputs to the valuation methodology are described as follows:

Level 1 - Quoted prices (unadjusted) in active markets for identical assets that the Plan has the ability to access.

Level 2 - Significant other observable (directly or indirectly) inputs, including quoted prices for similar assets in active markets or in inactive markets and other market observable inputs such as interest rate, credit risks, etc.

Level 3 - Significant unobservable inputs, including the Plan's own assumptions in determining the fair value of investments.

Following is a description of the valuation methodologies used for the Plan's investment assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**4. INVESTMENTS AND FAIR VALUE MEASUREMENTS (Continued)**

*Stable value common/collective trust fund:* The Plan's stable value fund is a common/collective trust fund which invests in fully benefit-responsive investment contracts and is valued at the net asset value of the units of the common/collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value. Participant transactions (purchases and sales) may occur daily. The stable value common/collective trust fund has no unfunded commitments and has daily redemption frequency; however, transfers into a competing fund are restricted for 90 days due to an equity wash provision and a 12 month delay may apply for Plan withdrawal requests. Were the Plan to initiate a full redemption of the common/collective trust fund, the provider reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

**5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by an affiliate of Fidelity Trust Management Company. Investment management fees are paid to this affiliate and are included in net appreciation in fair value of investments. In addition, the Plan pays other expenses for services rendered by the trustee as the plan recordkeeper and also to its third party administrator, investment advisor and auditor. The above transactions, including notes receivable from participants, qualify as allowable party-in-interest transactions for which there are statutory exceptions.

**6. INCOME TAX STATUS**

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service on June 30, 2020, stating that the written form of the underlying pre-approved plan is qualified under section 401(a) of the IRC, and that any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. Therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

U.S GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and amounts reported in the statements of net assets available for benefits.

**8. SUBSEQUENT EVENTS**

In preparing these financial statements, the Plan administrator has evaluated subsequent events and transactions for potential recognition or disclosure through September 5, 2025, the date the financial statements were available to be issued.
