Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Kason Industries, Inc. 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



Note A

Description of Plan

The following description of the Kason Industries, Inc. 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan established effective October 1, 1987, and was last restated effective January 1, 2022, to comply with the Internal Revenue Service's "IRS" cycle 3 restatement requirement. The Plan covers all full-time employees, except for union employees and nonresident aliens, of Kason Industries, Inc. (the Company or Plan Sponsor). The Plan is administered by a committee appointed by the Company. Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the trustees of the Plan, have responsibility for physical control of the Plan's assets and payment of plan benefits. Empower Retirement provides recordkeeping services for the Plan. Additionally, Pension Financial Services, Inc. serves as the Plan's third party administrator. The Plan is subject to requirements of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes a Qualified Automatic Contribution Arrangement (QACA) to provide safe harbor matching contributions and additional automatic enrollment features.

Eligibility:

Employees become eligible for participation in the Plan on the first day of a calendar quarter coinciding with or following the date the employee completes 90 days of service with the Company and attains age 21.

Contributions:

Participant elective contributions to the Plan are limited to the lesser of 100% of the employee's gross wages or the maximum amount established by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the Plan year are eligible for catch-up contributions. Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment option offered by the Plan.

The Plan also includes an automatic salary deferral provision which states that once an employee is eligible to participate, the Company will automatically defer 3% of the employee's eligible compensation to the Plan as a pre-tax contribution and allocate to the employee's applicable target-date retirement fund. The automatic deferral rate increases each year by 1% up to a maximum of 6%. Eligible employees may complete a salary deferral agreement to select an alternative deferral amount or to elect not to defer under the Plan.

The Company provides a safe-harbor matching contribution in an amount equal to 100% of each participant's contribution up to a maximum of 5% of their gross wages. Employees become eligible to receive a matching contribution on the first day of the plan year quarter coinciding with or following the date the employee completes one year of service with the Company.

At the end of each plan year, the Company, in its sole discretion, may also make a discretionary profit sharing contribution to the Plan that will be divided or allocated among participants eligible to share in the contributions for the Plan year. The Company did not elect to make a profit sharing contribution for the year ended December 31, 2024.

Participant Accounts:

Each participant's account is credited with a participant's contributions, an allocation of the employer matching and profit sharing contributions, and an allocation of investment earnings (losses) thereon, and is charged with withdrawals, an allocation of investment losses and administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are fully vested in employee and employer contributions at all times.

Notes Receivable from Participants:

Plan participants may borrow from his or her fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms generally range from one to five years; however, if the loan is used for the purchase of a principal residence, the Plan administrator may permit a longer repayment term. Participants may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates at the date of issuance, as determined by the Plan administrator. Principal and interest payments occur ratably through regular payroll deductions.

Payment of Benefits:

Upon disability, death, retirement, or termination, the participant's vested benefits are paid in a single lump sum, if the vested account balance does not exceed \$5,000. If the vested account balance exceeds \$5,000, the participant may elect to receive a distribution in a single lump-sum payment, partial withdrawals or installments or the participant may elect to delay the distribution. The Plan also provides that a participant may receive liquidation of all or part of their benefits in the event of economic hardship, subject to the approval of the Plan administrator. Participants may request in-service withdrawals if they are at least 59 1/2. Participants may also elect to withdraw all or part of their rollover account (including earnings).

Administrative Expenses:

The Company pays various administrative fees for the Plan including fees for mailing notices to participants. The participants pay the Asset fees and certain participant-requested service fees. A Plan expense account is maintained to hold revenue sharing funds the Plan receives from Empower Annuity Insurance Company of America pursuant to an agreement between Empower Annuity Insurance Company of America and the Plan. These revenue sharing funds are available to pay qualified Plan administrative or investment expenses. At December 31, 2024 and 2023, the Plan expense account balance was \$12,346 and \$3,932, respectively. During 2024, credits totaling \$38,772 were used to pay Plan expenses and credits of \$46,946 were received.

Note B

Significant Accounting Policies

Basis of Accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan payments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions:

Participant contributions and related Company safe harbor matching contributions are recognized in the period the participant contribution is withheld from compensation.

Payment of Benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

Use of Estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Note C
Information Prepared and Certified by Trustees

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America (the trustees of the Plan).

Note D
Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note E
Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note F
Income Tax Status

On June 30, 2020, the Internal Revenue Service ("IRS") stated that the non-standardized profit-sharing plan with CODA adopted by the Plan, as then designated, qualifies under Section 401(a) of the IRC. The Plan administrator timely adopted the approved Plan. The Plan administrator believes that the Plan is currently being operated in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires plan management to evaluate tax positions taken by the plan and recognizes a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note G

Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access.

- Level 2 Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as quoted by the fund. Mutual funds held by the plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no unfunded commitments for these funds, and normal redemptions are unrestricted. The Clearbridge Large Cap Growth fund requires a Plan to provide advance written notice of five business days for Plan directed withdrawals which will exceed \$1 million of the assets invested in the fund.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Empower Trust Company, LLC and Empower Annuity Insurance Company of America are the trustees, as defined by the plan and, therefore, these transactions qualify as party-in-interest transactions. For the year ended December 31, 2024, direct fees paid by the plan to Empower Trust Company, LLC and Empower Annuity Insurance Company of America were \$48,499.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
