Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of JCJ Architecture 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1 - Description of Plan

The following description of JCJ Architecture 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement, and any amendments thereto, for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 1984, and most recently restated and amended on August 1, 2022. See Note 9 - Subsequent events. Employees of JCJ Business Corp, Inc. and JCJ Architecture PC (collectively, the "Company"), excluding union employees, nonresident aliens, leased employees, durational employees or summer interns, become eligible to make elective deferrals upon attaining the age of 21. Participants become eligible to receive safe harbor matching, discretionary matching and nonelective profit sharing contributions on the first day of the month following the completion of six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Company's Board of Directors is responsible for oversight of the Plan. The President of JCJ Business Corp., Inc. determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Company's Board of Directors.

Contributions

Each year, participants may contribute an amount up to 90% of compensation, as defined in the Plan agreement, for the contribution period. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan includes an automatic deferral election for employees as they become eligible unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their rate set at 5% of eligible compensation and their contribution invested in a designated targeted retirement date fund until changed by the participant. On the first day of each Plan year, the rate is increased by 1% up to a maximum of 10%. See Note 9 - Subsequent events. Participants may also make Roth 401(k) elective deferrals. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

The Company can make safe harbor matching, discretionary matching and nonelective profit sharing contributions, as determined by the Company. The Company contributes an amount equal to \$1.00 for each \$1.00 contributed by a participant, up to a maximum of 3% of the participant's Plan compensation, plus \$0.50 for each \$1.00 contributed by a participant that exceeded 3% of the participant's Plan compensation but did not exceed 5% of the participant's Plan compensation. The Company did not make discretionary matching or nonelective profit sharing contributions for the year ended December 31, 2024. Participants direct the investment of all contributions in various investment options offered by the Plan.

The Plan currently offers various mutual funds as investment options for participants. Company safe harbor matching contributions are recorded on a pay period basis. Discretionary matching and nonelective profit sharing contributions, if any, are recorded annually. If discretionary matching contributions are made, there is no limit to the percentage the employer can contribute of a participant's compensation. Contributions are subject to certain Internal Revenue Service (the "IRS") limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their own contributions and safe harbor matching contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective profit sharing and matching contribution portion of their accounts is based on years of continuous service. Employees are 20% vested after two years of service, 40% vested after three years of service, 60% vested after four years of service, 80% vested after five years of service and 100% vested after six years of service. However, if an active participant dies or becomes totally and permanently disabled prior to the normal retirement age, the participant's account becomes 100% vested.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. A participant may have two loans outstanding at any time. The loan interest rate, determined monthly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of benefits

On termination of employment, retirement, the attainment of age 59½, death or permanent and total disability, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants may elect to receive a lump-sum amount equal to the value of the vested portion of their account, installment payments or partial payments over \$500. A terminated participant with a vested account balance of less than \$5,000 will have his or her funds directly rolled over by the Plan administrator into an individual retirement account designated by the Plan administrator if no other election is made. Participants may also take hardship distributions from elected deferral amounts or in-service withdrawals as provided for in the Plan document. Hardship and in-service withdrawals must be a minimum of \$500. Distributions are subject to the applicable provisions of the Plan agreement.

Forfeited accounts

Forfeitures result from nonvested discretionary nonelective profit sharing and matching contributions remaining in the Plan from terminated employees. Forfeitures available to pay Plan expenses or to reduce Company contributions in accordance with the Plan agreement were \$2,388 and \$12 as of December 31, 2024 and 2023, respectively. During 2024, \$7,184 was used to reduce Company contributions and no amounts were used to pay Plan expenses.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and

assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Finance Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and safe harbor matching contributions from the Company are recorded in the year in which the contributions are withheld from compensation. The discretionary nonelective profit sharing and matching contribution from the Company are recorded when participants compensation is earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to payment of benefits and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 18, 2025, the date the financial statements were available to be issued. See Note 9 - Subsequent events.

Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024 that are disclosed in the accompanying financial statements, were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan. See Note 9 - Subsequent events.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 6 - Related party transactions and party-in-interest transactions

Reliance Trust Company is the trustee as defined by the Plan. See Note 9 - Subsequent events. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments. The Company pays directly any other fees related to the Plan's operations with the exception of loan administration fees and benefit payment transaction fees.

Additional fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. During the year ended December 31, 2024, the Plan made direct payments to the custodian, trustee and other advisors of \$78,904, which was not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

Note 7 - Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the discretionary nonelective profit sharing and matching contribution portions of their account.

Note 8 - Tax status

The prototype plan document, which the Plan has adopted via a nonstandardized adoption agreement, obtained its latest opinion letter dated October 6, 2020, in which the IRS stated that the prototype plan, as then designed, was in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9 - Subsequent events

Effective January 1, 2025, the Plan increased the maximum limit of the automatic deferral escalation from 10% to 15%.

Effective January 1, 2025, the Plan Sponsor consented to the appointment of ADP Retirement Trust Services, LLC as the trustee of the Plan upon the resignation of Reliance Trust Company on December 31, 2024.
