Note 1. DESCRIPTION OF THE PLAN

The following description of the Avantus LLC 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined-contribution 401(k) plan established as of January 1, 2010 to provide retirement benefits for eligible employees of Avantus LLC (the Company). Employees must be 21 or older to be eligible for employee contributions and employer safe harbor matching contributions. Employees must be age 21 or older, an eligible participant employed by the employer at year end and have completed at least 500 hours of service to be eligible for employer profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective May 2, 2024, the Plan Adoption Agreement was amended to change the Plan's name from Avantus, LLC 401(k) Profit Sharing Plan and Trust to Avantus LLC 401(k) Profit Sharing Plan and Trust as the Company changed its plan from the ADP small market plan (#250934) to the mid-market plan (#428356) as its third-party administrator.

Contributions

Participants may elect salary deferral contributions to the Plan of up to 90% of their compensation, subject to annual limits established by the Internal Revenue Service. Participants who are age 50 or older before the end of the plan year are eligible to make additional catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The Company makes safe harbor matching contributions equal to 100% of participant salary deferrals that do not exceed 6% of eligible compensation. The Company may also make discretionary profit-sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's salary deferral contributions, the Company's matching contributions, an allocation of the Company's discretionary profit-sharing contributions, and the actual earnings thereon. The Company's discretionary profit-sharing contributions are allocated based on participant's eligible earnings compared to the eligible earnings of the other participants who will also share in the contribution.

Vesting

Participants are immediately 100% vested in their contributions, the Company's safe harbor matching contributions, and related earnings thereon.

Vesting in the Company's discretionary profit-sharing contributions and related earnings is as follows:

Less than 2 years	0%
2 years, but less than 3	20%
3 years, but less than 4	40%
4 years, but less than 5	60%

Participants become fully vested upon termination for reason of normal retirement, death or disability, or if the Plan is terminated. For participants that are not fully vested in their account balance upon termination for reasons other than normal retirement, death, or disability and do not take a distribution from the Plan, non-vested benefits are forfeited as of the date of the participant's five-year period of severance. For participants that are not fully vested in their account balance upon termination for reasons other than normal retirement, death, or disability and receive a distribution of the vested portion of their account, non-vested benefits are forfeited upon the date that the distribution is taken.

Forfeitures

Forfeitures may be used to reduce the Company's contributions or pay Plan expenses. Forfeitures were \$-0- in 2024 and 2023. Forfeitures of \$-0- and \$11 were used to reduce the Company's contributions in 2024 and 2023, respectively. The forfeiture account had a balance of \$13,052 and \$12,759 at December 31, 2024 and 2023, respectively.

Investment Options

A participant may direct their contributions to various registered investment companies and a collective investment trust. Participants may change their investment options at any time.

Notes Receivable from Participants

Notes receivable from participants are stated at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant notes receivable are reclassified as distributions. Participants may borrow up to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable from participants bear an interest rate equal to the Prime rate plus 2% and are secured by the participant's vested account balance. The participant notes receivable must be repaid within 5 years, or within 30 years if it qualifies as a home loan, as defined by the Plan. The interest rate on participant notes receivable ranged from 5.25% to 10.50% at December 31, 2024 and 2023.

Payment of Benefits

Upon termination of service, attainment of normal retirement age, disability or death, the participant will receive the value of the vested interest in their account as a lump-sum distribution or other distribution methods elected by the participant.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared based upon the accrual method of accounting.

Investments

Investments in registered investment companies are stated at fair value based on the publicly quoted net asset value (NAV) of the shares held by the Plan.

Investments (continued)

Investments in the collective investment trust, the MetLife Stable Value Solutions Fund-Fee Class J (the Fund), are stated at NAV as a practical expedient to estimate fair value. The NAV per unit, as provided by Wilmington Trust, N.A. (the Trustee), is computed by dividing the total contract value of the assets of the Fund, less its liabilities, by the total number of units outstanding at the time of such computation. Investment income earned is reinvested in the Fund and is included in the determination of unit values. The Fund was formed for the purpose of allowing collective investments in the MetLife Group Annuity Contract No. 25554 issued by Metropolitan Life Insurance Company (MetLife) to the Trustee. The investment objective of the Fund is to provide safety of principal, adequate liquidity, and a competitive yield with low return volatility.

Investment-related expenses are included in the net realized and unrealized gain (loss) in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company.

Note 3. FAIR VALUE MEASUREMENTS

The Plan's investments in registered investment companies are reported at fair value in the accompanying statements of net assets available for benefits. Generally accepted accounting principles establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

*Level 1 Fair Value Measurements*

Fair values are based on publicly quoted prices in active markets for identical assets. The fair value of investments in registered investment companies is based on the publicly quoted net asset value of the shares held by the Plan.

*Level 2 Fair Value Measurements*

Fair values are based on observable inputs other than publicly quoted prices in active markets for identical assets.

*Level 3 Fair Value Measurements*

Fair values are based on unobservable inputs used for valuing the asset.

Note 6. FEDERAL INCOME TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for an uncertain position if it is not more likely than not that the position would be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

Note 7. PARTIES-IN-INTEREST

Certain expenses of the Plan are paid for by the Company. The Company is the sponsor of the Plan and, therefore, these transactions qualify as party-in-interest. The most significant of these costs paid by the Company are the salaries for the Company's employees responsible for plan administration and the fees paid to a third-party administrator.

Note 8. PLAN TERMINATION

The Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their account balance.

Note 9.      **PROHIBITED TRANSACTION**

The Plan experienced a prohibited transaction during 2022, as defined by ERISA, Section 4975. The Company incorrectly matched an employee deferral relating to an unearned clawback bonus. Instead of transferring these incorrect matching contributions to the forfeiture account, as generally required, the Company withdrew the funds from the Plan. At the direction of the Company's legal counsel, the Company corrected this issue by contributing the employer match and lost earnings to the Plan's forfeiture account in 2023. Any potential penalties, interest, and associated costs with this prohibited transaction are the responsibility of the Company and will not be borne by the Plan or the participants.

Note 10.     **SUBSEQUENT EVENTS**

Subsequent events were evaluated for accrual and disclosure through September 9, 2025 which is the date the 2024 financial statements were available to be issued.
