We have performed audits of the financial statements of Hansen-Mueller Co. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Plan Description

---

The following brief description of the Hansen-Mueller Co. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan was established to provide post-retirement benefits for the employees of Hansen-Mueller Co. and Subsidiary (the Company). The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees are eligible to make pre-tax and designated Roth after-tax salary deferral contributions and receive safe harbor matching contributions, discretionary matching contributions, and discretionary profit-sharing contributions after attaining age 21 and completing one month of service. To receive discretionary profit-sharing contributions, eligible employees must be employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year. Eligible employees become participants on the first day of the Plan month immediately following the date on which entry requirements were fulfilled for pre-tax contributions, designated Roth after-tax contributions, and discretionary profit-sharing contributions.

#### ***Contributions***

Participants may make voluntary pre-tax and designated Roth after-tax contributions up to the maximum dollar limits allowable by law. Participants may also contribute amounts representing distributions from other qualified plans. The Plan is a "safe harbor 401(k) plan," whereby the Company makes safe harbor matching contributions of 100% of the participant's elected salary deferral up to 4% of the participant's eligible compensation for the Plan year. The Company also may make discretionary matching contributions (40% of the participant's deferral with a maximum of \$320 in 2024 and 2023), up to 6% of eligible compensation, and discretionary profit sharing contributions (0% of eligible compensation in 2024 and 2023). Participants who are eligible to make pre-tax and designated Roth after-tax contributions and who are projected to attain age 50 before the close of the calendar year shall be eligible to make catch-up contributions. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company's safe harbor matching contribution, b) the Company's discretionary matching contribution, c) the Company's discretionary profit-sharing contribution and d) Plan earnings or losses. The Company's safe harbor matching and discretionary matching contributions are allocated among participants based on each participant's elected salary deferral. The Company's discretionary profit-sharing contributions are allocated among participants based on each participant's eligible compensation. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are maintained in individual member accounts managed by Reliance Trust Company.

### *Vesting*

Participants are vested immediately in their contributions, the Company's safe harbor matching contributions and discretionary matching contributions plus actual earnings thereon. Vesting in the Company's discretionary profit-sharing contributions are based on years of service. A participant is 20% vested after one year of credited service and vesting increases 20% per year until a participant is 100% vested after five years of credited service.

### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the Wall Street Journal prime rate plus 1%. Principal and interest are paid through payroll deductions.

### *Payment of Benefits*

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive either a lump sum, installment, or annuity payments equal to the value of the vested funds allocated to the participant's account. The Plan requires distribution payments between \$1,000 and \$7,000 (\$5,000 prior to January 1, 2024) be directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Distributions under \$1,000 will be paid out to the participant in the event the participant does not elect a payout option. If a participant's balance is less than \$1,000 the balance may only be distributed to the participant in a single lump-sum payment. The Plan also allows in-service and hardship distributions as detailed by the Plan. Benefits are recorded when paid.

### *Forfeitures*

Upon a participant's termination of employment before normal retirement, disability or death, the portion of their Company contributions not then vested shall be forfeited. The forfeited portion of any participant's account will be used to reduce future Company contributions or plan expenses. As of December 31, 2024 and 2023, there were \$10 and \$0 forfeited non-vested accounts, respectively, of which all amounts were used to reduce Plan expenses.

## 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, Plan Accounting – Defined Contribution Pension Plans.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### ***Other***

Certain administrative expenses are paid by the Plan and recorded in administrative expenses. Other certain expenses specifically incurred by or attributable to individual participants are paid from the applicable participants' accounts. Investment related expenses are included in net appreciation in fair value of investments. Audit fees are paid by the Company and are excluded from these financial statements.

### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through September 16, 2025, noting no items for disclosure.

### 3. Information Certified by Reliance Trust Company

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, except for comparing such information certified by the trustee to information included in the Plan's financial statements and supplementary information.

### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the investments. The investments held by this Plan are open-ended investments that are registered with the Securities and Exchange Commission. These investments are required to publish their daily net asset value (NAV) and to transact at that price. The investments held by the Plan are deemed to be actively traded.

*Stable Value Fund:* Valued at the NAV based on the fair value of its underlying investments, FASB ASC 820, Fair Value Measurement, allows NAV per share to serve as a practical expedient to estimate the fair value as long as certain requirements are met. It is the Plan's assessment that this fund meets those requirements. Since the participants have the ability to redeem the fund at NAV as of the measurement date on a daily basis.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
