**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Advantage Mailing, LLC 401(K) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Advantage Mailing, LLC 401(K) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### NOTE 1. DESCRIPTION OF PLAN

The following description of the Advantage Mailing, LLC (the “Company”) 401K Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General:** The Plan is a defined contribution plan covering all employees of the Company who have completed one year of service. The Plan is subject to the provisions of ERISA. The Plan’s trustee is Reliance Trust Company (“Trustee”). The Plan’s recordkeeper is ADP, Inc. The Company is the Plan’s sponsor and serves as the plan administrator.

**Contributions:** Each year, participants may contribute a percentage of pretax compensation, as defined by the Plan. Participants may also elect to make Roth after-tax contributions. All contributions are subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, subject to certain IRC limitations. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of their eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan allows for the Company to make discretionary matching and non-elective contributions. For the years ended December 31, 2024 and 2023, the Company did not elect to make any employer contributions.

**Participant accounts:** Each participant’s account is credited with the participant’s elective contribution, and allocations of any Plan earnings, and is reduced by Plan fees. Allocations are based on participant earnings or account balances, as defined. Administrative expenses are allocated to participant’s accounts based on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting:** Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s non-elective discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service and are 100% vested after six years of credited service.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant’s account and bear a reasonable interest rate (prime rate at the inception of the loan plus one percent). Principal and interest is paid ratably through payroll deductions. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024. Loans are amortized in level payments over a period not to exceed five years, except for loans to purchase the participant’s primary residence that are amortized in level payments over a period not to exceed thirty years. For participant loans that become delinquent, the amount of the unpaid loan principal plus any accrued interest will be treated as a deemed distribution. Deemed distributions are reported as a taxable distribution and remain part of the participant’s account balance until a distributable event occurs.

### NOTE 1. DESCRIPTION OF PLAN (Continued)

**Payment of benefits:** The payment of benefits can be made upon service or disability retirement, termination of the Plan, death, termination of employment, or financial hardship. Upon termination of employment, a participant may withdraw his or her accumulated balances in the Plan. If a participant has reached the age of 59 ½, distributions may be made, at the participant's election, from any account which are 100% vested without requiring the participant to terminate employment. Only lump sum cash distributions are permitted. Upon termination, a participant with a vested account balance equal to or less than \$5,000 will automatically receive a lump sum distribution. Hardship withdrawals are allowed from the participant's elective account for certain qualifying hardship circumstance. Additionally, participants may keep their account with the Plan or rollover the balance to another qualified retirement account.

**Forfeited accounts:** As of December 31, 2024 and 2023, the forfeited nonvested accounts totaled \$0 and \$0, respectively. Forfeitures of nonvested accounts will be used to reduce any employer contributions.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting:** The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

**Use of estimates:** The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Notes receivable from participants:** Participant loan receivables are reported at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Administrative expenses:** Certain expenses of the Plan are paid by the Company and are excluded from these financial statements. Administrative expenses paid by the Plan for the year ended December 31, 2024 totaled \$125,032.

**Payment of benefits:** Distributions to the participants of the Plan are recorded when paid.

**Investment valuation and income recognition:** The Plan's participant directed investments are reported at fair value as determined by the Trustee based on factors such as quoted market prices in active markets and prevailing interest rates. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contributions are invested in unaffiliated mutual funds and a common collective trust.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Subsequent events:** The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

### NOTE 3. FAIR VALUE MEASUREMENTS (Continued)

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology are observable other than level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable for the assets or liabilities. Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation measurement are unobservable, supported by the little or no market data, and are significant to the fair value of the assets and liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded and are considered Level 1 assets. The NAV is a quoted price in an active market.

*Common collective trust ("CCTs"):* The Plan has an investment in a common collective trust: MetLife Rel Stable Value Fund. Units held in common collectives are valued using NAV practical expedient of the CCTs as reported by the CCTs managers. The NAV practical expedient is based on fair value of the underlying assets owned by the CCTs, minus its liabilities, and then divided by the number of units outstanding. The NAV practical expedient of a CCTs is calculated based on a compilation of primarily observable market information.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE 4. COMMON COLLECTIVE TRUST INVESTMENT

The MetLife Rel Stable Value Fund is fully benefit-responsive and contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the Trustee contract. The contract value approximates fair value at December 31, 2024. The average yield and crediting interest rate for the MetLife Rel Stable Value Fund for the year ended December 31, 2024 was 2.92%. The fund itself is considered to be non-benefit responsive. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. This common collective trust (CCT) is valued at NAV of units held. The NAV, as reported by the trustee of the CCT, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investment held by the CCT less its liabilities. The practical expedient is not used when it is determined to be probable that the CCT will sell for an amount different than the reported NAV. The CCT provides for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to this investment. This is a direct filing entity.

### NOTE 5. EXCESS CONTRIBUTIONS

Participants' contributions include \$45,992 and \$63,561 of excess contributions for the years ended December 31, 2024 and 2023, respectively. These excess contributions were returned to the participants before March 15, 2025 and 2024 for the years ended December 31, 2024 and 2023, respectively.

### NOTE 6. PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are made available by Reliance Trust Company, who is the Trustee as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Fees incurred by the Plan for investment servicing are included in net appreciation (depreciation) in fair value of investments and amounted to, as they are paid through revenue sharing, rather than direct payment.

#### NOTE 6. PARTY-IN-INTEREST TRANSACTIONS (Continued)

During the years ended December 31, 2024 and 2023, the Plan made direct payments of \$125,032 and \$104,488, respectively, to third party servicers for recordkeeping, trustee, and investment advisory services, which were not covered by revenue sharing. Of these payments, certain fees of \$67,225 paid to the recordkeeper are considered to be party-in interest transactions under ERISA. The Company pays directly any other fees related to the Plan's operations, other than investment management fees.

#### NOTE 7. CERTIFIED INVESTMENT INFORMATION

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

#### NOTE 9. TAX STATUS

The Plan document is a pre-approved prototype plan that received a favorable opinion letter from the IRS dated October 6, 2020, which stated that the Plan, as then designed, was in accordance with applicable sections of the IRC. Although the plan has been amended since receiving the favorable opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the federal or state tax authorities. The Plan's administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **NOTE 10. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts. Any unallocated assets of the Plan should be allocated to participant accounts and distributed in such a manner as the Company may determine.

### **NOTE 11. CORRECTIVE CONTRIBUTION**

The 2023 Plan assets include a corrective contribution in the amount of \$6,211 as a result of a failed nondiscrimination test that was erroneously not corrected during the proper period. This corrective contribution was made before December 31, 2023, through a qualified non-elective contribution ("QNEC") and was included on the 5500 as an employer contribution. The amount includes lost earnings and an excise tax, which was paid by December 31, 2023.

### **NOTE 12. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
