## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Lanco Employees Retirement/Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### 1. Description of Plan

The following description of the Lanco Employees Retirement/Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Lanco Assembly Systems, Inc. (the Company) who are at least 21 years of age and have met service requirements specified by the Plan.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

On December 29, 2022, the *Setting Every Community Up for Retirement Enhancement Act of 2022* (SECURE 2.0 Act) was signed into law. It includes mandatory and optional provisions impacting defined contribution plans. Applicable provisions outlined in the SECURE 2.0 Act will be adopted if elected and/or required. Plan amendments for these changes are not yet required.

The SECURE 2.0 Act expanded eligibility for certain long-term part-time (LTPT) employees. Effective January 1, 2024, part-time employees who have completed at least 500 hours of service in the three most recent consecutive years (2021 – 2023) are eligible to participate in the Plan. Effective January 1, 2025, the requirement is being reduced from three to the two most recent consecutive years (2023 – 2024).

The non-standardized pre-approved plan is sponsored by ADP, LLC and Reliance Trust Company is the trustee of the Plan. In 2024, the Plan was notified that effective January 1, 2025, ADP Trust Retirement Services, LLC would become the Plan's trustee as a successor to Reliance Trust Company.

#### Contributions

Participants may elect to make pre-tax or Roth contributions up to the maximum allowable of their eligible compensation, subject to the limitations established by the Internal Revenue Service (IRS). Participants may elect to rollover distributions from other qualified retirement plans.

Employer matching contributions are voluntary and are determined at the discretion of the Company. During 2024 and 2023, the Company matched 20% of the first 6% of employee salary deferrals. The Company may elect to make discretionary nonelective employer contributions to the Plan which are allocated to participants based upon relative compensation, as defined in the Plan agreement. Only participants employed by the Company and meeting the eligibility requirements as of the last day of the Plan year are eligible to receive these contributions. No such contributions were made during the years ended December 31, 2024 and 2023.

Effective January 1, 2023, the Plan was amended to allow for true-up contributions of the Company match at year end. The true-up contributions are calculated based on the ratio of employee elective deferrals to eligible compensation for the Plan year.

### 1. Description of Plan (Continued)

Participants can direct the allocation of their accounts to any of the stipulated investment fund alternatives offered by the Plan. These funds include a stable value option (collective trust) which provides for a specified return, as well as mutual funds and a money market fund.

#### Participant Accounts

Each participant's account is credited with an allocation of contributions and Plan earnings. Certain administrative fees are allocated and charged against each participant's accounts. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions and earnings thereon. Employer contributions vest as follows:

#### Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

#### Payment of Benefits

Upon death, disability, termination of employment, attainment of age 59½ or retirement on or after age 65, participants are entitled to a distribution of the balance of their accounts. Participants may also be entitled to a hardship withdrawal as determined in accordance with the Plan's provisions. If the vested benefit exceeds \$5,000, the payment of a participant's account shall be made in a lump sum payment or substantially equal installments. If the vested benefit does not exceed \$5,000, the payment shall be made in a lump sum.

### 1. **Description of Plan (Continued)**

#### *Notes Receivable From Participants*

Upon application, notes may be granted to participants. In no event shall the total of any such note to any participant exceed the lesser of (a) 50 percent of the participant's vested interest in their account in the fund, or (b) \$50,000. No note shall be for a term exceeding 5 years unless it is for the purchase of a principal residence. Only one outstanding note per participant is permitted at any one time. Notes bear interest at a rate that is commensurate with prevailing interest rates on similar loans. Principal and interest is paid ratably through payroll deductions.

#### *Forfeitures*

Participant forfeitures may be used to offset employer contributions or Plan expenses. In 2024 and 2023, respectively, forfeitures totaling approximately \$22,000 and \$47,800 were used to offset employer contributions. Available forfeitures totaled \$2,221 and \$10 at December 31, 2024 and 2023, respectively.

### 2. **Summary of Significant Accounting Policies**

#### *Basis of Presentation*

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### *Risks and Uncertainties*

The Plan provides for various investment options which in turn invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as pandemics or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### Investments and Income Recognition

The Plan provides participants with a selection of mutual funds, a money market fund and a stable value option (collective trust) to which participants may direct their contributions. Mutual funds and the money market fund are valued at the quoted value of shares held by the Plan at year end. See note 6. Investment in the collective trust is stated at fair value based on net asset value (NAV). NAV has been determined based on the unit value of the trust. Unit value is determined by dividing the fund's net assets based on the fair value of the underlying investments by its units outstanding at each valuation date. Purchases and sales of investments are recorded on a trade-date basis. Participants can purchase or redeem units on a daily basis in any of the Plan's funds based on the fund's reported net asset value per share. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date.

#### Notes Receivable From Participants

Participant notes receivable are measured at the notes' unpaid principal balance plus accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### Benefit Payments

Benefit payments are recorded when paid.

#### Contributions

Participant deferrals are recorded in the period in which payroll deductions are made. Employer matching contributions are recorded in the same period as the corresponding participant contributions.

#### Administrative Expenses

Administrative fees are paid by the Plan to the extent they are not paid by the Company.

#### Subsequent Events

For the purposes of recognition and disclosure in these financial statements, management of the Plan has evaluated subsequent events through September 15, 2025, which is the date these financial statements were available to be issued.

### 3. **Information Certified by the Custodian**

The Plan's investments, including interest and dividends, net appreciation in fair value of investments and investment transactions, and notes receivable from participants, interest associated with the notes receivable and notes receivable transactions were certified by Reliance Trust Company as of and for the years ended December 31, 2024 and 2023. The Plan Administrator has determined that the custodian meets the requirements of a qualified institution as defined by the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Therefore, in accordance with the request of the Plan Administrator and as permitted by CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, this information was not subjected to generally accepted auditing procedures by the Plan's independent public accountants.

### 4. **Tax Status**

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable. The Plan has adopted a non-standardized pre-approved plan sponsored by ADP, LLC. The IRS has issued an opinion letter dated October 6, 2020 for the non-standardized pre-approved plan stating that the pre-approved plan is acceptable under Section 401(a) of the Code. The Plan has been amended since the date of the opinion letter. The Plan Administrator believes that the Plan is currently being operated in compliance with the terms of the Plan and the Code and remains qualified under the Code and applicable regulations.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 5. **Stable Value Fund**

The Plan holds an investment in the Reliance Metlife Stable Value Fund, a collective trust. The Reliance Metlife Stable Value Fund's trustee is Reliance Trust Company. The primary investment objective of the Fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. The Fund invests entirely in the MetLife Group Annuity Contract 25053, which consists of separately managed investment portfolios directed by Reliance Trust Company. There are no unfunded commitments at December 31, 2024, and the fund provides for redemptions from the Plan at NAV. The fund is subject to certain events that could limit the ability of the Plan to transact at the reported NAV. These events include discontinued operations, layoffs, Plan termination, bankruptcy or reorganization, merger, early retirement incentive programs, tax disqualification of the Plan, or other events. Such events are not expected to be probable to occur.

Accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Valuations based on quoted prices in active markets for identical assets or liabilities. Valuations are obtained from readily available pricing sources for market transactions involving assets or liabilities.

Level 2 – Valuations for assets and liabilities traded in less active dealer or broker markets. Valuations are obtained from third-party pricing services for identical or similar assets or liabilities.

Level 3 – Valuations for assets and liabilities that are derived from other valuation methodologies, including option pricing models, discounted cash flow models and similar techniques, and not based on market exchange, dealer, or broker traded transactions. Level 3 valuations incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities. All assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

Mutual funds and the money market fund are valued at the quoted net asset value of shares (based on quoted market price) held by the Plan at year end. The units of the collective trust are valued using the NAV practical expedient as determined by the issuer based on the current underlying assets of the fund. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Administrative expenses include amounts paid to the custodians and recordkeeper and qualify as party-in-interest transactions.
