Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Rochester Midland Corporation 401(k) Salary Deferral and Deferred Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for plan benefits for the years then ended, and the related notes to the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of Plan

The following brief description of the Rochester Midland Corporation 401(k) Salary Deferral and Deferred Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on October 1, 1985 and is a salary reduction plan pursuant to Section 401(k) of the Internal Revenue Code. The Plan covers substantially all employees of Rochester Midland Corporation (RMC) who meet certain age requirements. The Plan is also subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan adopted a new prototype plan on November 1, 2020.

Participation in 401(k) benefits

Employees who complete one hour of service and reached age 18 are eligible to participate in the Plan. Further information concerning the Plan agreement and benefit provisions is contained in the Rochester Midland Corporation Payroll Investment Plan 401(k) Agreement. Copies of this agreement are available from the Rochester Midland Corporation 401(k) Salary Deferral and Deferred Profit Sharing Plan Advisory Committee (the Advisory Committee). In the absence of an election made by a participant, within a specific period of time as established by the Plan administrator, a participant shall be deemed to have elected a pre-tax contribution of 2.0% of his or her compensation. For new participants who are automatically enrolled in the plan after November 1, 2020, their automatic deferral percentage will increase by 1% per year up to a maximum of 6% of compensation. Starting July, 2022, the Plan allows participants to make elective after-tax Roth contributions. During 2024 and 2023, qualified pre-tax contributions totaled \$1,679,529 and \$1,608,051, respectively. During 2024 and 2023, elective after-tax Roth contributions totaled \$101,901 and \$81,724, respectively.

The Plan provides for a discretionary employer matching contribution. The matching contribution is at the sole discretion of the Board of Directors of RMC and is approved annually. Matching contributions, net of forfeitures, amounted to \$96,848 and \$107,076 for the years ended December 31, 2024 and 2023, respectively.

Participation in deferred profit sharing benefits

Employees are immediately eligible to receive the profit sharing contribution. Further information concerning the Plan agreement and the vesting and benefit provisions is contained in the Rochester Midland Corporation Deferred Profit Sharing Trust Agreement. Copies of this agreement are available from the Advisory Committee.

Participant accounts

Each participant shall have an account which will be credited with employer contributions, participant's contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances.

Administration

The Advisory Committee is responsible for the general administration of the Plan and implementation of the Plan provisions.

Participant loans

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates determined by the Plan administrator. At any time, no more than one loan may be outstanding from the Plan to the participant. Participant loans outstanding at December 31, 2024 bear interest rates of 4.25% to 9.50%.

Vesting

Participant salary deferral fund balances are fully vested at all times. Deferred profit sharing and matching contributions from RMC are vested as follows:

20% after 2nd year of participation
40% after 3rd year of participation
60% after 4th year of participation
80% after 5th year of participation
100% after 6th year of participation

Funding policy

Each eligible participant may contribute any percentage up to 90% of their compensation for the pay period as elected in the salary deferral agreement, subject to annual limitations. Participants' accounts are credited for their contributions upon disbursement of payroll. Discretionary employer matching contributions are provided for in the Plan. In addition, participants may transfer funds from other qualified plans with the consent of the Plan administrators.

Included in transfer of assets to this plan was \$217,524 and \$4,022,953 of transferred funds from the ESOP for the years ended December 31, 2024 and 2023, respectively. The fund transfers were due to the termination of the ESOP. The active participants in this Plan had their funds transferred from the ESOP to this Plan.

RMC shall provide annual discretionary profit sharing contributions to the Plan, if any, as specified by the Board of Directors of the Company for each participant eligible to share in the allocation for a plan year. The Plan is funded on a current basis. There were no discretionary profit sharing contributions made to the Plan for the years ended December 31, 2024 and 2023.

Payment of benefits

Upon retirement, death, or disability, the entire account balance, if less than \$5,000 will be distributed in the form of a lump-sum payment. If the account balance is greater than \$5,000, the participant may choose a lump-sum distribution or equal installments over various periods based on life expectancy. In addition, lump-sum distributions may be made with participant consent, under the following conditions: separation from service and upon the hardship of a participant as provided for in the Plan and in government regulations. The Plan permits participants who have attained the age of 59 ½ and are still employed by the Company to obtain distributions from their vested accounts.

Forfeitures

Forfeitures arising under the Plan are used first to offset the employer match and second to offset administrative costs. Any remaining forfeitures are available to be allocated to participant accounts. Forfeitures activity during 2024 and 2023 consisted of the following:

Basis of accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) in all material respects and present the net assets available for Plan benefits and changes in those net assets.

Notes receivable from participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest.

Revenue recognition

Purchases and sales of securities are recorded on the trade date basis. Interest and dividends are recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Fair value measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Fair value measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value.

Cash equivalents: Includes money market accounts, certificates of deposit and all highly liquid debt instruments with an original maturity date of three months or less.

Mutual funds: Values are determined based on quoted market prices in active markets.

Common collective trust: Reported at contact value of the underlying investment contracts, which approximates fair value (including guaranteed investment contracts issued by insurance companies and other financial institutions, separate account contracts and synthetic wrap contracts).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The fair value of these investments is subject to market volatility and may be susceptible to fluctuations.

Use of estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Income taxes

The Plan evaluates income tax positions for uncertainty to determine any tax positions that may not be fully sustained upon examination by taxing authorities, despite the belief that the underlying tax positions are fully supportable. Tax positions are reviewed on an ongoing basis and are analyzed in light of changing facts and circumstances, including progress of tax audits, developments in case law, and closing of statute of limitations. The Plan administrator has determined that the Plan has no uncertain tax positions. The Plan is no longer subject to examinations by the applicable taxing jurisdictions for periods prior to December 31, 2021.

Plan management's review of subsequent events

The Plan administrator evaluated events occurring between the end of the most recent Plan year and August 15, 2025, the date the financial statements were available to be issued.

6. Tax Status

The Plan obtained its latest determination letter in October, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan is qualified and is tax-exempt as of the financial statement date.
