1. DESCRIPTION OF THE PLAN

The following description of the Bauer Compressors, Inc. Employee Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) profit-sharing plan established by Bauer Compressors, Inc. (the "Employer") on January 1, 2015. The Plan was amended on May 10, 2021 to allow the merger of the Employer's Grandfathered 401(k) Profit Sharing Plan (the "Grandfathered Plan") with the Plan effective May 10, 2021. The Grandfathered Plan was originally established on October 1, 1994.

The Plan provides retirement benefits for substantially all the employees. Employees become eligible to participate in the Plan at age 19 after completing three months of service for salary deferral and six months of service for the Employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code (the "IRC").

Contributions

Participant may contribute, on a pre-tax basis or after-tax, up to 100% of their compensation, as defined by the Plan, subject to IRC limitations, in the form of a salary deferral. Participants not electing otherwise are automatically enrolled to make salary deferral contributions to the Plan in the amount of 3% of their compensation. Participants may also make rollover contributions to the Plan, which represent distributions from other qualified plans.

The Employer makes profit-sharing contributions to the Plan annually on behalf of all eligible employees. To be eligible for profit-sharing contributions employees must complete six months of service. Profit-sharing contributions are allocated amongst participants based upon the ratio that the participant's compensation for the Plan year bears to the total compensation for the Plan year of all participants. Depending on the employee's division, the profit-sharing contributions are either 4.5% or 9% of compensation.

Investment options

The Plan's investment assets are held by Empower Trust Company, LLC (the "Custodian"), the custodian of the Plan's investment assets. Under an arrangement with the Custodian and upon enrollment in the Plan, participants direct all contributions in any whole percentage increment to any of the available funds. Participants may change their allocation among the various investment options at any time.

Participant accounts

Each participant's account is credited with (a) the participant's contributions, (b) the Employers' contributions on behalf of the participant, and (c) the earnings and losses of the participant's investments and is charged with any expenses incurred as a result of transactions initiated by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately fully vested in the portion of their account attributable to their contributions and earnings thereon. Vesting in the portion of their account attributable to the Employer's contributions and earnings thereon is based on years of employment service, and occurs at a rate of 25% per year, with full vesting occurring after four years of service.

Payment of benefits

Upon termination of employment, attainment retirement age, or for reasons of death or disability, participants may withdraw the vested portion of their account in the form of a lump sum. Participants still employed with the Employer may withdraw all or a portion of their account balance attributable to their salary deferral contributions and actual earnings thereon upon attainment of age 59½ or for reasons of a financial hardship, as allowed under the IRC. A participant whose vested account balance does not exceed \$200 will receive a lump sum distribution of their vested account balance as soon as administratively feasible following termination. A terminated participant whose vested account balance is between \$200 and

\$7,000 and who does not elect otherwise, will have their vested account balance distributed from the Plan directly into an individual retirement account in their name.

#### Forfeitures

Forfeitures of nonvested account balances may be used, at the sole discretion of the Employer, to pay administrative expenses of the Plan or reduce Employer contributions. During the year ended December 31, 2024, \$23,855 was forfeited and \$13,995 was used to reduce Employer contributions. Accumulated forfeitures totaled \$33,180 and \$23,255 at December 31, 2024 and 2023, respectively.

#### Notes receivable from participants

Participants may borrow, from their fund accounts, amounts ranging from \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balances. The maximum term of repayment for a loan is five years, unless it is for the purchase of a principal residence, in which case the maximum term of repayment is fifteen years. The loans are secured by the balance in the participant's account and bear interest at fixed rates commensurate with prevailing market rates for similar loans, as determined by the plan administrator at the date of origination. Principal and interest are paid ratably through payroll deductions. A participant may only have one loan outstanding at a time. Interest rates ranged from 4.25% to 9.50% on participant loans outstanding at December 31, 2024, and 2023.

#### Administrative expenses

Administrative fees associated with participant loans and certain distributions are paid by the Plan and charged to the accounts of the participants initiating the transactions. Also, participants who have separated from service with the Employers and choose to maintain a balance in the Plan are charged an annual fee.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

#### Use of estimates in financial statement preparation

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### Investment valuation and income recognition

Investments, except for fully benefit-responsive investment contracts, are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes realized and unrealized gains and losses on those investments. See Note 4 for discussion of fair value measurements.

For fully benefit-responsive investment contracts, contract value, is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributed to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as distributions based upon the Plan's provisions.

#### Payment of benefits

Benefits are recorded when paid.

#### Expenses

Certain expenses incurred in maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Investment-related expenses are included in the net appreciation/depreciation of fair value of investments.

### Subsequent events

The Sponsor has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIAN (UNAUDITED)

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (the "DOL") Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by the Custodian, except for comparing such information to the related information included in the Plan's financial statements and supplemental schedules.

The following information included in the accompanying financial statements and supplemental schedules was prepared and certified to be complete and accurate by the Custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

### 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

#### Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

#### Level 2

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

There were no changes in the methodology used during the year ended December 31, 2024.

- Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year-end. Funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price, and are deemed to be actively traded.
- Collective trusts: Valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require a 12-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Employer believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a guaranteed investment contract (the "Contract") with Great-West Life & Annuity Insurance Company ("GW") which is a fully benefit-responsive investment contract. GW maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the Contract is fully benefit-responsive, contract value is the relevant measurement attribute for net assets available for benefits attributable to the Contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: 1) the complete or partial termination of the Plan, 2) the establishment of, or material change in, any plan investment fund, or 3) an amendment to the Plan or a change in the administration or operation of the Plan. The plan administrator does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The Contract may be terminated by GW upon the Plan's establishment, activation, or material change to any plan investment fund that GW determines will prevent its ability to continue to operate the contract under the current terms. Termination of the Contract with the GW may result in the settlement of the outstanding balance at an amount that differs from contract value.

The Contract has a guaranteed minimum interest rate of 0.00%. Crediting interest rates ranged from 1.35% - 1.45% during 2024 and from 1.15% - 1.30% during 2023, respectively.

## 6. RELATED PARTY TRANSACTIONS

The Employer pays certain costs on behalf of the Plan for insurance, administration and professional services. Recordkeeping and administrative services are also provided by the Employers at no cost to the Plan.

The Plan offers, as investment options, certain funds managed by the Custodian. Accordingly, transactions in these investments qualify as party-in-interest transactions as defined by ERISA.

## 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 8. INCOME TAX STATUS

The Plan utilizes a prototype plan document sponsored by Great-West Trust Company, LLC, who was informed by the Internal Revenue Service ("IRS") by a letter dated June 30, 2020, that the plan, as amended, is designed and being operated in accordance with applicable sections of the IRC. Though the Plan has not received a determination from the IRS, the Employer and the Plan's tax counsel believe that the Plan is designed and being operated in accordance with the applicable sections of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress and the plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

## 9. RECONCILIATION TO FORM 5500

## 10. PLAN TERMINATION

Although they have not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants would become 100% vested in their accounts.

## 11. PLAN AMENDMENTS

Effective October 1, 2024, Automatic Contribution Agreement provision includes an automatic 1% increase in contributions each year, up to a maximum of 6%.

Effective January 1, 2024, the Sponsor increased the threshold for forced distributions of terminated participants from \$5,000 to \$7,000 as permitted under the Secures Act 2.0.
