We have performed an audit of the financial statements of Vernet US Corporation 401(k) Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

### Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). 

## NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

### 1. DESCRIPTION OF PLAN

The following description of the Vernet US Corporation 401(k) Retirement Savings Plan (the Plan), formerly the Caltherm Corporation 401(k) Retirement Savings Plan, provides only general information. Plan participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan sponsor is Vernet US Corporation (Company), which is the holding company of Caltherm Corporation (Employer).

In October 2019, Vernet US Corporation's shareholder, Magnum Corporation, purchased Rostra Vernatherm. The company, whose name was changed to Vernatherm by Vernet (Vernatherm), sponsored a 401(k) plan for its salaried employees that was merged with the Plan in September 2020.

#### GENERAL

The Plan is a defined contribution plan that includes salary deferral features and is intended to meet the requirements of a qualified plan under Section 401(k) of the Internal Revenue Code. The Plan provides for retirement benefits and is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA) as amended. All employees who are at least 18 years of age and have completed 3 months of service may elect to participate in the Plan. The Plan was established April 1, 1993 and amended at various times. The assets of the Plan are held and recordkeeping services are provided by The Standard Insurance Company, Inc. (The Standard).

#### CONTRIBUTIONS

The Employer may make matching contributions equal to a discretionary percentage, to be determined annually by the Company, of the participants' salary reductions. The Employer may also make a discretionary contribution, which is not limited to its current or accumulated net profit.

Participants may elect to contribute up to an annual maximum prescribed under the Internal Revenue Code (IRC). Participants may also contribute amounts distributed from other qualified plans. Participants over age 50 may make additional contributions as provided by the IRC. Participants who do not complete a salary deferral agreement upon Plan eligibility will automatically be enrolled in the Plan with salary deferrals of 5% of eligible earnings contributed to the Plan.

#### PARTICIPANT ACCOUNTS

Individual accounts are maintained for each participant and are credited with each participant's contributions and allocation of: (a) Employer contributions and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct investments in their accounts into several investment options and are allowed to change investment selections on a daily basis.

#### BENEFITS

Distribution of a participant's interest in the Plan may occur due to death, disability, retirement or other reasons. A participant will receive a lump-sum amount equal to the value of the participant's account balance. Benefits are recorded when paid.

### VESTING

Participants are always 100% vested in their contributions plus actual earnings thereon. Employer contributions vest at 25% per year and are 100% vested after 4 years of service for employees who entered the Plan prior to September 1, 2020. Beginning September 1, 2020, participants are 100% vested in employer contributions.

### NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts up to the lesser of \$50,000 less than the highest outstanding loan balance in the last 12 months, or 50% of the participant's vested account balance. Participants are limited to two outstanding loans at any given time. Loans must be repaid ratably as to principal and interest over a period not to exceed five years through payroll withholdings, unless used to acquire or construct the primary residence of the participant. The loan is secured by the 100% vested portion of the participant's account balance and bears interest at a fixed rate that is comparable to commercial lending rates. Outstanding notes receivable from participants totaled \$134,738 and \$151,435 at December 31, 2024 and 2023, respectively.

### PLAN TERMINATION

Although the Employer has not expressed intent to discontinue participation in the Plan, they may do so at any time upon resolution by the Company's Board of Directors subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in Employer contributions.

### FORFEITED ACCOUNTS

Forfeited nonvested accounts were \$-0- for both of the years ended December 31, 2024 and 2023. According to Plan provisions, these accounts will be used to pay administrative expenses or reduce future employer contributions. For the years ended December 31, 2024 and 2023, forfeited nonvested accounts of \$292 and \$2,365 were used for administrative expenses, respectively.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

### BASIS OF ACCOUNTING

The accounts of the Plan are maintained and the accompanying financial statements have been prepared on the modified cash basis. Investment income is recognized when received; disbursements are recognized when paid; and contributions are recorded when received. Additionally, investments are reflected at fair value.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

### ESTIMATES

The Plan Administrator uses estimates and assumptions in preparing modified cash basis of accounting financial statements which require the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

### INVESTMENT VALUATION AND INCOME RECOGNITION

The Standard Insurance Company, Inc. maintains the Plan's investment funds. The Plan's investments held in the insurance company's general account are reported at contract value. Pooled separate accounts are valued at fair value at the net asset value (NAV) of the pooled separate accounts as provided by the custodian. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Net appreciation or depreciation of investments is reported in the statement of changes in net assets available for benefits and consists of the realized gains and losses and the unrealized appreciation or depreciation of these investments. Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as received.

### EXPENSES OF THE PLAN

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

### **3. INCOME TAXES**

The Plan is based on a prototype plan sponsored by The Standard Insurance Company, Inc., the Custodian of the Plan, which has received a favorable opinion letter from the Internal Revenue Service that the prototype plan is designed to qualify as being exempt from federal income taxes. The Plan Administrator has not separately applied for a determination letter from the Internal Revenue Service. The prototype plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRC. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 4. PARTY-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such a person.

At December 31, 2024 and 2023, certain investments of the Plan were held in investment funds managed by The Standard. Agresta, Storms & O'Leary, PC served as the Plan's auditors. Transactions with these parties qualify as party-in-interest transactions. The Employer provides certain accounting, recordkeeping and administrative services to the Plan, for which it is not compensated.

### 5. INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, The Standard, the Custodian of the Plan at December 31, 2024 and 2023, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits and the schedule of assets (held at end of year) at December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### 6. INVESTMENT IN GUARANTEED INTEREST ACCOUNT

The Plan had an investment in the Standard Stable Asset A Fund (the Fund) as of and for the years ended December 31, 2024 and 2023. The fund is a fully benefit-responsive investment fund for the collective investment of qualified plans. Because the investment is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the fully benefit-responsive contracts. Such contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the fund to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract value of the investment in the Fund was \$1,240,987 and \$1,182,039 at December 31, 2024 and 2023, respectively.

### 7. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in accordance with FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures* (ASC 820) in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ASC 820 defines fair value, establishes a framework for measuring fair value under generally accepted accounting principles and expands disclosures about fair value measurements. ASC 820 establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the inputs used to measure fair value are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than quoted prices in Level 1, such as quoted prices for similar assets and liabilities in active markets, similar assets and liabilities in markets that are not active or can be corroborated by observable market data.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities. This includes certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

### 10. SUBSEQUENT EVENTS

In accordance with ASC Topic 855, Subsequent Events, the Plan has evaluated events through September 16, 2025, which is the date these financial statements were available to be issued, and has determined that there are no subsequent events that require disclosure in the financial statements.
