**NOTE 1**    **DESCRIPTION OF PLAN**

The following description of the Manganaro 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document or the Summary Plan Description for a more complete description of the Plan's provisions.

**GENERAL**

The Plan is a defined contribution plan covering all employees except non-office personnel and those subject to collective bargaining agreements of Manganaro North America, Inc. and its subsidiaries (collectively referred to as the Company), provided the employee is at least 21 years old and attains certain minimum levels of service with the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**CONTRIBUTIONS**

Each year, participants may contribute up to the annual limitations defined in the Internal Revenue Code (IRC). In addition, participants may rollover distributions received from other qualified plans.

The Company makes an annual matching contribution of 50% of the elective deferrals that do not exceed 7% of compensation, as defined by the Plan. The Company may elect, at its sole discretion, to make additional contributions. No discretionary contributions were made for the year ended December 31, 2024.

**PARTICIPANT ACCOUNTS**

Each participant's account is credited with the participant's contribution, an allocation of Plan earnings, Plan expenses, and any discretionary Company contributions. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**VESTING**

Participants hired before July 1, 2017 are immediately vested in their voluntary contributions and the Company's matching and discretionary contributions. Participants hired after June 30, 2017 are fully vested in their voluntary contributions and the Company's matching and discretionary contributions after two years of service with the Company. A year of service is defined as a minimum of 1,000 hours within a Plan year.

**INVESTMENT OPTIONS**

Upon enrollment in the Plan, a participant may direct contributions into various investment options offered by the Plan.

**NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow against the balance in their account, up to the lesser of 50% of their vested balance or \$50,000. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans mature within five years or longer for the purchase of a primary residence.

**PAYMENT OF BENEFITS**

Benefits are payable as soon as practicable following normal retirement, disability, death, or termination of employment, subject to specific benefit payment requirements in the Plan Document.

**FORFEITED ACCOUNTS**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,127 and \$7,295, respectively. These accounts will be used to reduce future Company contributions in accordance with the Plan Document.

**ADMINISTRATIVE EXPENSES**

Certain administrative expenses of the Plan are paid by the Company. In addition, the Company provides services to the Plan without charge.

**PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. Upon termination of the Plan, all interests of the participants not previously vested would become vested and non-forfeitable, and the net assets of the Plan would be distributed to participants based upon individual equities in the Plan.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**BASIS OF ACCOUNTING**

The accompanying financial statements are prepared on the accrual basis of accounting.

**ACCOUNTING STANDARDS CODIFICATION**

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

*(See Independent Auditors' Report)*

#### USE OF ESTIMATES

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### VALUATION OF INVESTMENTS

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year ended December 31, 2024.

#### BENEFIT PAYMENTS

Benefits are recorded when paid.

#### RISK AND UNCERTAINTIES

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

#### **NOTE 3** VALUATION OF INVESTMENTS

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*(See Independent Auditors' Report)*

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Money Market and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at period end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Common/Collective Trusts: Valued using NAV. NAV is quoted on a private market that is not active; however, the unit price is based on underlying investments which are traded on an active market.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 TAX STATUS**

The Plan obtained its latest determination letter dated December 28, 2017, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan was amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 5 RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by the Trustee of the Plan. These transactions qualify as party-in-interest transactions. The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$78,000 for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

In addition, certain administrative fees were paid indirectly through revenue sharing and are included in the net appreciation in fair value of investments.

**NOTE 6**    **SUBSEQUENT EVENTS**

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through August 5, 2025, the date the financial statements were available to be issued.
