Note 1 - Plan Description

The following description of Michigan Health & Hospital Association 401(k) Thrift and Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

In 1985, Michigan Health & Hospital Association implemented a multiple-employer defined contribution plan. The Plan covers substantially all employees of the following entities: Michigan Health & Hospital Association; Michigan Health & Hospital Association Service Corporation; MHA Health Foundation; and Health Care Legal Group, P.C. (collectively, the "Company"). Health Care Legal Group, P.C. exited the Plan during 2024. The Plan was restated effective January 1, 2021.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The terms of the Plan are intended to comply with Internal Revenue Code (IRC) Sections 401(a) and 401(k) and the Treasury regulations issued thereunder in order that the Plan may qualify as a tax-exempt profit-sharing plan under Internal Revenue Code Section 501(a). All employees, except those who are leased, independent contractors, co-op students, and temporary employees of Michigan Health & Hospital Association and participating related entities, as listed above, are eligible to voluntarily participate in the Plan. Summaries of the Plan's provisions are as follows:

Contributions

The Plan provides for elective deferral contributions by the participants subject to dollar limitations contained in Internal Revenue Code Section 402(g). The Plan provides for nonelective safe harbor employer contributions equal to 3 percent of eligible compensation to all eligible participants. The Plan also provides for discretionary employer contributions to eligible participants. Discretionary contributions totaled approximately \$1,047,000 for the year ended December 31, 2024.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participant Notes Receivable

The Plan allows participants to borrow money from their accounts up to the lesser of (1) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made over the outstanding balance of loans from the Plan on the date the loan is made or (2) one-half of the participant's account balance. Participant notes receivable, other than qualifying home loans, must have a term of no longer than five years and will bear interest at a reasonable rate. The notes receivable are collateralized by the balance in the participant's account.

Party-in-interest Transactions

Certain administrative costs are paid by the participating entities. Additionally, the Plan invests in certain investments managed by Alerus Financial, N.A. Alerus Financial, N.A. is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Benefit Payments

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or a direct rollover to another qualified retirement plan, an Internal Revenue Code Section 403(b) tax deferred annuity, a governmental 457 plan, or an IRA. In addition, the Plan allows for in-service withdrawals.

Vesting

Participants are immediately 100 percent vested in voluntary contributions, rollovers, and employer safe harbor matching contributions.

A participant's vested percentage in the Company's employer discretionary contributions, if any, shall be determined in accordance with the following:

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce employer contributions. Forfeitures were not significant at December 31, 2024 or 2023.

Termination

While it has not expressed any intent to do so, each participating entity has the right under the Plan to discontinue its contributions at any time and to terminate its participation in the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100 percent vested in their account balances, including employer contributions and earnings thereon.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. See Note 5 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 21, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Alerus Financial, N.A. (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan is a preapproved plan. The Plan has sought and received its own determination letter in July 2022, covering amendments through May 2022, indicating that the Plan, as designed, is qualified for federal income tax-exempt status.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of Michigan Health & Hospital Association 401(k) Thrift and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Plan Description

The following description of Michigan Health & Hospital Association 401(k) Thrift and Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

In 1985, Michigan Health & Hospital Association implemented a multiple-employer defined contribution plan. The Plan covers substantially all employees of the following entities: Michigan Health & Hospital Association; Michigan Health & Hospital Association Service Corporation; MHA Health Foundation; and Health Care Legal Group, P.C. (collectively, the "Company"). Health Care Legal Group, P.C. exited the Plan during 2024. The Plan was restated effective January 1, 2021.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The terms of the Plan are intended to comply with Internal Revenue Code (IRC) Sections 401(a) and 401(k) and the Treasury regulations issued thereunder in order that the Plan may qualify as a tax-exempt profit-sharing plan under Internal Revenue Code Section 501(a). All employees, except those who are leased, independent contractors, co-op students, and temporary employees of Michigan Health & Hospital Association and participating related entities, as listed above, are eligible to voluntarily participate in the Plan. Summaries of the Plan's provisions are as follows:

Contributions

The Plan provides for elective deferral contributions by the participants subject to dollar limitations contained in Internal Revenue Code Section 402(g). The Plan provides for nonelective safe harbor employer contributions equal to 3 percent of eligible compensation to all eligible participants. The Plan also provides for discretionary employer contributions to eligible participants. Discretionary contributions totaled approximately \$1,047,000 for the year ended December 31, 2024.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Participant Notes Receivable

The Plan allows participants to borrow money from their accounts up to the lesser of (1) \$50,000 reduced by the excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the loan is made over the outstanding balance of loans from the Plan on the date the loan is made or (2) one-half of the participant's account balance. Participant notes receivable, other than qualifying home loans, must have a term of no longer than five years and will bear interest at a reasonable rate. The notes receivable are collateralized by the balance in the participant's account.

Party-in-interest Transactions

Certain administrative costs are paid by the participating entities. Additionally, the Plan invests in certain investments managed by Alerus Financial, N.A. Alerus Financial, N.A. is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 1 - Plan Description (Continued)

Benefit Payments

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or a direct rollover to another qualified retirement plan, an Internal Revenue Code Section 403(b) tax deferred annuity, a governmental 457 plan, or an IRA. In addition, the Plan allows for in-service withdrawals.

Vesting

Participants are immediately 100 percent vested in voluntary contributions, rollovers, and employer safe harbor matching contributions.

A participant's vested percentage in the Company's employer discretionary contributions, if any, shall be determined in accordance with the following:

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce employer contributions. Forfeitures were not significant at December 31, 2024 or 2023.

Termination

While it has not expressed any intent to do so, each participating entity has the right under the Plan to discontinue its contributions at any time and to terminate its participation in the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100 percent vested in their account balances, including employer contributions and earnings thereon.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) or its equivalent of the funds, which is based on the fair value of the funds' underlying assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. See Note 5 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Note 2 - Summary of Significant Accounting Policies (Continued)

Benefit Payments

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including August 21, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Alerus Financial, N.A. (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan is a preapproved plan. The Plan has sought and received its own determination letter in July 2022, covering amendments through May 2022, indicating that the Plan, as designed, is qualified for federal income tax-exempt status.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
