### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

#### Note 1 - Plan Description

The following description of Adena Health System Tax Deferred Annuity/Matched Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan, established on January 1, 1998 and restated as of January 1, 2021, covering all eligible employees of the Plan's sponsor, Adena Health System (the "System"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Contributions**

The Plan provides for employee salary contributions subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan has an auto-enrollment feature where all newly eligible employees are automatically enrolled in the Plan at a 3 percent deferral rate unless they affirmatively elect otherwise. The Plan also has an auto-escalation feature of 1 percent increases per year to a maximum of 6 percent of eligible compensation unless participants affirmatively elect otherwise. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. Contributions to the Plan are invested as directed by participants in any one or more investment alternatives.

During 2022, the System remitted certain employee deferrals to the Plan after the Department of Labor's required time frame. A contribution of the lost earnings was made during 2023. Certain participant contributions in 2023 were paid after the time frame required by the Department of Labor. The System remitted these contributions and related lost earnings during 2023.

Certain participant contributions in 2024 were paid after the time frame required by the Department of Labor. The System remitted these contributions during 2024 and plans to remit related lost earnings to the Plan in 2025.

The Plan provides for employer safe harbor matching contributions of 100 percent of the participant's contribution up to 4 percent of the employee's deferred compensation and 50 percent of the participant's contribution in excess of 4 percent, but not in excess of 6 percent, of deferred compensation. Effective May 12, 2024, the Plan was amended to update the employer safe harbor matching contribution to 100 percent of the participant's contribution up to 1 percent of the employee's deferred compensation and 50 percent of the participant's contribution for the next 5 percent of deferred compensation. The Plan also allows for employer discretionary contributions to be determined by the System. However, the System elected not to make any such discretionary contributions for the years ended December 31, 2024 and 2023.

##### **Participant Accounts**

The Variable Annuity Life Insurance Company (VALIC Life) and VALIC Trust Company Inc. (formerly known as AIG Federal Savings Bank) maintain individual accounts for each participant for the deposit of contributions and earnings thereon. Earnings and plan expenses on plan assets are distributed based upon the participant's pro rata share of the total account balances.

##### **Administration**

The System is the sponsor of the Plan. The retirement committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. VALIC Life and VALIC Trust Company Inc. function as the trustees and investment managers. Investment management fees and trustee fees are paid by the Plan in accordance with the plan agreement.

### Note 1 - Plan Description (Continued)

#### ***Participant Notes Receivable***

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balances, whichever is less, as prescribed in the Plan and the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a market rate.

#### ***Plan Loans***

Participants may borrow a minimum of \$1,000 up to a maximum of \$50,000 or 50 percent of their account balances, whichever is less, from The Variable Annuity Life Insurance Company, a trustee of the Plan, using invested funds as collateral for the loan. VALIC Life transfers an amount equal to the original principal of the loan into a loan collateral account and amounts equal to the first quarter of interest due and potential surrender charges into a loan escrow account. The loan collateral account and the loan escrow account are invested in the VALIC Fixed Account Plus investment option. The participant's account is not reduced; collateral is released to the participant-controlled investments as loan payments are made. Loans bear interest at market rates. The amount of these outstanding loans was \$335,413 and \$421,078 at December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, \$268,398 and \$323,519, respectively, of these loan balances was in default.

#### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is 100 percent vested in the employer safe harbor matching and discretionary contribution portion of their account after two years of credited service.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$95,567 and \$108,635, respectively. The forfeiture balances are included within the fixed-interest investment account.

#### ***Benefit Payments***

Upon termination of employment, a participant, or, in the case of death, the beneficiary or surviving spouse, may elect to receive the participant's vested account balance in a single lump sum or in various installment annuities.

Participants may request that all or a portion of their account be distributed in the case of financial hardship, as defined in the plan document. The plan administrator must approve any such hardship withdrawals.

#### ***Termination***

While it has not expressed any intent to do so, the System has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

#### ***Party-in-interest Transactions***

Certain plan assets are investment funds managed by VALIC Trust Company Inc., VALIC Life, or their affiliates. VALIC Life and VALIC Trust Company Inc. are the trustees of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

### Note 2 - Summary of Significant Accounting Policies

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value except the fully benefit-responsive investment contracts valued at contract value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. See Note 5 for additional information.

Variable separate accounts are valued at net asset value per share (NAV) or its equivalent, which is based on the fair value of the funds' underlying assets. All other investments are valued based on quoted market prices reported in active markets. See Note 6 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Certain administrative expenses, including audit fees, are paid by the System.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including August 14, 2025, which is the date the financial statements were available to be issued.

### Note 3 - Certified Information

The Variable Annuity Life Insurance Company and VALIC Trust Company Inc. (collectively, the "Trustees") hold the Plan's investments and participant notes receivable and execute all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustees.

### Note 4 - Tax Status

The Plan, as adopted, is a volume submitter plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The volume submitter plan has received a favorable notification letter from the IRS dated April 5, 2018. The Plan has not individually sought its own determination letter.

### Note 5 - Unallocated Investment Contracts

The Plan has benefit-responsive investment contracts with VALIC Life. VALIC Life maintains these contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise.

The interest crediting rate for the VALIC Fixed Interest and VALIC Fixed Account Plus contracts is based on a formula agreed upon with the contract issuers, but it may not be less than 3 percent for participant accounts set up before December 1, 2003 and 2 percent for participant accounts set up on or after December 1, 2003. The minimum crediting rate for the VALIC Short Term Fixed Account is 1 percent. Interest crediting rates are reviewed on a periodic basis for resetting. When establishing interest crediting rates for this product, VALIC Life considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the Plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable. There are no events that allow the issuer to terminate the contracts and that require the plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

As described in Note 2, because the contracts are fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets attributable to the investment contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

### Note 6 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### **Level 1**

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### **Level 2**

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

### Note 6 - Fair Value Measurements (Continued)

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
