Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of Renesas Electronics America Inc. Short Term Disability Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of benefit obligations and net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in benefit obligations and net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – The Plan and Its Significant Accounting Policies

General – The following description of Renesas Electronics America Inc. Short Term Disability Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of Plan provisions.

The Plan is a self-insured health and welfare benefit plan available to full-time and part-time U.S. employees of Renesas Electronics America Inc. (the Company) who reside in states with no short-term disability state program. The Plan provides salary replacement payments to participants in the event of a short-term disability.

Administration – Under the terms of the Plan, a group of designated officers of the Company act as the trustee. The Company has appointed certain employees of the Company to manage the operation and administration of the Plan. The Company has contracted with California Bank and Trust to act as the custodian, and has appointed the TRISTAR Benefit Administrators, Inc. (TRISTAR) to act as the third-party administrator to process and maintain the records of participant claims. Substantially, all expenses incurred for administering the Plan are paid by the Company.

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The Plan's investment is stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 2 for discussion of fair value measurements.

Income recognition – Interest income is recorded on the accrual basis.

Cash accounting – The Plan holds non-interest-bearing cash, which recognized activity at the time that cash is either deposited or disbursed.

The Plan maintains its cash in bank deposit accounts, which, at times, exceed federally insured deposit limits. If any of the financial institutions with whom the Plan does business were to be placed into receivership with the Federal Deposit Insurance Corporation, the Plan may be unable to access the cash on deposit with such institutions. If the Plan were unable to access its cash and cash equivalents as needed, the Plan's financial position and ability to complete transactions could be adversely affected.

Payment of benefits – Claim payments are recorded when paid by TRISTAR, the third-party claims processors.

Income taxes – The Voluntary Employee Beneficiary Association (VEBA) trust received an exemption letter from the Internal Revenue Service dated May 21, 1992, stating that the VEBA trust is tax-exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (the Code). In addition, the Plan and the related VEBA trust are required to operate in conformity with the Code to maintain the tax-exempt status of the VEBA trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related VEBA trust is tax-exempt.

The Plan administrator believes that the Plan is operated in accordance with, and qualifies under, the applicable requirements of the Code and related state statutes, and that the VEBA trust, which forms a part of the Plan, is exempt from federal income and state franchise taxes. In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Subsequent events – The Plan has evaluated subsequent events through September 15, 2025, which is the date the financial statements were available to be issued.

Note 2 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation technique used for assets measured at fair value. There have been no changes in the technique used at December 31, 2024 and 2023.

The certificate of deposit account is valued at amortized cost, which usually approximates fair value.

Note 3 – Contributions and Benefit Payments

The Plan provides for participant contributions to be made in the form of payroll withholdings. Participant contributions made to the Plan are at the discretion of the Plan administrator, and were 0.6% of participants' annual earnings, up to a maximum of \$153,164 for the year ended December 31, 2024. In addition, the Company is obligated to satisfy funding deficiencies in plan assets that may arise if claims incurred exceed participant contributions and Plan assets.

Participants are eligible to receive salary replacement payments upon disability, as defined in the Plan, up to 70% of the participant's weekly eligible salary, up to a maximum amount of \$2,308, for the first 180 days of disability, as described in the Plan.

Participants are eligible to receive Paid Family Leave, up to 70% of the participant's weekly eligible salary for the first 70 days of family leave, as described in the Plan.

Benefit payments are paid directly from the Plan VEBA trust.

Note 4 – Plan Obligations

Plan obligations at December 31, 2024 and 2023, for disability claims payable and claims incurred by active participants but not reported at that date, and for future disability payments to participants considered disabled at December 31, 2024 and 2023, are estimated by the Plan based on an analysis of actual payments subsequent to the Plan's year end. Future payments to participants considered disabled, and disability claims incurred by active participants but not reported at December 31, 2024 and 2023, were approximately \$39,000 and \$42,000, respectively.

Note 5 – Related Party Transactions

The certificate of deposit is managed by California Bank and Trust, the custodian of the Plan. Transactions such as deposits and disbursements, while considered party-in-interest transactions under ERISA regulations, are permitted under the provision of the Plan and are specifically exempt from the prohibition of party-in-interest under ERISA.

Note 6 – Plan Termination or Modification

The Company intends to continue the Plan indefinitely for the benefit of its employees; however, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. Upon termination of the Plan, participants whose disability commenced prior to termination are entitled to their full benefits under the terms of the Plan. Any remaining undistributed funds are to be disposed of for the benefit of covered individuals. In the event that benefits due and payable exceed available funds, the Company will contribute to the Plan such amounts as may be necessary to ensure continuance of such benefit payments.


