# MINDEX TECHNOLOGIES, INC. 401(K) PROFIT SHARING PLAN

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the Mindex Technologies, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a qualified defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code. The Plan covers substantially all the employees of Mindex Technologies, Inc. (the Company) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Administration and Custodian**

The Company is the sponsor and administrator of the Plan. Fidelity Management Trust Company (Fidelity) is the trustee and custodian of the Plan's assets and provides recordkeeping and administrative services for the Plan.

#### **Eligibility**

Full-time employees are eligible to participate in the Plan on the first day of the month following the participant's date of hire and the attainment of eighteen years of age. Part-time employees are eligible to participate in the Plan after completing 1,000 hours of service and the attainment of twenty-one years of age and enter the Plan on the first day of the month following the satisfaction of these requirements.

#### **Contributions**

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 7% of eligible compensation and their contributions treated as a pre-tax deferral. The Plan also includes an auto-increase provision whereby on January 2<sup>nd</sup> of each Plan year, participant's deferral rate will increase by 1% up to a maximum of 15% of compensation. Participants may complete a salary deferral agreement to elect an alternative deferral amount or to elect not to defer under the Plan in accordance with the deferral procedures of the Plan. Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan, up to the maximum amount allowable in accordance with applicable sections of the Internal Revenue Code (IRC) (Elective Deferrals). Participants may also make Roth contributions subject to certain limitations under the IRC. Participants may also rollover contributions from other qualified retirement plans. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

Additional discretionary matching and profit-sharing contributions may be contributed at the option of the Company. The discretionary matching contributions are based on a percentage of a participant's elective deferral amount. For the years ended December 31, 2024 and 2023, the discretionary matching contribution was equal to 25% of a participant's elective deferrals, up to a maximum of \$10,000 of participant contributions (resulting in a maximum employer match of \$2,500) each Plan Year. The Company did not make any discretionary profit-sharing contributions in 2024 or 2023.

## 1. DESCRIPTION OF PLAN (Continued)

### Participant Accounts

Participants direct the investment of their contributions and employer matching and discretionary profit-sharing contributions into the various investment options offered by the Plan. Each participant's account is credited with the elective deferral contributions, employer discretionary matching contributions and profit-sharing contributions, and Plan earnings, losses, and administrative expenses. Allocations of earnings (losses) and administrative expenses are based on participant earnings or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately 100% vested in their contributions plus actual earnings thereon. Employer discretionary matching and profit-sharing contributions plus earnings thereon become 33% vested upon completion of one year of service and continue to vest at the rate of 33% for each successive year of service until 100% vested after three years of service.

### Forfeitures

Forfeitures of non-vested discretionary matching and profit-sharing contributions are used to reduce future employer contributions or offset administrative expenses. Unused amounts are held and invested in a segregated account within the Plan. In 2024 and 2023, there were forfeitures of non-vested employer contributions and earnings on unused amounts totaling \$91,433 and \$62,072, respectively. At December 31, 2024 and 2023, there was \$14,422 and \$11,023, respectively, available to reduce future employer contributions or pay administrative expenses. In 2024 and 2023, forfeitures of \$88,034 and \$53,646, respectively, were used to reduce employer contributions or to offset administrative expenses.

### Benefit Payments

Upon retirement, death, hardship, or termination of employment, a participant may elect to receive benefits either in a lump-sum distribution of their vested account balance or in the form of an annuity. Participants may also elect an in-service distribution upon attaining age 59 ½. Participants whose vested account balance is \$7,000 or less at the time of termination are subject to the involuntary cash-out provisions of the Plan.

### Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's pre-tax contribution account. All hardship withdrawals must comply with IRC rules relating to hardship withdrawals, which are uniformly applicable to all participants.

### Administrative Expenses

Expenses associated with the administration of the Plan are paid by both the Company and the Plan.

### Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, each participant's account will become fully vested.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The Plan's financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Investments and Income Recognition**

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### **Fair Value Measurements - Definition and Hierarchy**

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820* (ASC 820) establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

A description of where the Plan's investments fall within the hierarchy is provided in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

### **Benefit Payments**

Benefit payments are recorded when paid.

### **Revenue Credits**

Revenue credits are provided under the agreement with Fidelity, whereby a portion of the fees paid for services is returned to the Plan. Revenue credits received are recorded other revenue on the statements of changes in net assets available for benefits. The Plan allocates such excess revenue to accounts of eligible participants, typically as a negative expense.

### **Risks and Uncertainties**

Investments are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in values in the near term would materially affect participants' account balances and the amount reported in the accompanying financial statements.

### **Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

### Reclassifications

Certain reclassifications have been made to the prior year's financial statements in order to enhance comparability with the current year's presentation.

(a) In accordance with Subtopic 820-10, certain investments that were measured at net asset value ("NAV") per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

There were no changes to the valuation methodologies used during 2024 and 2023.

The following is a description of the valuation methodology used for assets measured at fair value:

*Mutual funds:* Valued at fair value based on quoted market prices in active markets.

*Self-directed brokerage accounts:* Accounts primarily consist of mutual funds that are valued at the daily closing price as reported by the fund.

*Money market fund:* Valued at fair value based on quoted market prices in active markets.

*Common/collective trust:* Valued at fair value using the net asset value (NAV) per share practical expedient, based on the value of the underlying investments held at year end, divided by the number of units outstanding. The unit price is set by the trustee; however the unit price is based on the market value of the underlying investments as measured at the close of business on the valuation date and is primarily based on observable inputs. The primary investment objective of the common/collective trust is to seek income while preserving the principal investment. These accounts do not have any unfunded commitments. The Plan can redeem these investments daily. There are currently no redemption restrictions on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity, the trustee, and therefore, these transactions qualify as party-in-interest transactions.

Fees incurred by the Plan for the investment management services are included in other revenue, as they are paid through revenue sharing, rather than a direct payment. Fidelity receives revenue from investment fund service providers for services Fidelity provides to the funds. This revenue is used to offset certain amounts owed to Fidelity for its administrative services to the Plan. If the revenue received by Fidelity from such investment fund service providers exceeds the amount owed for its services, Fidelity remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to Fidelity for administrative expenses not covered by revenue sharing.

## 6. TAX STATUS

The Plan adopted a pre-approved plan offered by FMR LLC. The pre-approved plan received an Internal Revenue Service (IRS) Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 7. RECONCILIATION TO FORM 5500

Certain items are classified differently between the financial statements and Form 5500. Net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.
