## **Independent Auditor's Report**

### **To the Plan Administrator of the Denver Art Museum Retirement Plan**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the accompanying financial statements of the Denver Art Museum Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Denver Art Museum Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**(1) General Description of the Plan**

The following description of the Denver Art Museum Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**(a) General**

On January 1, 2016, the Denver Art Museum (the Museum) established the Denver Art Museum Retirement Plan (the Plan). The Plan is a defined contribution plan that covers all employees of the Museum. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**(b) Contributions**

New employees are automatically enrolled in the plan at an automatic deferral rate of 2%. Beginning January 1, 2020, the automatic deferral will automatically increase by 2% each year until reaching 10% in the 5<sup>th</sup> year of participating in the Plan. Participants may change their elective deferral at any time and may contribute to the Plan the maximum amount allowed by law. Participants who have attained age 50 during a calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans as rollover contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers twenty-seven investment options for participants. A participant becomes eligible for employer contributions and employer's match after one year of continuous service and totaling at least 1,000 service hours. For the years ended December 31, 2024 and 2023, the Museum made discretionary contributions to the Plan equal to 3% of participating employees' compensation and employer matching contributions up to 2% of employee salary for employees who made elective deferrals. Employer contributions are invested in the portfolio of investments as directed by the participant.

**(c) Participant Accounts**

Each participant's account is credited with the participant's, Museum's, and rollover contributions and participant earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

If a participant terminates employment and their vested balance is \$5,000 or less, a lump sum mandatory distribution will be made to the participant. If a participant terminates employment and has a vested balance of more than \$5,000, the participant may elect to receive a distribution of a portion or all of the participant's vested account balance.

**(d) Vesting**

Contributions, pre-tax deferrals, and income earned thereon are fully vested immediately and cannot be forfeited, even if employment is terminated or an employee becomes ineligible to participate in the Plan.

### (1) General Description of the Plan, Continued

#### (e) Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. A participant can only have one loan outstanding at a time. The loans are issued directly from and secured by a participant's vested account balance. All loans bear a reasonable interest rate, established by the Denver Art Museum Fiduciary Committee, which is the Prime interest rate. Loans require bi-weekly payments through payroll deductions in a level amortization schedule over a period not exceeding five years, except in the purchase of a primary residence, in which case, the term is up to ten years. Total loans outstanding at December 31, 2024 and 2023 were \$180,411 and \$108,914, respectively.

#### (f) Plan transfers

The Museum decided to terminate their Denver Art Museum DC Plan (the DC Plan) effective December 31, 2015. Active participants of the DC Plan had the option to transfer their balance to this Plan. However, some participants did not have the ability to transfer all of their funds, if their account was invested in a certain annuity with withdrawal restrictions. As those withdrawal restrictions are released additional transfers could occur in future years, until all those funds are released. Many active participants transferred their funds to this Plan, and the total Plan transfers were \$58,975 and \$57,781 during the years ended December 31, 2024 and 2023, respectively.

#### (g) Payment of Benefits

On termination of service due to death, a single lump-sum cash payment or annuity option will be made to the participant's designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution, an annuity option, or a direct rollover to an individual retirement account or to another employer's tax qualified plan. Participants who are age 59 ½ and still employed by the Museum may withdraw all or a portion of their respective account balance.

#### (h) Expenses

Plan administration fees are paid from the assets of the Plan. Expenses are allocated among all Plan participants or charged directly against individual account balances. Fees charged directly to individual account balances include general recordkeeping fees and expenses related to processing distributions or loans, qualified domestic relations orders, and directing the investment of the participant's account balance. Total fees for the years ended December 31, 2024 and 2023 were \$1,604 and \$4,623, respectively. Total fees charged directly and indirectly to the Plan for the years ended December 31, 2024 and 2023 were \$58,041 and \$44,758, respectively.

**(1) General Description of the Plan, Continued**

**(i) Hardship Distributions**

The Plan permits the withdrawal of a hardship distribution by a participant to satisfy immediate and heavy financial needs. A hardship distribution may be made only for certain needs, including medical expenses, costs related to the purchase of a principal residence, costs to prevent eviction from a principal residence, burial or funeral expenses, expenses for the repair of damage to a participant's personal residence, Federal, state or local income taxes or penalties anticipated to result from a hardship distribution, or certain educational expenses for post-secondary education. Furthermore, the distribution cannot be in excess of the amount of the participant's immediate and heavy financial need; and all other distributions, other than hardship distributions, and all loans currently available under the Plan must have been exhausted. The distribution can be made only from the participant's salary deferrals (including catch-up contributions), or employer contributions held in annuity contracts.

**(2) Summary of Accounting Policies**

**(a) Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**(b) Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**(c) Investments**

Investments are reported at fair value, except for the Stable Value Fund, which is valued at contract value. Fair value is determined as more fully described in note 2(d). The market values for variable annuity contracts represent the Plan's pro-rata interest in the net assets of each investment and are based on the fair value of the underlying assets.

These investments are not publicly traded on national security market exchanges and may be valued differently than if readily available markets existed for such investments. Management is responsible for the fair value measurement of investments reported in the financial statements and believes that the reported values are reasonable.

Investment return consists of the Plan's distributive share of any interest, dividends, capital gains and losses, generated from investments, as well as the change in fair value of the investments. Gains and losses attributable to investments are realized and reported upon a sales or disposition of the investments. Unrealized gains and losses are included in the change in net assets available for benefits.

**(d) Fair Value Measurements**

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. US GAAP establishes a fair value hierarchy that prioritizes investments based on the assumptions market participants would use when pricing an asset. The fair value hierarchy gives the highest priority to quoted prices in active markets (observable inputs) and the lowest priority to an entity's assumptions (unobservable inputs). The Plan groups assets at fair value in three levels based on the markets in which the assets and liabilities are traded, and the reliability of the assumptions used to determine fair value. In addition, the Plan reports certain investments using the "practical expedient" method. The practical expedient allows net asset value per share or its equivalent to represent fair value for reporting purposes when the criteria for using this method are met. Investments valued using net asset value per share or its equivalent are not categorized within the hierarchy.

These levels are:

- Level 1     Unadjusted quoted market prices for identical assets or liabilities in active markets as of the measurement date.
- Level 2     Other observable inputs, either directly or indirectly, including:
  - Quoted prices for similar assets/liabilities in active markets;
  - Quoted prices for identical or similar assets in non-active markets;
  - Inputs other than quoted prices that are observable for the asset/liability; and,
  - Inputs that are derived principally from or corroborated by other observable market data.
- Level 3     Unobservable inputs that cannot be corroborated by observable market data.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, an investment's level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. These classifications (Level 1, 2 and 3) are intended to reflect the observability of inputs used in the valuation of investments and are not necessarily an indication of risk or liquidity.

Market price is affected by a number of factors, including the type of instrument and the characteristics specific to the instrument, as well as the effects of market, interest and credit risk. Instruments with readily available active quoted prices or for which fair value can be measured from actively quoted prices generally will have a higher degree of market price observability and a lesser degree of judgment used in measuring fair value. It is reasonably possible that change in values of these instruments will occur in the near term and that such changes could materially affect amounts reported in the Plan's financial statements.

**(e) Participant Accounting Records**

The Plan's custodian, OneAmerica, maintains individual participants' accounting records. Contributions and income are allocated by the custodian to the participants' accounts on a daily basis, and statements are prepared and sent to all participants quarterly.

**(f) Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are placed on nonaccrual status at the time a participant terminates employment and makes no further payments on the loan. A participant loan is considered delinquent when payments are ninety days past due, at which time the entire balance of principal and interest is due. A terminated employee is required to pay the entire balance of principal and interest within sixty days of termination. If unpaid, these participant loans for terminated participants are reclassified as distributions based upon terms of the Plan document.

At December 31, 2024 and 2023, all notes receivables from participants were current.

**(g) Payment of Benefits**

Benefits are recorded when paid.

**(h) Subsequent Events**

Management has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued.

**(3) Plan Termination**

Although it has not expressed any intent to do so, the Museum has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**(4) Tax Status**

The Plan has been informed by its contract administrator that the 403(b) plan is designed in accordance with applicable sections of the Internal Revenue Code. The Plan has been amended since its adoption. The Museum is of the opinion that the Plan is currently being operated as and fulfills the applicable requirements of a qualified plan.

Generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements and determined there are none. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan files the Form 5500, and generally the three previous tax years remain subject to examination.

**(5) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **(6) Guaranteed Investment Contract**

The Plan invests in the AUL Stable Value Fund which is a fully benefit-responsive guaranteed investment contract with American United Life Insurance Company (AUL) totaling \$79,193 and \$150,038 at December 31, 2024 and 2023, respectively. AUL maintains the contributions in a general account. The account is credited with earnings on underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed interest contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on an annual basis for resetting but may not be less than zero percent. The guaranteed investment contract permits AUL to terminate the agreement if a minimum balance, \$400, and minimum activity, contributions at least every six months, is not maintained.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement with the consent of the issuer.

Annuity contracts are invested in underlying funds that primarily consist of equity securities, fixed-income instruments and other mutual funds and short-term instruments. Investments are valued daily and can be redeemed with a one day notice period.

**(8) Related Party Transactions**

Investment products and plan administrative services are provided by OneAmerica. OneAmerica is the third-party administrator and provides administrative services as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions.

**(9) Financial Data Certified by the Plan Trustee**

The Plan administrator has elected the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan trustees have certified all financial data from which the Plan investment balances and activities reported on the statement of net assets available for benefits, the statement of changes in net assets available for benefits, and the supplemental schedule of assets held for investment purposes have been prepared.
