Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of RO-SAL Plumbing & Heating, Inc. Incentive Savings Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C). Notes to Financial Statements Year Ended December 31, 2024

1. Description of Plan The following summary description of the RO-SAL Plumbing & Heating, Inc. (the "Company") Incentive Savings Trust (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General The Plan is a defined contribution plan covering all employees of the Company, except members of a collective bargaining agreement, nonresident aliens, and leased employees, who have completed one year of service and 1,000 hours, as defined. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Contributions Participants may contribute any specific percentage of their compensation, as defined, each plan year through payroll deductions, subject to limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). There are two types of elective deferrals available to participants: pre-tax deferral and Roth deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. All participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan has an automatic enrollment program for new eligible participants. Eligible participants automatically make pre-tax contributions in the amount of 1% of earnings. Eligible participants may opt-out of the automatic enrollment program at any time, as well as make changes to or maintain the level of contributions.

Employer Contributions The Plan has a mandatory "Safe Harbor 401(k)" contribution. Pursuant to the Plan's provisions, when an eligible participant makes a deferral, the participant will be eligible to receive a Safe Harbor matching contribution equal to 100% of the amount contributed to the Plan for the Plan year up to the first 3% of Plan compensation plus 50% of the amount contributed between 3% and 5% of Plan compensation.

The Company may make discretionary contributions called a Qualified Matching Contribution ("QMAC"). Eligible participants, who are non-highly compensated employees, as defined, will be 100% vested at the time of the QMAC contribution. The QMAC will be allocated uniformly to all eligible participants. To receive an allocation of QMACs, a participant must satisfy the service conditions, as defined. However, a participant does not have to be employed at the end of the year or work a specific number of hours of service to receive an allocation of QMACs under the Plan.

Employer Contributions (continued)

In addition to any other contributions authorized under the Plan, the Company may decide to make a special discretionary contribution called a Qualified Nonelective Employer Contribution ("QNEC"). All participants receiving a QNEC contribution, will automatically be 100% vested in the QNEC contribution. QNEC will only be made to eligible participants who are non-highly compensated employees, as defined. Any QNEC contributed to the Plan will be allocated as a uniform percentage of Plan compensation, as defined, or as a uniform dollar amount. The Company may make QNECs first to eligible employees with the lowest Plan compensation. To receive an allocation of QNECs, a participant must satisfy the minimum age and services criteria, as defined. However, a participant does not have to be employed at the end of the year or work a specific number of hours of service to receive an allocation of QNECs under the Plan.

The Plan also allows for discretionary profit-sharing contributions. To be eligible for profit-sharing contributions, generally, employees are required to complete 1,000 hours during the Plan year, as defined, and must be employed with the Company on the last day of the Plan year.

The Plan did not make QMAC or QNEC contributions during the year ended December 31, 2024. The Company's Safe Harbor Match and profit-sharing contributions aggregated \$690,730 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited to reflect contributions, withdrawals, distributions, investment fund transfers and reallocations, income earned or accrued, expenses paid from the assets of the Plan and any increase or decrease in the fair market value of the assets of the Plan. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions, plus actual earnings thereon and certain special contributions including Safe Harbor contributions, QMACs, and QNECs. Vesting in profit-sharing contributions increases 20% per year after the second year of vesting service, as defined in the Plan. Participants are 100% vested in all their accounts upon the latter of normal retirement age (age 65) or once they have completed six years of vesting service, as defined, or upon death or disability.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans must be repaid in level payments on a monthly basis up to a five-year period unless it is for the purchase of a principal residence, in which case repayment can be made over as many as 10 years. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1% as determined by the Company. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the plan document.

Forfeitures

The portion of a participant's account balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. The Plan provides for terminated employees who resume employment within five consecutive breaks, as defined, to have any forfeited amounts reinstated ("reinstatement period"), if the employee repays the full amount of the distribution attributable to vested employer contributions prior to the end of the reinstatement period. Plan participants' forfeitures may be used to pay Plan expenses or to reduce the Company's employer matching and non-elective contributions for the Plan year. There were no forfeitures applied during the year ended December 31, 2024 to reduce employer contributions. At December 31, 2024 amounts in the forfeiture account totaled approximately \$37,000.

Payment of Benefits

A participant's vested interest in his or her account balance is distributable generally upon termination, disability, retirement or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the Plan.

Under certain conditions, a contributing participant could make withdrawals from the vested portion of his or her account balance prior to termination of employment by filing a withdrawal form. Two types of withdrawals are available to participants - regular and hardship. Generally, regular withdrawals are available to participants over the age of 59 ½. Hardship withdrawals to participants are allowed upon meeting certain requirements as described in the Plan.

2. Significant Accounting Policies

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an investment or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further information regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains (losses) on investments bought or sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits	Benefits are recorded when paid.
Estimates	The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
Plan Expenses	Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses, including custodian fees and auditing fees, may be paid directly by the Company. If the Company does not pay Plan-related expenses, such fees or expenses will generally be allocated to the accounts of participants either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the Plan. Fees related to the administration of notes receivable from participants and other transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in "Net appreciation (depreciation) in fair value of investments."

3. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual Funds: Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash equivalents: Valued at cost plus accrued interest, which approximates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

6. Income Tax Status

On June 30, 2020 the Internal Revenue Service stated that the prototype plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code ("IRC"). The Plan has not received a determination letter specific to the Plan itself; however, the plan administrator believes that the Plan, which has been amended since receiving the determination letter, was designed and is being operated in compliance with the applicable requirements of the IRC. The Plan has been amended effective January 1, 2023, for changes required by the Coronavirus Aid, Relief and Economic Security Act and other changes in accordance with applicable law and Internal Revenue Service guidance. Further, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of and for the year ended December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**7. Risks and
Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

**8. Party-in-Interest
Transactions**

Fees and expenses such as plan administration fees may be deducted directly from investment returns in accordance with applicable investment options selected by the participant. In addition, providers of other administrative fees (i.e., administration, legal, and accounting) paid by the employer are considered a party-in-interest as defined by ERISA.

9. Subsequent Events

The Company has evaluated events and transactions that occurred between December 31, 2024 and September 17, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.
