(1) Description of the Plan

The following description of the Arrowstreet Capital, L.P. 401(k) Plan (the Plan) provides only general information. Participants of the Plan should refer to the plan document for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution retirement and savings plan under Section 401(k) of the Internal Revenue Code (IRC), sponsored by Arrowstreet Capital, L.P. (the Company, Employer, Plan Sponsor, and Plan Administrator). Employees of the Company are eligible to participate in the Plan upon employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

(b) Participant Accounts

Each participant account is credited with the participant's contributions and the Company's matching contributions and allocations of plan earnings and is charged with an allocation of administrative credits or expenses, as applicable. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative credits or expenses are based in accordance with plan documents. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(c) Contributions

(i) Employer Contribution

The total amount of employer contribution (Employer Contribution) is determined annually by the Company and is subject to certain limitations on the amount that can be contributed on behalf of any single participant under the IRC. The Company's safe harbor contributions are calculated as 3% of net earnings subject to a limit of \$10,350 and \$9,900 per employee in 2024 and 2023, respectively. The Company may also match the participant's contribution up to 4% of the participant's net earnings, subject to a limit of \$13,800 and \$13,200 per plan participant in 2024 and 2023, respectively.

(ii) Participant Contributions

Participants may voluntarily make contributions (Employee Contributions) subject to certain limitations. Participants could contribute up to 80% of their eligible pre-tax and/or after-tax compensation to the Plan but could not exceed the annual dollar limit allowed by the IRC of \$23,000 in 2024 and \$22,500 in 2023. Participant contributions are made through pre-tax and/or Roth after-tax 401(k) salary reduction contributions. Participants who attained at least fifty years of age during the year could make additional contributions from their eligible pre-tax and/or after-tax compensation (catch-up contributions) of up to \$7,500 in 2024 and 2023.

(d) Investment Alternatives

Each participant is responsible for determining how his or her individual account balance is invested, from a listing of permissible investment options.

(e) Vesting

All Employee Contributions and earnings thereon are fully vested at all times. A participant is fully vested immediately in Employer Contributions and earnings thereon.

(f) Benefits

Benefits are payable to each participant or each participant's beneficiary upon the participant's death, disability, retirement, attainment of age 59½ or termination of employment. In certain circumstances, participants may also make discretionary or hardship withdrawals.

(g) Loans to Participants

Participants actively employed by the Company may borrow from their fund account a minimum of \$1,000 up to 50% of their vested retirement account balance up to a maximum of \$50,000 minus their highest outstanding balance in the past 12 months (if any). The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at one percent above the prime rate, as defined. Principal and interest is paid ratably through bi-weekly or monthly payroll deductions over not more than five years. If a participant terminates employment with the Company, they must pay the balance in full. If the loan is not repaid, it will automatically be treated as a distribution to the participant after three months.

(h) Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

(2) Summary of Significant Accounting Policies

The following is a summary of significant accounting policies.

(a) Basis of Accounting

The Plan's financial statements have been prepared on the accrual basis of accounting in accordance with generally accepted accounting principles.

Administrative expenses of \$10,000 in the prior year's financial statement has been reclassified to conform to the current year's financial statement presentation. This reclassification had no effect on the reported statement of changes in net assets available for benefits.

(b) Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

If available, a readily determinable fair value is used to value investments, including valuation for Mutual and Collective Investment Trust (CIT) funds. Quoted market prices and net asset values (NAV) are used.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation (depreciation) in fair value of investments includes gains and losses on investments bought and sold as well as held during the year.

(c) Payment of Benefits

Benefits are recorded when paid.

(d) Loans Receivable from Participants

Loans receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on loans receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

(e) Expenses

Certain administrative expenses such as auditing and legal fees are paid directly by the Company and, accordingly, are not reflected in the accompanying financial statements. However, other administrative costs, such as check charges for participant distributions are paid for by the participants. Participant-paid expenses are deducted directly from their account balance and, therefore, are reflected in the accompanying financial statements.

(f) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(3) Investments

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held and loans receivable from participants at December 31, 2024 and 2023, and net realized and unrealized appreciation in fair value of investments, interest and dividend income, and interest income on loans receivable from participants for the years then ended, was obtained or derived from information provided to the Plan Administrator and certified as complete and accurate by Fidelity Management Trust Company, the Trustee of the Plan.

(4) Fair Value Measurements

ASC Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

As of December 31, 2024 and 2023, the Plan assets consisted solely of Mutual and CIT fund investments. Mutual funds are valued at the quoted NAV of shares held by the Plan at year-end (a Level 1 measurement). CIT funds are deemed to have a readily determinable fair value in an active market (a Level 1 measurement).

(5) Tax Status

The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. The Plan Administrator has determined that it is eligible to and has chosen to rely on the current IRS pre-approved plan opinion letter. Once qualified, the Plan is required to operate in conformity with the Internal Revenue Code to maintain its qualified status. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Related Party and Party-in-Interest Transactions

The Plan's record keeper and Trustee are Fidelity Investments Institutional Operations Company, Inc. (FIIOC) and Fidelity Management Trust Company (FMTC), respectively. Both FIIOC and FMTC are related parties to the Plan. In addition, investment transactions with Fidelity and certain administrative expenses paid directly by the Company (note 2(d) and 2(e)) qualify as party-in-interest transactions.

Payment of a management fee to the Company with respect to the interests held by the Plan would be a prohibited transaction under ERISA; however, the Company does not receive a management fee with respect to shares of any Company managed-CIT that are held by the Plan.

(7) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(8) Subsequent Events

Plan management has evaluated the need for disclosure and/or adjustments resulting from subsequent events through September 12, 2025, which represents the date the financial statements were available to be issued.
