### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed an audit of the financial statements of SS White Burs, Inc. Salary Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)" audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 (liquidation basis), and the related statement of changes in net assets available for benefits in liquidation for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of SS White Burs, Inc. Salary Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of SS White Burs, Inc. Salary Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Plan Termination and Liquidation Basis of Accounting***

As described in Note 1 to the financial statements, the governing body of SS White Burs, Inc. Salary Savings Plan approved a plan of liquidation to terminate the Plan effective September 30, 2024 and management determined liquidation became imminent. Accordingly, the Plan has changed its basis of accounting from the ongoing basis used in presenting the Plan's 2023 financial statements to the liquidation basis used in presenting the Plan's 2024 financial statements. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about SS White Burs, Inc. Salary Savings Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- exercise professional judgment and maintain professional skepticism throughout the audit.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 23, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the DOL Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

### 1. Description of Plan

The following description of the SS White Burs, Inc. Salary Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan established effective August 1, 1986, as restated October 30, 2022. In October 2024, the governing body of SS White Burs, Inc. Salary Savings Plan approved a plan of liquidation to terminate the plan effective September 30, 2024 and amended the Plan to adopt the provisions of the Secure 2.0 Act of 2022. See Note 6.

The Plan covers all employees, excluding union, non-resident aliens, and residents of Puerto Rico, of SS White Burs, Inc. (the Company) who have completed six months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Trustee is responsible for oversight of the Plan. The Plan's Trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Contributions*

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes safe harbor matching contributions of 100% of the participants' elective deferrals up to the first 3% of compensation plus 50% up to the next 2% of compensation deferred, not to exceed the maximum amount allowable as a deduction imposed by specific IRC sections. Additional profit sharing amounts may be contributed at the option of the Plan Administrator. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan. Additional discretionary amounts may be contributed by the Company at the option of the Employer. For the year ended December 31, 2024, there were no discretionary contributions to the Plan.

#### *Participant Accounts*

Each participant's account was credited with the participant's contributions, Company safe harbor matching contributions, allocations of the Company's discretionary contributions, an allocation of the Plan's earnings and debited with distributions. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled was the benefit that was provided from the participant's vested account.

#### *Vesting*

Participants were vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts was based on years of continuous service. A participant was 20 percent vested after two years of credited service and continued to vest in increments of 20 percent until 100 percent vested after six years of credited service.

#### *Notes Receivable from Participants*

Participants were permitted to borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined monthly, was set at one percent above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

#### *Payment of Benefits*

On termination of service due to death, disability, or retirement, a participant was allowed to elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant was allowed to receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance was less than or equal to \$7,000, the amount may have been automatically distributed in the form of lump sum cash payment or IRA, depending on the balance. In addition, the Plan allowed for hardship distributions if certain criteria were met.

#### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$11,258, respectively. These accounts were used to reduce 2024 employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$15,042 and \$17 was allocated to participant accounts from forfeited nonvested accounts, in accordance with plan provisions.

### 2. Summary of Accounting Policies

#### *Basis of Accounting*

As further discussed in Note 1 to the financial statements, the Company elected to terminate the Plan effective September 30, 2024. In accordance with U.S. generally accepted accounting principles (GAAP), the Plan had changed its basis of accounting from the ongoing basis used in presenting the financial statements as of December 31, 2023, to the liquidation basis used in presenting the financial statements as of and for the year ended December 31, 2024. This basis of accounting is considered appropriate when, among other things, liquidation of an entity is probable and the net realizable value of assets are reasonably determinable. Under the liquidation basis of accounting, assets are stated at their estimated net realized cash value and liabilities are stated at their anticipated settlement amounts. All assets of the Plan were liquidated and distributed as of December 31, 2024.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determined the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Contributions*

Contributions from Plan participants and the matching contributions from the Employer were recorded in the year in which the employee contributions were withheld from compensation. Contributions were subject to certain Internal Revenue Service (IRS) limitations.

#### *Notes Receivable from Participants*

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed as incurred.

#### *Payment of Benefits*

Benefits were recorded when paid.

#### *Expenses*

Certain expenses of maintaining the Plan were paid by the Plan, unless otherwise paid by the Company. Expenses that were paid by the Company were excluded from these financial statements. Fees related to the administration of notes receivable from participants were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

#### *Subsequent Events*

Subsequent events were evaluated through September 22, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

**Level 1** - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability had a specified (contractual) term, the Level 2 input must have been observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation technique were unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy was based on the lowest level of any input that was significant to the fair value measurement. Valuation techniques maximized the use of relevant observable inputs and minimized the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There were no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments measured at net asset value:* Consisting of pooled separate accounts, valued at the net asset value (NAV) of units of a pooled separate account. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan had no investments reported on NAV at December 31, 2024. The following presents investment strategies relative to Plan investments reported on NAV at December 31, 2023:

1. Asset allocation funds: Invested in a variety of combinations of equity and fixed income instruments. These funds seek to provide long-term investors with an asset allocation strategy designed to maximize assets for retirement consistent with the risk level and projected retirement date associated with each fund. The funds are designed to automatically adjust their risk over time in order to reduce the risk of investment in equity securities and shift from a focus on capital appreciation to one of capital preservation, while maintaining some exposure to capital appreciation asset classes. As of December 31, 2023, amounts invested in these investment funds were \$10,696,685.
2. International funds: Invested in a variety of combinations of equity and fixed income instruments. These funds seek broad exposure to emerging markets opportunities, principally by investing in emerging market companies as well as multinational companies with material emerging markets exposure. As of December 31, 2023, amounts invested in these investment funds were \$247,084.
3. Specialty funds: Invested primarily in equity securities. These funds aim to take advantage of unique market movements or profit from growth in specific industries and offer a more concentrated investment approach. These funds concentrate on sectors such as technology, real estate, healthcare or specific regions. As of December 31, 2023, amounts invested in these investment funds were \$40,339.
4. Small-Cap, Mid-Cap, and Large-Cap funds: Invested primarily in equity instruments. Small-caps provide significant growth potential, as they are often in an early growth stage. Mid-caps also offer growth opportunities with less risk than small-caps. Large-caps generally provide steady, though typically more modest, returns, and are often favored for their dividend payments. As of December 31, 2023, amounts invested in these investment funds were \$984,696.
5. Bond funds: Invested primarily in equity and debt securities, with a focus on preservation of principal. These funds primarily seek current income rather than capital appreciation. As of December 31, 2023, amounts invested in these investment funds were \$596,795.
6. Balanced funds: Invested primarily in equity and debt securities, with a focus on dividend-paying stocks and fixed income to allow for low volatility and attractive downside resilience. As of December 31, 2023, amounts invested in these investment funds were \$2,430.
7. Money Market: Invested in primarily debt securities with short maturities and minimal credit risk. As of December 31, 2023, amounts invested in these investment funds and \$3,222,564.
8. Fixed: investment is a capital preservation solution offered that includes guaranteed separate account group annuities or funding agreements, that provide a fixed rate of return. As of December 31, 2023, amounts invested in these investment funds were \$181,720.

#### 4. Information Certified by Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. #### 5. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the Custodian, and therefore, these transactions qualify as party in interest transactions.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

#### 6. Plan Termination

On October 3, 2024, the Company elected to terminate the Plan effective September 30, 2024. At that time, participants became 100% vested in their accounts, the Plan ceased employee contributions into the Plan and ceased new participants from entering the Plan. The Plan was frozen as per the Plan document effective September 30, 2024. Plan assets were fully liquidated and distributed in December 2024.

#### 7. Tax Status

The Plan adopted a pre-approved plan offered by Empower Retirement LLC. The pre-approved plan received an IRS Opinion Letter dated November 14, 2022, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently

being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 8. Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it was at least reasonably possible that changes in the values of investment securities could occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
