Notes to Financial Statements December 31, 2024 and 2023

Note 1: Description of Plan

The following description of the RW Specialties Employee Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document, which provides a more complete description of the Plan's provisions.

General

Effective January 1, 1988, and restated January 1, 2021, RWS Operating Co. LLC (the Plan Sponsor or the Company) established the Plan as a defined contribution plan covering substantially all employees except employees covered by a collective bargaining agreement. Employees must have completed two months of service and have reached age 18 to be eligible to participate in the Plan except for employer matching and nonelective contributions which require one year of service. Eligible employees are permitted to enter the Plan beginning on the first day of the quarter following or coinciding with the date each employee satisfies the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. An officer of the Company serves as Trustee of the Plan.

Standard Insurance Company (Standard or the Custodian) serves as the Custodian of the Plan. Standard receives all contributions made under the Plan, holds plan assets, pays benefits as directed by the Plan Administrator and assists in the administration of the Plan. Standard serves as the intermediary for all asset purchases and redemptions. Additionally, Standard manages certain investment options of the Plan (see Note 7).

Contributions

The Plan includes a provision under Internal Revenue Code (IRC) Section 401(k) whereby participants may deposit pretax and Roth contributions totaling a maximum of 100% of compensation, as defined, subject to the statutory limit set by the Internal Revenue Code (IRC). The limit for 2024 was \$23,000. Participants who have attained at least age 50 are eligible to defer additional amounts (catch-up contributions). The maximum catch-up contribution in 2024 was \$7,500. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). The Plan includes an auto-enrollment provision, whereby all employees hired after January 1, 2021, will be automatically enrolled in the Plan at a deferral rate set at 3% of eligible compensation, with no escalation provision.

The Plan Sponsor will make matching and nonelective contributions using participants' elective deferrals up to 6% of compensation for a maximum match of 4% of compensation. There were no matching or nonelective contributions during 2024. The Plan Sponsor will also make safe harbor matching contributions equal to 3% of compensation plus 50% of the amount of the participant's elective deferrals that exceed 3% but do not exceed 5% of the Participant's compensation, as defined. The Plan Sponsor made safe harbor contributions totaling \$196,040 for the year ended December 31, 2024.

Participant Accounts

Each participant account is credited with the participant's pretax, Roth, and rollover contributions and the participant's portion of the Plan Sponsor's safe harbor, matching and nonelective contributions and actual plan earnings or losses thereon. The participant's account is also charged with withdrawals, applicable allocations of investment gains/losses and administrative expenses. Allocations are based on the participant's Plan compensation, account balances or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Vesting

Participants are immediately 100% vested in their pretax and Roth contributions, rollover balances, safe harbor contributions and investment performance thereon. Participant vesting in the Plan Sponsor's discretionary matching and nonelective contributions, and income earned thereon is based on years of continuous service. All participants become 100% vested after six years of service. The vesting percentages are as follows:

Participants also become 100% vested upon termination of the Plan, or upon total and permanent disability or death while still an employee of the Plan Sponsor.

Investment Options

Participants are required to make participant-directed allocations of their accounts in increments totaling 100% among various investment options selected by the Plan Administrator, including certain options for which Standard or its affiliates serve as investment advisors (Note 7). Participants can make changes to their investment options daily.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess, if any, of the highest outstanding balance of any notes issued during the preceding twelve-month period, or 50% of their vested account balance. Participants are limited to two outstanding notes at a time. The notes are secured by the balance in the participant's vested account balance and bear interest at rates that range from 9.00% to 9.50% as of December 31, 2024, which are equal to the Prime interest rate plus one percent. Principal and interest are paid ratably through semi-monthly payroll deductions over a period not to exceed five years, except for a note used to finance the purchase of a participant's principal residence.

Forfeitures

Non-vested account balances of terminated employees are forfeited upon the earlier of complete distribution of the vested portion of their account or the last day of the Plan year in which the former participants incurred five consecutive breaks in service, as defined in the Plan Agreement. Forfeitures of terminated employees' non-vested accounts are used to reduce Plan Sponsor contributions and administrative expenses of the Plan. Forfeitures used to reduce Plan Sponsor contributions and administrative expenses were nominal for the year ended December 31, 2024 and 2023.

Payment of Benefits

The Plan provides for benefit distributions to participants or beneficiaries of their vested account balance upon termination of employment, retirement, reaching age 59 ½, disability, or death in the form of a lump sum or partial withdrawal. The value of the vested balance will be automatically distributed as soon as administratively feasible following the cause for distribution. When employment is terminated, the benefit will automatically be distributed to the participant in a lump sum payment as soon as administratively feasible following their termination of employment. Any vested account balances greater than \$5,000 require consent from the participant or beneficiaries as to the method of distribution. However, the participant may elect whether to receive the distribution or to roll over the distribution to another retirement plan such as an individual retirement account (IRA). If the participant does not elect either to receive or to roll over the distribution, the Plan will distribute the participant's account without their consent if the account balance is \$5,000 or less, as defined in the Plan Document.

In general, a participant may withdraw up to 100% of employee cumulative pretax contributions in the event of a participant's heavy and immediate financial hardship, as defined in the Plan Document. Hardship distributions may not exceed the amount of the participant's financial hardship and may not be repaid by the participant.

Distributions from the Plan will normally be subject to income taxes and in certain circumstances may also be subject to Internal Revenue Service (IRS) penalties unless transferred to another qualified Plan or individual retirement account.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the Standard Stable Value Asset Fund that is a fully benefit-responsive investment contract, which is reported at contract value, see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities, including gains and losses, are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded when earned. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participants to be in default, the participants loan balance is reduced and a benefit payment is recorded.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate risk, market risk and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid by the Plan.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Plan Sponsor, as defined in the Plan Document. These expenses include, but are not limited to, legal, accounting and recordkeeping fees, and investment expenses. However, individual transaction fees for withdrawals or notes receivable from participants are paid from the participant's account. For administrative expenses not paid by the Company, a proportionate share of fees and expenses paid by the Plan is charged to each participant's account.

Note 3: Information Certified by Custodian (Unaudited)

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 (c) of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Standard, except for comparing such information certified by Standard to information included in the Plan's financial statements:

Note 4: Fair Value Measurements

The accounting standard for fair value measurement provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in non-active markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Investments in the pooled separate accounts are composed primarily of investments in mutual funds and are valued by the Custodian at the net asset value (NAV) of the shares held by the Plan at the end of the Plan year. NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the investment will sell for an amount different from the reported NAV. Participant-directed transactions (purchases and sales) may occur daily. There are currently no unfunded commitments on these investments. The fair value of pooled separate accounts totaled \$6,767,391 and \$8,305,795 as of December 31, 2024 and 2023, respectively, and are reported as investments at fair value on the statements of net assets available for benefits.

Net appreciation/depreciation in the fair value of investments represents the change in fair value during the year, including realized and unrealized gains and losses.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Fully Benefit-Responsive Investment Contract

The Plan has entered into a traditional investment contract through a group annuity contract with the Custodian. The traditional investment contract held by the Plan is a guaranteed investment contract which meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus interest, less participant withdrawals and administrative expenses. The Custodian maintains the contributions in a general account secured by the general assets of the Custodian. Guaranteed interest rates and maturity dates are revised quarterly by the Custodian subject to contractual limitation in the contract. Certain events such as plan termination or a plan merger initiated by the Plan Sponsor may limit the ability of the Plan to transact at contract value. The Plan Sponsor does not believe that any events that may limit the ability of the Plan to transact at contract value are probable of occurring. The contract value of guaranteed investment contracts totaled \$747,783 and \$873,061 as of December 31, 2024 and 2023 respectively, and is reported as investment at contract value on the accompanying statement of net assets available for benefits.

Note 6: Income Tax Status

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Trustee believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Note 7: Party-in-Interest Transactions

Standard, the Custodian of the Plan, performs services for, sells products to, and manages certain investment options for which fees are charged to the Plan. These transactions qualify as party-in-interest transactions. Fees paid by the Plan for these services amounted to \$26,097 for the year ended December 31, 2024, which are included in administrative expenses. In addition, notes receivable from participants also qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 9: Reconciliation of Financial Statements to Form 5500

The financial information of the Plan, as reported on Form 5500, does not include all amounts necessary for reporting on the accrual basis of accounting. A reconciliation of the amounts appearing on Form 5500 to the accompanying financial statements is as follows:

Note 10: Prohibited Transactions

During 2024 and 2023, the Plan Sponsor deducted, via payroll withholding, an aggregate of \$19,645 and \$87,693 from participants’ gross wages that were not remitted in a timely manner to the Plan in accordance with DOL regulations. The Plan Sponsor made restorative contributions to the Plan for all of the 2023 late remittances and \$15,940 of the \$19,645 2024 late remittances in 2024. The Plan Sponsor intends to make the restorative contributions to the Plan during 2025 for the remaining \$3,705 of late remittances from 2024.

Note 11: Subsequent Events

The Plan Sponsor has evaluated for subsequent events between the statement of net assets available for benefits date of December 31, 2024 and the report date, the date these financial statements were available for issuance, and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
