### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Gooding Group LLC, 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gooding Group, LLC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

NOTE 1: DESCRIPTION OF PLAN

The following description of the Gooding Group, LLC 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with a 401(k) provision. Effective June 1, 2017, the Plan was amended and restated in its entirety by adopting a Prototype Defined Contribution Plan sponsored by Fulton Bank, N.A. The Plan was adopted by Gooding Group, LLC (the sponsor employer), Gooding, Simpson & Mackes, Inc. (participating employer), and G/S/M Industrial, Inc. (participating employer), herein referred to as "the Companies." The Plan covers substantially all employees of the Companies who have attained age 18 and have completed two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan includes an Employer Non-elective Contribution (NEC). Participants must be employed on the last day of the year and have worked at least 1,000 hours to receive the NEC. Vesting for the NEC is on a 6-year graded schedule. Each participating employer will determine the amount of the NEC, and it will be allocated to their participants only. Eligibility for the NEC shall be the same as for elective deferrals.

Contributions

Each year participants may contribute up to 100% of their annual pre-tax compensation, as defined in the Plan; however, the participant's contribution cannot exceed amounts allowable under applicable federal regulations. Participants may also contribute Roth 401(k) salary deferrals. In addition, participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other defined benefit or contribution plans (rollover). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at 6% of eligible compensation unless they affirmatively elect otherwise. For the 2024 and 2023 Plan years, the Companies contributed matching contributions of 50% of the first 6% of base compensation that a participant contributed to the Plan. Contributions are subject to certain IRS limitations. Participants direct the investment of all contributions into various investment options offered by the Plan. For the years ended December 31, 2024 and 2023, the Plan offered 25 mutual funds, and one collective investment trust as investment options.

Participant Accounts

Each participant's account is credited with the participant's contributions, Companies' matching contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participants' accounts and bear interest rates between 3.24% and 8.74% at December 31, 2024 and December 31, 2023, which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's account balance, or periodic installments over a fixed period of time. In-service withdrawals are available to participants who have attained age 59 1/2 or have reached the Plan's normal retirement age. A participant may request a hardship withdrawal of all or part of the eligible balance in his or her account.

Vesting

Participants are immediately vested in their contributions and the Companies' matching contributions plus actual earnings thereon upon meeting eligibility requirements.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$713 and \$2,008 respectively. These accounts can be used to reduce future employer contributions or pay down administrative expenses. During the year ended December 31, 2024, \$2,008 of forfeitures were used to pay down administrative expenses.

NOTE 2: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator and 401(k) Plan Committee determine the Plan's valuation policies utilizing information provided by investment advisers and the Plan's custodian and trustee. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payments of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses

The Plan pays all administrative costs of maintaining the Plan, which are recorded as administrative expenses in the statement of changes in net assets available for benefits. Investment related expenses are charged directly to the participants' accounts.

NOTE 3: FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. The mutual funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust

Valued at net asset value, which is not publicly quoted, but is available to current Plan participants on their online accounts. The investments can be redeemed at the option of the investor of the funds. There are no circumstances noted in which redeemable investments might not be redeemed.

NOTE 4: INCOME TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated September 21, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5: PLAN TERMINATION

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will be 100% vested in their accounts.

NOTE 6: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 7: RELATED-PARTY TRANSACTIONS

Fulton Financial Advisors ("FFA") provides investment advisory and record-keeping services to the Plan. Administrative fees paid to FFA by the Plan net of fee rebates totaled \$96,939 for the year ended December 31, 2024.

As previously discussed, the Plan may issue notes receivable to participants that are secured by participant account balances. Participant loans totaled \$397,437 and \$374,037 at December 31, 2024 and 2023, respectively. Interest income from participant loans was \$30,639 for the year ended December 31, 2024. All of these transactions qualify as party-in-interest transactions.

NOTE 8: INFORMATION CERTIFIED BY THE PLAN'S TRUSTEES

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, was obtained from information supplied to the Plan administrator and certified as complete and accurate by Matrix Trust Company. Matrix Trust Company, trustee, held the Plan's investment assets as of December 31, 2024 and 2023 and executed investment transactions for the year ended December 31, 2024.

NOTE 9: SUBSEQUENT EVENTS

Events that occurred subsequent to December 31, 2024, have been evaluated by the Plan through September 17, 2025, which is the date the financial statements were available to be issued.
