As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

**Note 1: Description of Plan**

The following description of The EADS Group Employees Profit Sharing Plan provides only general information. Participants should refer to the Plan Agreement for a complete description on the Plan's provision.

**1. General**

The Plan is a defined contribution plan and 401(k) plan covering all eligible employees of the Company who have 90 days of service and are eighteen years of age or older. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

**2. Contributions**

**a. Employer**

The employer shall determine, in its sole discretion, the amount of employer contribution to be made to this plan from its current or accumulated net profits. "Net profits" means current and accumulated earnings of the employer before federal and state taxes and before contributions to this and any other qualified plan.

The amount of employer contribution shall not exceed the maximum amount deductible for tax purposes under Code Section 404(a). Such employer contribution shall also be limited by the maximum amounts, which may be allocated to participants as provided under Code Section 415.

**b. Employees**

The contribution of the Company shall be determined by the resolution of the board. Each year, participants may contribute up to 60% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

**3. Participant Accounts**

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) plan earnings, and (c) forfeitures of terminated participant's nonvested accounts. Allocations of the Company's contribution and forfeitures are based in the same proportion that each participant's compensation for such taxable year bears to the total compensation of all participants for such year. Plan earnings shall be allocated pro rata according to the net credit balances in the participant's accounts.

**4. Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of service as shown in the schedule below.

**5. Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25% to 9.50%, which commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions. Loans to participants are reported at their unpaid principal balance plus accrued interest.

**6. Payment of Benefits**

On termination of service due to employment, death, disability, retirement or other, a participant may elect to receive either a lump-sum amount equal to the value of his account, or periodic payments not to exceed the life expectancy of the participant.

The Plan allows for two types of in-service withdrawals: (1) Hardship withdrawals, if certain criteria outlined in the plan document is met. (2) Age requirement, if an active participant is age 50 or older, they are eligible to receive a distribution from employer matching and nonelective contributions. If an active participant is age 59 ½ they are eligible to receive a distribution from employee elective deferrals.

Vested accounts of terminated participants included in investment balances as of December 31, 2024 and 2023 were \$594,727 and \$190,708, respectively, as reported on IRS Form 8955-SSA.

**7. Forfeited Accounts**

At December 31, 2024 and 2023, forfeited accounts balances totaled \$34,169 and \$40,769, respectively. These accounts will be distributed to Plan participants. During 2024 and 2023, a total of \$40,769 and \$0, respectively, were allocated to participants.

**8. Investment Options**

The Plan is entirely participant-directed and, as such, upon enrollment in the Plan, a participant may direct employee and employer contributions in any investment option offered in the Plan. Participants may change their investment option at any time.

**9. Secure Act and Secure Act 2.0**

The Plan is currently working with their third party administrator to ensure compliance and any required plan changes are made to comply with the Secure Act and the Secure Act 2.0.

**Note 2: Summary of Accounting Policies**

**Date of Management's Review**

Subsequent events were evaluated through September 18, 2025, which is the date the financial statements were available to be issued.

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting**

The financial statements of the plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

**Investment Valuation and Income Recognition**

The investments are reported at fair value (except for fully benefit-responsive investment contracts). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation from investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

Investment contracts held by a defined contribution plan are required to be reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would

receive if they were to initiate permitted transactions under the terms of the plan. The Plan's investments include the Guaranteed Insurance Contract, which is a fully benefit-responsive investment contract. The trustee believes that within a retirement plan, contract value is an appropriate measurement for the reporting and financial statement purposes.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation from investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent loans are treated as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Reclassifications**

Certain prior year amounts have been reclassified for consistency with the current year presentation. These reclassifications had no effect on the Plan's reported activity.

**Note 3: Fair Value Measurement**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

The Plan follows the guidance for fair value measurements and disclosures in accordance with Accounting Standards Codification Topic 820, *Fair Value Measurements and Disclosures* ("ASC 820"). Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (i.e., the "exit price") in an orderly transaction between market participants at the measurement date.

In determining fair value, Management uses various valuation approaches, as appropriate in the circumstances. ASC 820 establishes a fair value hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the most observable inputs be used when available. Observable inputs are market data from independent sources. Unobservable inputs are Management's assumptions, based on the best information available, of how the market would price the asset or liability. The fair value hierarchy is categorized into three levels based on the inputs as follows:

**Level 1**

Valuations based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these securities does not entail a significant degree of judgment.

**Level 2**

Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, either directly or indirectly.

**Level 3**

Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The inputs into the determination of fair value require significant judgment and estimation.

Gains and losses in net assets available for benefits for years ending December 31, 2024 and 2023, are reported in net appreciation from investments.

The Plan's policy is to recognize transfer of investments into or out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For years ended December 31, 2024 and 2023, there were no transfers of investments into or out of Level 3.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been changes in the methodologies used or level designations as of December 31, 2024 and 2023.

(a) Common/Collective Trust Funds: Valued at the NAV of units of a collective trust. The NAV, as provided by the fund house or other investment provider, is used as a practical expedient to estimated fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust fund, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities' liquidations will be carried out in an orderly business manner.

**Note 4: Tax Status**

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated November 14, 2022, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan is a prototype standardized plan. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

**Note 5: Information Prepared and Certified by Custodian**

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower Retirement, LLC, the custodian of the Plan, has certified to the completeness and accuracy of all investments including notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023.

**Note 6: Related Party and Party-in-Interest Transactions**

Certain plan investments include shares of funds managed by the trustee and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the contract administrator services amounted to \$55,310 and \$45,841 for the years ended December 31, 2024 and 2023, respectively, and are included in "Administrative and Other Expenses" on the Statements of Changes in Net Assets Available for Benefits.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

**Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 8: Risks and Uncertainties**

The Plan provides for investment options in various mutual funds, a guaranteed insurance contract, and collective trust funds. Investment securities are exposed to various risks, such as interest rate risk, market risk, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits. The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across different mutual fund elections. Additionally, the investments within each participant-directed mutual fund election are further diversified into varied financial instruments.

**Note 10: Guaranteed Insurance Contract with Insurance Company**

On December 26, 2011, the Plan entered into a traditional benefit-responsive guaranteed insurance contract with Great-West Life & Annuity Insurance Company (Great-West). Empower Retirement, LLC is an indirect wholly-owned subsidiary of Great-West. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed insurance contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed insurance contract. The guaranteed insurance contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the insurance contract at December 31, 2024 and 2023 was \$1,272,142 and \$2,388,458, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Great-West. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring.

Great-West may terminate the contract with 90 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, plan disqualification, and failure to adopt the plan in a reasonable period of time. Upon termination by Great-West, a market value adjustment may apply.

The guaranteed insurance contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.
