## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Beacon Converters, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### Note 1 - Description of Plan:

The following description of the Beacon Converters, Inc. 401(k) Profit Sharing Plan (the "Plan") is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General** - The Plan is sponsored by Beacons Converter, Inc. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), covering all eligible Beacon employees of Beacon Converters Inc ("the Company" and "Plan Sponsor") except leased employees, independent contractors and temporary employees. An employee becomes eligible to participate in the Plan after completing six months of service. An eligible employee who has satisfied the eligibility requirements can become a participant in the Plan on the first day of each month. Employees who are eligible to participate in the Plan are automatically enrolled in the 401(k) portion of the Plan and will be deemed to have elected a pre-tax contribution of 3% of their eligible contribution, increasing 1% annually until reaching 5%.

**Plan Administrations** - The Plan is administered by the Plan Sponsor. The Plan's assets are held by Ascensus, LLC (the "Trustee"), who is responsible for the custody and management of the Plan's assets.

**Contributions** - Eligible participants may elect to contribute an amount equal to their deferral percentage or dollar amount of their compensation to the Plan on a pre-tax or after-tax basis, subject to the Internal Revenue Code (IRC) limitations for 401(k) plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions during that year.

**Employer Contributions** - An employee becomes eligible to participate in discretionary employer matching contributions after completing six months of service. The Company may make an employer discretionary matching contribution to the participants' accounts based on percentage of eligible participant salary deferrals made during the Plan year on a uniform basis. Total employer discretionary matching contributions made to the Plan for the year ended December 31, 2024 were \$194,977.

The Company may make a discretionary profit sharing contribution on behalf of eligible participants to the Plan. Pursuant to the plan document, participants must be employed on the last day of the Plan year and complete at least 1,000 hours of service during the Plan year to receive contributions. There were no discretionary non-elective profit sharing contributions made to the Plan for the year ended December 31, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocation of (a) the Company's contributions and (b) Plan earnings and or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various investment options offered by the Plan.

**Vesting** - Participants are vested immediately in their own contributions plus actual earnings thereon. Vesting in the employer discretionary matching and discretionary profit sharing contributions portions of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. In order to receive credit for a year of service an employee must work a minimum of 1,000 hours during the Plan year.

**Payment of Benefits** - On termination of services due to death, disability or normal retirement age, a participant receives an amount equal to the value of the participant's vested interest in their account in a lump-sum. The Plan has forced cash outs for balances of \$5,000 or below. For termination of service due to other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution. If death occurs prior to retirement, the participant's account is paid to the designated beneficiary. In-service withdrawals are permitted upon the participant attaining the age of 59 and a half.

**Forfeitures** - Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures will be used to reduce employer contributions and plan expenses under the Plan. Forfeited non-vested accounts totaled \$0 and \$314 for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$1,386 were utilized during 2024.

#### **Note 2 - Summary of Significant Accounting Policies:**

**Basis of Accounting** - The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions in net assets available for benefits during the reporting period. Actual results, as determined at a later date, could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, based upon the terms of the Plan Document, the participant loan balance is reduced and a benefit payment is recorded.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and general plan administration are charged directly to the participant's account and included in administrative expenses. Recordkeeping and investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits** - Benefits are recorded when paid.

**Hardship Withdrawals** - The Plan provides for hardship withdrawals from participants' vested balances, not to exceed an amount required to meet an immediate need created by hardship, and then only to the extent that such immediate need cannot be satisfied by other sources reasonably available to the participant. Permissible circumstances for hardship withdrawals include medical expenses, purchase of a home, tuition payments, amounts necessary to prevent eviction from the participants' personal residence, and such other circumstances as the Plan Administrator may determine in accordance with Internal Revenue Service ("IRS") rules and regulations.

**Subsequent Events** - The Plan Administrator has reviewed and evaluated all events and transactions from December 31, 2024 through July 24, 2025, the date the financial statements were available to be issued. The effects of those events and transactions that provide additional pertinent information about conditions that existed as of the date of the Statements of Net Assets Available for Benefits, have been recognized in the accompanying financial statements.

#### **Note 3 - Certified Investment Information:**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, the Trustee, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- a) Investments, as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.
- b) Investment income, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.
- c) Investment information included in the Schedule H, Part IV, Line 4i - Schedule of Assets (Held at End of Year), as of December 31, 2024, as shown on the ERISA-required supplemental schedule of assets (held at end of year).

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

#### **Note 4 - Fair Value Measurements:**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the closing price reported in the active market in which the fund is traded.
- *Collective investment trust* - Valued at the net asset value ("NAV") of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. The NAV is the basis for current transactions and can be redeemed at NAV as of the measurement date, which is computed daily. The Trustee reserves the right to delay transfers and payouts as described in the Declaration of Trustee issued to the Plan, in order to ensure that securities liquidations will be carried out in an orderly business manner. (See Note 6).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2, or 3.

**Note 5 - Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain fully vested in their own contributions and in any employer contributions. Under no circumstances may the Company take ownership of any of the Plan's assets as a result of Plan termination.

#### **Note 6 - Collective Investment Trust:**

The Plan invests in investment contracts through its collective investment trust ("CIT"). The CIT's fair values are relevant measurement attributes. The CIT held by the Plan is a stable value investment which has an objective to preserve capital and to provide a competitive level of income over time that is consistent with the preservation of capital. To achieve this objective the fund invest primarily in investment contracts. Redemptions are allowed for participants daily except for participant withdrawals which generally require one year written advance notice to the Trustee. There are no unfunded commitments at December 31, 2024 or 2023.

#### **Note 7 - Notes Receivable from Participants:**

Participants may obtain loans from the Plan at a minimum of \$1,000 and maximum of one-half of a participant's account balance, or \$50,000 whichever is less. Each loan bears a reasonable interest rate as determined by the Plan Administrator based on the prevailing interest rate charged by persons in the business of lending money or loans which would be made under similar circumstances and are collateralized by a participant's account balance. Loans are generally payable through payroll deductions within five years.

#### **Note 8 - Tax Status:**

The Plan was written on an IRS non-standardized pre-approved document, which obtained its latest opinion letter on June 30, 2020 in which the IRS stated that the Plan as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

#### **Note 9 - Risks and Uncertainties and Concentration of Investment Risk:**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the financial statements.

The Company is evaluating the potential impacts of the ongoing political uncertainties in the United States on its operations and financial position. These uncertainties could lead to changes in infrastructure spending, regulatory requirements, tax policies, industry-specific regulations, economic policies affecting market conditions, and trade policies impacting supply chains and costs. The Company cannot reasonably estimate the financial impact of these uncertainties and will continue to monitor developments and adjust its strategies as necessary to address any potential impact to the Company.

The Plan's investment in two funds comprises approximately 53% of total investments at December 31, 2024. The Plan's investment in three funds comprises approximately 62% of total investments at December 31, 2023.

**Note 10 - Party-in-Interest Transactions:**

Certain Plan investments are managed by the Trustee. The Trustee also provides administrative services to the Plan; therefore, these transactions qualify as party-in-interest. Fees paid to the Trustee by the Plan totaled \$47,412 for the year ended December 31, 2024.

**Note 11 - Prohibited Transactions:**

During 2024, the Company's remittances of certain employee contributions to the Plan's Trustee totaling \$7,743 were not remitted within the period prescribed by Department of Labor regulations. In 2024, the Company made additional contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays, totaling approximately \$67.
