Independent Auditor’s Report

To the Plan Administrator and Plan Participants
of the Arise Industrial Manufacturing 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Arise Industrial Manufacturing 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. 

1. Description of the Plan

General

The following description of the Arise Industrial Manufacturing 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan’s provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

The Plan, established on January 1, 2023, is a defined contribution plan offered to eligible employees of Arise Industrial Manufacturing and its affiliates (the “Employer”). Employees become eligible to participate in the Plan on the first day of the calendar month coinciding with or immediately following their attainment of age 18 and the completion of 3 months of service, measured from their date of hire.

During 2023, two employees of the Employer served as Plan Trustees (the “Plan Trustees”). Effective September 1, 2024, a third employee was appointed to join the Plan Trustees. The Plan Trustees do not receive any fees for their service.

Transfers In from Other Qualified Plans

In conjunction with the Employer’s acquisition of FabriFast, LLC, effective January 1, 2023, the Employer executed a merger and transfer agreement under which the FabriFast, LLC 401(k) Profit Sharing Plan (the “FabriFast Plan”) and its assets were merged into the Plan. On January 23, 2023, participant account balances totaling \$430,721 were transferred to the Plan via a plan-to-plan transfer. The custodian of the FabriFast Plan, Matrix Trust Company, provided certified investment information for all plan activity from January 1, 2023, through the date of the transfer.

In conjunction with the Employer’s acquisition of Olympic Industries, effective January 1, 2023, the Employer executed a merger and transfer agreement under which the Olympic Industries, LLC 401(k) Profit Sharing Plan (the “Olympic Plan”) and its assets were merged into the Plan. On January 19, 2023, and January 23, 2023, participant account balances totaling \$455,965 were transferred to the Plan via a plan-to-plan transfer. The custodian of the Olympic Plan, Matrix Trust Company, provided certified investment information for all plan activity from January 1, 2023, through the date of the transfer, excluding participant notes, which were not covered by the certification.

In conjunction with the Employer’s acquisition of R&M Manufacturing Co., LLC, effective January 1, 2023, the Employer executed a merger and transfer agreement under which the R&M Manufacturing Co., LLC 401(k) Savings Plan (the “R&M Manufacturing Plan”) and its assets were merged into the Plan. On March 9, 2023, participant account balances totaling \$2,498,156 were transferred to the Plan via a plan-to-plan transfer. The custodian of the R&M Manufacturing Plan, Empower Trust Company, LLC, provided certified investment information for all plan activity from January 1, 2023, through the date of the transfer.

In conjunction with the Employer’s acquisition of R&M High Speed Stampings, LLC (formerly known as Thomas Engineering Company), effective May 1, 2023, the Employer executed a merger and transfer agreement under which the Thomas Engineering Company Retirement Plan (the “Thomas Engineering Plan”) and its assets were merged into the. On August 17, 2023, participant account balances totaling \$6,764,670 were transferred to the Plan via a plan-to-plan transfer. The custodian of the Thomas Engineering Plan, Empower Trust Company, LLC, provided certified investment information for all plan activity from January 1, 2023, through the

transfer date, August 17, 2023. However, Empower Trust Company, LLC was unable to certify investment information for plan activity from May 1, 2023, through the transfer date, which included participant notes, \$184,126 in net appreciation in the fair value of investments, and \$4,358 in interest and dividends.

Refer to Note 4 for additional information related to unaudited information certified by the Plan custodians.

Amendments

Effective May 1, 2023, the Plan was amended to implement special vesting rules. Participants will become fully vested upon reaching the normal retirement age of 62 while employed. Additionally, employees of R&M Manufacturing Co., LLC who were employed as of January 1, 2023, and employees of R&M High Speed Stampings, LLC who were employed as of April 13, 2023, are 100% vested in all money sources.

Contributions

The Employer provides a safe harbor matching contribution of 100% of the first 3% of the participant's voluntary contribution and 50% of the next 2% on a payroll period basis. The Employer may also provide a discretionary Employer matching contribution. There were no discretionary Employer matching contributions for the years ending December 31, 2024 and 2023.

The Employer may also make a non-elective Employer contribution, allocated as a uniform percentage of each participant's total voluntary contributions. The allocation is determined based on participants' contributions as of the end of the Plan year. No non-elective Employer contributions were made for the years ended December 31, 2024 and 2023.

Each year, participants may contribute up to 100% of their annual compensation, as defined in the Plan document, on a pre-tax basis. Participants may also contribute Roth deferrals on an after-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions and an allocation of the Employer's contribution, Plan earnings and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

On termination of service due to death, retirement or other reasons, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. In-service distributions may also be granted in accordance with the provisions of the Plan document.

Vesting

Participants are immediately vested in their contributions, including actual earnings, as well as in the Employer's safe harbor matching contributions. Vesting in the discretionary Employer matching contribution account and non-elective Employer contribution account, along with actual earnings, is based on years of vesting service in accordance following vesting schedule:

The vesting schedule does not apply once a participant reaches the Plan's Normal Retirement Age of 62. At that point, the participant becomes 100% vested in all contributions. Additionally, a participant becomes 100% vested in their account if they die or become disabled while employed with the Employer.

Notes Receivable from Participants

A participant may borrow money from the Plan a minimum of \$1,000 up to a maximum of 50% of the participant's vested account balance up to \$50,000. The loans are secured by the balance in the participant's account. The interest rate on the loans is equal to 1% plus the prime lending rate. Principal and interest are paid ratably through payroll deductions. Loan repayment terms are not to exceed five years, unless the loan will be used by the participant to acquire the participant's principal residence.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statements of changes in net assets available for benefits.

Plan Termination

Although the Employer has not expressed any intent to do so, the Employer has the right under the Plan to discontinue their contributions at any time. The Employer reserves the right to terminate the Plan at any time, at its sole discretion, in compliance with the provisions of ERISA. Upon Plan termination or partial termination, participants will become fully vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent

assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis using fair value. Dividends are recorded on the ex-dividend date. Interest is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Net Appreciation in Fair Value of Investments

Net realized and unrealized appreciation/depreciation is recorded in the accompanying statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023, respectively.

Contributions

Contributions from Plan participants, and the related safe harbor matching contributions from the Employer, are recorded in the year in which the participant contributions are withheld from payroll.

Administrative Expenses

Certain expenses of administering the Plan are paid by the Employer and are therefore not reflected in the Plan's financial statements. Other expenses such as loan fees paid by participants and recordkeeping fees are paid with Plan assets and are reflected in the financial statements.

Benefit Payments

Benefits are recorded when paid.

Reclassifications

Certain amounts in the 2023 financial statements have been reclassified to conform to the presentation of the 2024 financial statements.

3. Fair Value Measurements

Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets and liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each general type of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and exchange-traded funds are valued at quoted market prices reported on the active market on which they are traded and are classified as Level 1 in the fair value hierarchy.

Interest-bearing cash is valued at cost plus accrued interest, which approximates fair value, and is classified as a Level 1 investment in the fair value hierarchy, as the balance is immediately available for participant transactions at \$1 per unit.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

On June 30, 2020, the Internal Revenue Service (“IRS”) stated that the non-standardized pre-approved plan adopted by the Employer, as then designed, qualifies under Code Section 401(a) (the “Code”). The Plan has not received a determination letter specific to the Plan itself; however, the Plan administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Parties-in-interest Transactions

The Employer, which is a party-in-interest, provides certain administrative services to the Plan at no charge. The cost of providing these services constitutes exempt party-in-interest transactions under ERISA. The Plan is also serviced by an outside investment adviser, which charges the Plan fees. In addition, the Plan has arrangements with other various service providers and these arrangements qualify as exempt party-in-interest transactions.

Notes receivable from participants, along with the related interest income, are also classified as party-in-interest transactions.

7. Subsequent Events

Effective January 1, 2025, the Plan was amended to implement automatic enrollment provisions. Participants whose Plan entry date is on or after January 1, 2025, will be automatically enrolled at an initial pre-tax deferral rate of 10% of eligible compensation, unless they make an affirmative

election otherwise. In addition, the determination period for calculating employer safe harbor matching contributions was amended to the end of the Plan year.
