Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Double H Plastics, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

(1) Description of Plan

The following description of Double H Plastics, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. The Plan also covers the eligible employees of Double H Manufacturing Corporation, Double H Tennessee, LLC, and Old York Road Printing, LLC, related by common ownership to Double H Plastics, Inc. (collectively, the Company).

General

The Plan is a defined-contribution, 401(k) profit-sharing plan covering all full-time employees of the Company who have completed 6 months of service. Upon satisfying these requirements, an employee will become eligible to enter the Plan on the earlier of the first day of the Plan year or the first day of the fourth, seventh, or tenth month of the Plan year (quarterly). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal) is the trustee and recordkeeper of the Plan. The Investment Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participant elective deferral contributions are equal to a portion of compensation as specified in the written elective deferral agreement. Participants not making an elective deferral of at least 1% will be automatically enrolled to defer 1% of compensation, unless the participant chooses a different percentage (including 0). The percentage will automatically increase each January 1, up to a maximum of 10%. A participant may defer up to 75% of compensation. The Plan also permits Roth contributions. Participants direct the investments of their contribution into various investment options offered by the Plan. Participant contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Company's discretionary annual contribution is determined each year by the Company and is calculated as a percentage of all eligible employees' compensation, who have completed 1,000 hours and 12 months of service. For the year ended December 31, 2024, the discretionary match was 7%. The discretionary match contribution net of forfeitures was \$1,581,188 for the year ended December 31, 2024.

The Company makes a safe harbor nonelective contribution to the Plan on behalf of each participant eligible to make pretax contributions to the Plan. Every participant who has completed 1,000 hours and 12 months of service, is eligible for a profit-sharing contribution if he or she was an active participant at any time during the Plan year. The safe harbor nonelective contribution is equal to 3% of each eligible participant's compensation for the Plan year. The safe harbor nonelective contribution was \$719,658 for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, and Company safe harbor nonelective contributions, as well as an allocation of the Company's discretionary annual contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's safe harbor nonelective contributions, and earnings or losses thereon.

Participants are vested in discretionary employer contributions and the earnings or losses thereon, in accordance with the following table:

Participants become immediately vested in their discretionary employer contributions upon normal retirement age, death, or becoming totally disabled, as defined.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participants' accounts and bear a fixed rate of interest determined by the plan administrator on a nondiscriminatory basis. The plan administrator takes into consideration the interest rates being charged on similar loans by independent parties when determining the interest rate. The interest rate for loans outstanding at December 31, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant with a vested account balance of \$7,000 or less will receive a single lump-sum distribution. If a participant's vested account balance is more than \$7,000, he or she, or a beneficiary, may elect to receive either a lump-sum distribution, a series of substantially equal annual payments over a fixed period of whole years, or a specified dollar amount each year.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$95,143 and \$61,627, respectively. Forfeitures of terminated participants' nonvested accounts may be used in the following order to: 1) offset administrative costs and 2) reduce employer contributions. During the year ended December 31, 2024, forfeitures of \$938 were utilized to offset administrative expenses and forfeitures of \$63,862 were used to reduce employer contributions.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from plan participants, and the safe harbor nonelective contributions and discretionary annual contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an ordinary transaction between market participants at the measurement date. The Company's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition, Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded based on the terms of the Plan.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 16, 2025, the date the financial statements were available to be issued.

(3) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value, investments at contract value, and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investment assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 or 2023.

Registered investment companies (mutual funds) - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts - Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Pooled separate account – Valued at the NAV of units held by the Plan at year end based on the market value of their underlying investments. Although the pooled separate account is not available in an active market, the NAV of the units are approximated based on the quoted prices of the underlying investments that are traded in an active market.

(5) Investment Contract with Insurance Company

On August 16, 2010, the Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal Life), which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal as well as interest at a specified rate that is guaranteed to the Plan. As of December 31, 2024 and 2023, this investment totals \$7,555,595 and \$7,726,898, respectively.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The net crediting rate and average yield earned are the same. The composite crediting interest rate is based upon a formula agreed upon with the issuer and is reset on a semi-annual basis. The contract provides assurance that the composite crediting interest rate will not be less than 1%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin offs of a subsidiary) that cause a significant withdrawal from the Plan, and (4) failure of the trust to qualify for exemption under ERISA. The plan administrator does not believe that the occurrence of any events which would limit the Plan's ability to transact at contract value with participants is probable.

The guaranteed investment contract does not have a defined maturity specified in the contract. The contract shall terminate on the date when no current deposit arrangements have been made between the Plan and Principal Life and there are no guaranteed interest funds with a value greater than zero under this contract. Provisions relating to annuities in the course of payment will continue to govern payment of such annuities until the final payment under each such annuity is made.

(6) Related Party and Party in Interest Transactions

Certain plan investments are a pooled separate account and a guaranteed investment contract managed by Principal. Principal is also the Plan trustee; therefore, transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$159,052 for the year ended December 31, 2024.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

(8) Tax Status

Effective January 1, 2019, the plan adopted an adoption agreement and plan document sponsored by Principal Life. The IRS has determined and informed Principal Life by a letter dated June 30, 2020, that the non-standardized pre-approved plan document and related trust are designed in accordance with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC, and therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
