### Opinion

#### Note 1. Plan Description

The following description of the CDI, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all employees of CDI, LLC and all employees of Apex Graphics, LLC (collectively, the Company) who are age 18 or older and are not subject to a collective bargaining agreement, a non-resident alien, or a leased employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions:** Each year, participants may contribute a percentage of their annual pre-tax compensation, as defined in the Plan Agreement, limited to the maximum amount allowed by the Internal Revenue Code (IRC). Participants may also elect to contribute to a Roth contribution. Participants can contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may contribute a matching contribution determined at the discretion of the Company. For the year ended December 31, 2024, the Company made a matching contribution of approximately \$88,500. The Company contributions are invested into various investment options in a manner that is consistent with participant contributions. Contributions are subject to certain limitations.

The Company may also contribute a profit-sharing contribution determined at the discretion of the Company. No such profit-sharing contribution was made for the year ended December 31, 2024.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions to selected investments as made available and determined by the Plan Administrator in 1% increments. Participants may change their investment options daily.

**Participant accounts:** Each participant's account is credited with the participant's contributions and an allocation of: (a) the Company's contribution, if any, and (b) Plan earnings, and charged an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary match and profit-sharing contributions plus actual earnings thereon, is based on years of service, as defined by the Plan. A participant is 100% vested after six years of credited service if they were hired after December 31, 2018. A participant is 100% vested after three years of credited service if they were hired on or before December 31, 2018.

**Forfeited accounts:** Forfeitures of non-vested Company matching and profit-sharing contributions may be used to reduce the employer contribution or to pay administrative expenses of the Plan. No forfeitures were used to reduce the employer contribution and pay administrative expenses during the year ended December 31, 2024. At December 31, 2024 and 2023, there was approximately \$3,600 and \$1,700, respectively, in the forfeiture account.

**Payment of benefits:** Upon termination, death, retirement or permanent disability, a participant or the decedent's beneficiary may elect to receive a lump-sum amount equal to the vested value of his or her account. In addition, participants may make withdrawals upon reaching a normal retirement age of 65 or by determination that a financial hardship, as defined in the Plan Agreement, has been incurred.

### Notes to Financial Statements

#### Note 1. Plan Description (Continued)

In the event of a participant's death, the entire death benefit must generally be paid to the beneficiaries within five years after the date of death.

Benefit payments are recorded when paid.

**Notes receivable from participants:** Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance. Loan terms generally range from one to five years, unless the loan qualifies as a loan used to purchase a principal residence. The loans are collateralized by the balance in the participant's account and will bear interest at a rate that is commensurate with prevailing market rates. Principal and interest are paid ratably through payroll deductions.

**Administration of plan assets:** Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the Company.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The accompanying financial statements are prepared on the accrual basis of accounting.

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Contributions:** Contributions from plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the custodian. See below for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### Note 2. Significant Accounting Policies (Continued)

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make the scheduled repayments and the Plan Administrator deems the participant to be in default, the participant's note receivable is reduced, and a benefit payment is recorded based on the terms of the Plan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Fair value measurements:** The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

**Registered investment companies:** Valued at the quoted market price of the funds as reported on public exchanges.

**Common/collective trust:** Valued based on the net asset value (NAV) of units of the common/collective trust. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments comprising the trust less its liabilities.

This practical expedient is not to be used when it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

#### Note 2. Significant Accounting Policies (Continued)

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Subsequent events:** The Company has evaluated subsequent events for potential recognition and/or disclosure through September 15, 2025, the date the financial statements were available to be issued.

#### Note 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### Note 5. Party-in-Interest and Related Party Transactions

Certain plan investments are shares of registered investment companies and a stable value contract issued by T. Rowe Price, the custodian; therefore, these transactions qualify as party-in-interest transactions. Fees of approximately \$19,500 were paid by the Plan to T. Rowe Price for the year ended December 31, 2024.

#### Note 6. Income Tax Status and Uncertain Tax Positions

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions. An audit was completed for the years ended December 31, 2022 and 2021; the exam closed with no findings as of the date September 9, 2024. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
