Opinion

We have audited the financial statements of the **Wiginton Corporation Employee Stock Ownership Plan and Trust** (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (the "financial statements").

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). 1. DESCRIPTION OF THE PLAN

The following description of the *Wiginton Corporation Employee Stock Ownership Plan and Trust* (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

Wiginton Corporation (the "Company") established the Plan effective January 1, 2007. The Plan operates as a leveraged employee stock ownership plan ("ESOP"), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (the "Code") of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is administered by the Company. Certain employees of the Company are the Plan's trustees (the "Trustees").

On January 1, 2008, the Plan purchased Company common stock using the proceeds of a loan from the Company and holds the common stock in a trust established under the Plan. The borrowing was paid in full during 2022 and all of the Company's common stock has been allocated on the same date.

Eligibility

The Plan is a defined contribution plan which covers all of employees of the Company and its participating subsidiary, *Wiginton Fire Protection Engineering, Inc.*, who have been credited with 1,000 or more hours of employment and are 18 years of age or older. Participants who do not have at least 1,000 hours of service during the Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's earnings from dividends and interest, equals the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan and fund the Plan's buy-back obligation. Participant contributions are not permitted.

Participant Accounts and Forfeitures

The Plan is a defined contribution plan under which a separate account is established for each participant. Each participant's account is credited as of the last day of each Plan year with allocations of (a) shares of the Company's common stock released by the Trustees from the unallocated account, (b) forfeitures of terminated participants' nonvested accounts and (c) Company contributions when made. Only those participants who are eligible employees of the Company as of the last day of the Plan year receive the allocation of contributions and forfeitures. Employer contributions and forfeitures are allocated in proportion to each participant's compensation compared with the total compensation of all participants.

Plan forfeitures are eligible for allocation at the earlier of a) distribution of the entire vested portion of the terminated participant's account balance or b) the last day of the Plan year in which a terminated participant incurs five consecutive one year breaks in service. Terminated participants with no vested account balance are deemed distributed at the date of termination. During 2024 and 2023, forfeitures allocated to eligible participants totaled 15,595 and 12,881 shares, respectively. Plan earnings are allocated to each participant's account based on the ratio of the participant's beginning of the year account balance to all participant's beginning of the year account balances. Forfeited non-vested accounts to be allocated to participant accounts in future years as of December 31, 2024 and 2023, were approximately \$795,000 and \$384,000, respectively.

Vesting

A participant's interest in the Plan is fully vested after six years of credited service or when they reach the normal retirement date (65 years of age), permanent disability, or death. A participant becomes 20% vested after two years of credited service and increases ratably until fully vested after six years of service. Employees who terminate before vesting forfeit their nonvested interest in the Plan after a one year break in service. Participants terminating from the Plan receive no allocation of employer contributions or forfeitures in the year they terminate from the Plan. Forfeitures are allocated each year to remaining eligible participants based on relative compensation levels, as defined in the Plan document.

Payment of Benefits

No distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, their legal representatives), or otherwise terminates employment with the Company. Lump sum distributions will be made for the vested portion of a participant's account that is valued at \$20,000 or less. Participants whose vested account balances are greater than \$20,000 shall receive a distribution in an annual installment based on the vested balance. During 2017, the Plan was amended that if a participant does not elect payment of their vested balance when they are eligible for such payment and the participant's vested account exceeds \$5,000, such account balance shall be converted to cash and then directly transferred to the Wiginton Company 401(k) Retirement Plan (the "401(k) Plan") for investment and distribution in accordance with the 401(k) Plan.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan. During 2024 and 2023, the Company repurchased from participants 325,479 and 346,750 shares, respectively, at prices determined from the independent appraisal.

Voting Rights

All Company stock held by the Trust shall be voted by the Trustees in accordance with instructions from the Plan's Administrative Committee. Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustees prior to the time that such rights are to be exercised. In accordance with instructions from the Plan's Administrative Committee, the Trustees shall vote any unallocated shares held by the trust, as well as any allocated shares for which a participant has failed to give timely voting direction.

Put Option

Under federal income tax regulations, the employer stock that is held by the Plan and its participants and that is or becomes not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its common stock distributed to participants for which there is no market. The put price is intended to be representative of the fair market value of the Company's common stock. The Company can finance any common stock repurchase with interest over a period not exceeding five years. The purpose of the put option is to ensure that the participants have the ability to ultimately obtain cash for the value of their shares.

Diversification

Diversification is offered to participants close to retirement age so that they may have the opportunity to direct part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25 percent of the value of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify their account receive a cash distribution and such distribution will be directly transferred to the Company's 401(k) Plan for investment in accordance with the 401(k) Plan. During 2024 and 2023, the Company repurchased from participants 24,510 and 46,065 shares, respectively, at prices determined by an independent appraisal.

Administration of Plan Assets

The Plan's assets, which consist principally of the Company's common shares, are held by the Trustees of the Plan.

Company contributions are held and managed by the Trustees, which invests cash received, interest, and dividend income and makes distributions to participants. The Trustees also administered the payment of interest and principal on the loans, which were reimbursed to the Trustees through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. Certain administrative expenses, including Trustees fees, are paid directly by the Company.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in conformity with GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. The fair value of the Wiginton Corporation common stock is one such significant estimate. Actual results could differ from those estimates.

Cash

Cash consists of bank deposit account in a financial institution, which at times may exceed federally insured limits. Interest income is recorded on the accrual basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and Trustees. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's aggregate gains and losses on investments bought and sold as well as held during the year.

Contributions

Employer contributions are recorded in the period in which they become the obligation of the Company.

Benefits Paid to Participants

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid directly by the Company and are excluded from these financial statements.

Subsequent Events

In preparing these financial statements, Plan management has evaluated, for potential recognition or disclosure, significant events or transactions that occurred during the period subsequent to the most recent statement of net assets available for benefits presented herein, through the date these financial statements were available to be issued.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurements. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Wiginton Corporation common stock: The fair value of the Wiginton Corporation common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal is based upon a combination of several different approaches for valuation of the common stock, specifically, income based, asset based, and market based approaches. The appraiser considered historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities. Plan management has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves Plan management's selection of an independent appraiser. Plan management accumulates the data for the appraiser from the audited financial statements of the Company. The appraiser prepares a preliminary report which Plan management reviews in detail, discusses and approves. The estimated fair value of common stock of the Company as of December 31, 2024 and 2023, was \$22.76 and \$12.04 per share, respectively, and is classified as Level 3.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no purchases, sales or transfers of assets into or out of Level 3 in 2024 or 2023.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in Company common stock, which is related party and party-in-interest transactions. As described in Note 2, the Company pays substantially all Plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA and related transactions are exempt from prohibited transaction rules.

6. TAX STATUS

The Plan has received a favorable determination letter dated May 10, 2017, from the Internal Revenue Service ("IRS"), that the Plan and related trust are designed in accordance with the applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's legal counsel believe that the Plan is designed in compliance with the applicable requirements of the Code. Additionally, the Plan administrator believes that the Plan is currently being operated in compliance with the applicable requirements of the Code, and therefore, believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires Plan management to evaluate and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. While the Plan may be subject to routine audits by taxing jurisdictions, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions. Upon termination of the Plan, the Plan's Administrative Committee shall direct the Trustees to pay all liabilities and expenses of the trust fund.

8. RISKS AND ECONOMIC UNCERTAINTIES

The Plan invests in common stock of the Plan Sponsor. The Plan Sponsor common stock is exposed to various risks, such as interest rate, market and credit risks as well as valuation assumptions based on earnings, cash flows, recent transactions, and other such techniques. Market risks include global events which could impact the value of the Plan's investment, such as a pandemic or international conflict. Due to the level of interest rate, market, and credit risks inherent with the Plan's investment, including uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the fair value of investment will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.
