Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed the audits of the financial statements of RSCI, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of RSCI, Inc. Retirement Plan 's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note F to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

A. Description of Plan:

The following description of the RSCI, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General** - The Plan is a defined contribution plan covering all eligible full-time employees of RSCI, Inc. (Company/Sponsor). Employees who were employed before November 1, 2009, were required to have at least one hour of service in order to be eligible to participate. There are no eligibility requirements for employees who were employed after November 1, 2009. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2016, the Plan was restated to comply with the requirements of the Pension Protection Act of 2006 (PPA), the Heroes Earnings Assistance and Relief Tax Act of 2008 (HEART Act), the Worker, Retiree, and Employer Recovery Act of 2008 (WRERA) and other applicable guidance. On January 1, 2022, the Plan was amended and restated to bring the plan into compliance with the legislative and regulatory changes set forth in IRS Notice 2017-37. Effective October 28, 2022, the Plan was amended to change eligibility of in-service distributions, excluding Salary Deferrals, by lowering the required age to 18. A participant may take no more than one in-service distribution in a Plan Year from the Prevailing Wage/Davis Bacon source. The plan was restated effective August 1, 2024 to change third party administrators.
2. **Contributions** - Each year participants may make elective deferrals of their pretax annual compensation up to the maximum limits, as defined in the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover).

RSCI, Inc. adopted a Safe Harbor matching Formula beginning in 2008. Under this formula, the safe harbor contribution is calculated at 100% of a participant's elective deferral up to 3% of compensation (as defined in the Plan) plus 50% of the participant's elective deferral up to 5% of compensation (as defined in the Plan). In 2008, all individuals participating in the Plan were eligible for safe harbor matching contributions. Starting in 2009, all participants, who were not eligible to receive a safe harbor matching amount in 2008, had to have one year of credited service to receive a safe harbor matching contribution. At their discretion, the Sponsor can make additional contributions to the Plan in the form of non-elective profit-sharing contributions. Contributions are subject to certain IRS limitations. The Sponsor performs work on certain public works projects that are prevailing wage projects. As a result, the Sponsor is required to pay employees working on these jobs pre-determined wages and fringe benefits. All fringe benefit amounts earned by the employees are contributed by the Sponsor, in the employee's name, to the Plan.

3. **Participant Accounts** – Each participant's account is credited with the participant's contributions and Company's matching contributions, as well as allocations of the Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting** – Participants are 100% vested in all contributions except for Sponsor Non-Safe Harbor Matching Contributions. Sponsor Non-Safe Harbor Matching Contributions vest based on a graduated vesting schedule which is determined by continuous years of service. The Plan utilizes a graduated vesting schedule allowing a participant to become 100% vested after six years of credited service.
5. **Forfeited Non-vested Accounts** – When a participant terminates prior to fully vesting, the non-vested portion of the participant's account is used to reduce administrative expenses. At December 31, 2024, and December 31, 2023, forfeited non-vested account balances totaled \$19 and \$19, respectively. In 2024 and 2023, \$0 and \$0 from forfeited accounts were used to reduce employer contributions and other expenses, respectively.

Payment of Benefits – Upon attaining normal retirement age of 65, termination of employment, or disability or death, a participant may receive a lump-sum amount or installments equal to the vested interest of his or her account.

B. Summary of Significant Accounting Policies:

The following are the significant accounting policies followed by the Plan:

1. **Basis of Accounting** – The financial statements of the Plan are prepared using the accrual method of accounting.
2. **Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. **Investment Valuation and Income Recognition** – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Custodians determine the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note I for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

4. **Payments of Benefits** – Benefits are recorded when paid.
5. **Subsequent Events** – The Plan has evaluated subsequent events through August 27, 2025, the date the financial statements were available to be issued.
6. **Costs of Plan Administration** – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer, RSCI, Inc. Expenses that are paid by the employer are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.
7. **Contributions** – Contributions from the Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

C. Plan Termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

D. Tax Status:

The Plan uses a pre-approved Plan document sponsored by Pinnacle Pension Services, Inc., which received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, stating that the pre-approved document satisfies the applicable provisions of the Internal Revenue Service (IRC). Effective August 1, 2024, the plan was restated to use a pre-approved Plan document sponsored by Benefits 2 Administrators, LLC, which received an opinion letter from the IRS dated September 13, 2023. The Plan itself has not received an opinion letter from the IRS; however, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirement of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

D. Tax Status (continued):

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

E. Reconciliation of Financial Statements to Form 5500:

For the years ended December 31, 2024 and December 31, 2023 there were no reconciling items between the Financial Statements and Form 5500.

F. Information prepared and certified by custodians:

The following information included in the accompanying financial statements and the information used to complete the supplemental schedule, Schedule H, Line 4i, Form 5500 was obtained from data that has been prepared and certified to as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC (formerly known as Great-West Life & Annuity Insurance Company and Great-West Trust company, LLC), the Custodian as of and for the years ended December 31, 2024 and 2023:

G. Concentration of Credit Risk:

Financial instruments that potentially subject the Plan to concentrations of credit risk consist of cash and short-term investments and marketable securities. The amount of exposure to any one specific investment has been limited by investing in mutual funds that use a diverse investment portfolio to limit risk.

H. Risks and Uncertainties:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially alter participants' account balances and the amounts reported in the statement of net assets available for benefits.

I. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

I. Fair Value Measurements (continued):

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Variable Annuities: Valued based on the prices/unit values calculated daily by the annuity provider. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract.

Collective Trust: Valued at fair value based on the NAV of unit held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

Collective Trust accounts consist of various investment options (i.e. common stock, mutual funds, short-term securities, real estate) and are valued based on the investments held. While the majority of the underlying asset values are quoted prices, the net asset value of the Collective Trust accounts are not publicly quoted.

K. Contract with Insurance Company:

The Plan entered into a traditional benefit-responsive guaranteed investment contract (GIC) with Empower Life & Annuity Insurance Company (Empower). Empower maintains the contributions in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The GIC issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The GIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contribution made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The contract value of the investment contract at December 31, 2024 and 2023 were \$103,045 and \$91,831, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. Amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan).
2. Changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions.
3. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestiture or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan.

K. Contract with Insurance Company (continued):

4. The Plan's failure to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.
5. Premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer.

L. Related Party and Party-In-Interest Transactions:

Certain Plan investments are managed by Empower Life & Annuity Insurance Company and Empower Trust Company, LLC. Empower Life & Annuity Insurance Company and Empower Trust Company, LLC is the custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

M. SECURE 2.0:

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 SECURE Act Secure Act 2.0. Many of the provisions have different effective dates, with some changes impacting 2023, 2024, 2025 and beyond. Plan documents are required to be formally amended for mandatory and any nonmandatory provisions adopted on or before the last day of the 2025 plan year. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.
