### NOTES TO FINANCIAL STATEMENTS

#### DESCRIPTION OF PLAN

The following description of the Datamark, Inc. 401(k) Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was adopted January 1, 1997. The Plan is a defined contribution plan covering substantially all employees of Datamark, Inc. (“the Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Effective October 4, 2023, Datamark Management Company, LLC became a participating employer in the Plan.

Adoption Agreement Revisions – Effective January 1, 2024, the Plan amended its Adoption Agreement to reduce the eligibility service requirement from 90 days to 30 days, change entry dates from quarterly to monthly, and allow deferral election changes on a monthly basis.

Plan Administration – Principal Trust Company (“Principal”) is the Custodian of the Plan. The Plan Administrator, an employee of the Company, administers the Plan. The Trustees, appointed by the Company, provide oversight of the Plan by determining the appropriateness of Plan provisions and investment offerings and monitoring investment performance.

Eligibility – All employees of the Company, excluding members of a collective bargaining unit and nonresident aliens with no U.S. source income, who have attained age 21 and completed 30 days of service are eligible to participate in the Plan.

Contributions – Each year, participants may establish contributions at any level of pretax annual compensation allowable under the provisions of the Internal Revenue Code, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make an annual discretionary matching contribution on behalf of each participant who contributed during the Plan year. To be eligible, a participant must be active on the last day of the Plan Year and have completed at least 500 hours of service. In 2024, the Company made a matching contribution equal to 50% of the participant’s elective deferral, not to exceed 6% of the participant’s compensation.

The Company may make a discretionary nonelective contribution to the Plan on behalf of each participant eligible to share in the allocation of the contribution. During 2024, the Company did not make any nonelective contributions.

Participants direct the investment of their contributions and the Company’s matching and nonelective contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

#### DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts – Each participant's account is credited with the participant's contributions, the Company's matching and nonelective contributions, and an allocation of the Plan's earnings and administrative expenses as applicable. Allocations are based on the participant's proportionate share of units held of the applicable investment options during each Plan year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions and rollovers, if any, plus actual earnings thereon. Vesting in the Company's matching and nonelective contributions portion of their accounts, plus actual earnings thereon, is according to a graded schedule based on years of service. Participants are fully vested in these contributions after six years of service.

Notes Receivable from Participants – Subject to limitations, a participant may borrow from the vested portion of his or her elective account. The minimum amount of any loan is \$1,000 and the maximum amount is the lesser of one-half of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in the participant's account during the prior twelve-month period. The loans are secured by the balance in the participants' accounts. Up to 50% of a participant's vested account balance may be used as collateral for any loan. Notes receivable from participants, at the time of loan withdrawal, are applied with interest rates of Wall Street Prime, which was 7.5% and 8.5% as of December 31, 2024 and 2023, respectively, plus 2% and remain at that rate through the loan's maturity. Outstanding notes receivable from participants have interest rates ranging from 7.5% to 10.5%. Principal and interest are paid through payroll deductions, or a check for prepayment. Notes receivable from participants are reported at their unpaid balances, plus any accrued, but unpaid, interest. There were no defaulted loans as of December 31, 2024 and 2023.

Payment of Benefits – On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) may elect to receive a lump-sum distribution or a direct rollover equal to the participant's vested account balance. In addition, hardship distributions and in-service distributions are permitted if certain criteria are met.

Forfeited Accounts – Forfeitures of the Company's contributions, and earnings thereon resulting from participants leaving the Company prior to vesting, are retained in a forfeiture account. Forfeitures of Company contributions may be applied first to the payment of Plan administration expenses, and then shall be applied to reduce the contributions of the Company. Forfeitures must be applied by the end of the Plan year following the Plan year in which the forfeiture occurs. The balance in the Plan's forfeiture account as of December 31, 2024 and 2023 was \$23,890 and \$11,541, respectively. During 2024, employer contributions and administrative expenses were offset using the balance of forfeited non-vested accounts by \$11,114 and \$1,433, respectively.

**SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting – The financial statements of the Plan are prepared using the accrual method of accounting.

Accounting Estimates – The preparation of the Plan's financial statements in conformity with generally accepted accounting principles in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Fair Value Measurements footnote for additional narrative. Unallocated contract funds held in the insurance company general account are valued at contract value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) consists of the unrealized appreciation (depreciation) of the investments and the excess (deficiency) of net proceeds over (under) market value of the related investment at the beginning of the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, but unpaid, interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based on the terms of the Plan document. Notes receivable from participants are specifically excluded from ASU 2016-13 *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments* (“ASC 326”).

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to investment advisory services and the administration of benefit payments and notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of the fair value of investments. For the year ended December 31, 2024, administrative expenses amounting to \$46,503 were paid by the Plan.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule of Schedule H, Line 4i - Schedule of Assets (Held at End-of-Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified to as complete and accurate by Principal Trust Company, the Custodian of the Plan.

**FAIR VALUE MEASUREMENTS**

The Plan investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

FASB ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. In general, fair value determined by Level 1 inputs utilize quoted prices (unadjusted) in active markets the Plan has the ability to access for identical assets or liabilities. Fair value determined by Level 2 inputs utilize inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. Level 2 inputs include quoted prices for similar assets and liabilities in active markets and inputs other than quoted prices observable for the asset or liability, such as interest rate and yield curves observable at commonly quoted intervals. Level 3 inputs are unobservable inputs for the asset or liability, and include situations where there is little, if any, market activity for the asset or liability.

In instances in which the inputs used to measure fair value may fall into different levels of the fair value hierarchy, the level in the fair value hierarchy within which the fair value measurement in its entirety has been determined is based on the lowest level input significant to the fair value measurement in its entirety. The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability.

Level 1 Fair Value Measurements – The fair value of the mutual fund accounts is based on quoted net asset values of the shares held by the Plan at year-end. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Investments Measured at Net Asset Value – Certain investments that are measured at fair value using the net asset value per share (or its equivalent) as a practical expedient, which include common collective trust funds, have not been categorized in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the amounts presented on the statements of net assets available for benefits. These investments have no unfunded commitments as of December 31, 2024 and 2023 and can be redeemed daily with no redemption notice period or other redemption restrictions.

**GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In 2013, the Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (“Principal”). Principal maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully-benefit responsive, contract value is the relevant measurement attribute for that portion of net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract as of December 31, 2024 and 2023 was \$10,446 and \$10,366, respectively. The crediting interest is declared monthly at an annual effective rate but may not be less than 1% or greater than 3%.

Certain events limit the Plan’s ability to transact at contract value with Principal. Such events include the following: (a) amendments to Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Company or other Company events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

#### EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds and common collective trust funds managed by Principal Trust Company (“Principal”). Principal is the Custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Principal provides certain administrative services to the Plan pursuant to a Plan service agreement between the Company and Principal. Principal receives revenue from mutual funds and common collective trust funds service providers for services Principal provides to the funds. This revenue is used to offset certain amounts owed to Principal for its administrative services to the Plan. If the revenue received by Principal from such service providers exceeds the amount owed under the Plan service agreement, Principal remits the excess to the Plan’s trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Company may make a payment to Principal for administrative expenses. Fees paid by the Plan to Principal for investment management services amounted to \$30,211 for the year ended December 31, 2024.

Global Retirement Partners, LLC (“Global”) provides investment advisory services to the Plan pursuant to a service agreement between the Company and Global. These transactions qualify as exempt party-in-interest transactions. The Plan or Company may make a payment to Global for investment advisory services. Fees paid by the Plan to Global for investment advisory services amounted to \$16,292 for the year ended December 31, 2024. There were no fees paid to Global by the Company during 2024.

SBNG, PC, the auditor of the Plan and Company, charges fees for the audit and attest services it provides, which are paid by the Company. These transactions qualify as exempt party-in-interest transactions. The Plan’s audit fees during the year ended December 31, 2024 were paid by the Company and are excluded from these financial statements.

The Plan has notes receivable from participants, which are secured solely by a portion of the participants’ vested account balance, in accordance with the Plan document. These transactions qualify as exempt party-in-interest transactions. The balance of notes receivable from participants as of December 31, 2024 and 2023 was \$46,473 and \$28,729, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

#### **INCOME TAX STATUS**

The Plan has not requested determination from the Internal Revenue Service as to the Plan's tax-exempt status. The IRS has determined and informed Principal Trust Company by a letter dated June 30, 2020 that the master prototype plan from which the Plan was drafted is designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the letter, Plan management believes that the Plan is designed to operate in accordance with all applicable provisions of the Internal Revenue Code; therefore, management believes that the Plan is qualified and that the related trust is exempt from taxation under the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain tax position that more likely than not would not be sustained upon examination by the IRS. As of December 31, 2024, there were no uncertain tax positions. The Plan files a Form 5500. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to U.S. federal and state income tax examinations by authorities for the years before December 31, 2021.

#### **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

#### **RISKS AND UNCERTAINTIES**

The Plan provides for various investment options in any combination of investment securities based upon participant requests. Investment securities are exposed to various risks such as interest rate, market, and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### **SUBSEQUENT EVENTS**

Subsequent events were evaluated through August 29, 2025, which is the date the financial statements were available to be issued.
