We have performed audits of the financial statements of Sheridan Production Operating Company, LLC 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). ### 1. Description of the Plan

The following description of the Sheridan Production Operating Company, LLC 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined-contribution voluntary employee savings plan qualified under Section 401(a) of the Internal Revenue Code (IRC) available to qualifying employees of Sheridan Production Operating Company, LLC (the Company, Employer, or Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *Plan Administration*

Fidelity Management Trust Company (Fidelity or Trustee) is the Trustee of the Plan and acts as the investment custodian for the Plan's participant-directed accounts. The recordkeeper of the Plan is Fidelity Workplace Service LLC.

#### *Eligibility*

All employees, except leased employees, residents of Puerto Rico, and interns, are eligible to enroll in and begin contributing to the Plan on their date of hire. Interns must attain age 21 and complete at least 1,000 hours of service, as defined, in order to become eligible to participate in the Plan. Employees will be automatically enrolled in the Plan 30 days after their hire date at a pre-tax deferral rate of 2%, unless they actively elect to enroll in the Plan at a different deferral rate or actively elect to opt out of participation in the Plan.

#### *Contributions*

Eligible participants may elect to contribute to the Plan on a pre-tax or after-tax Roth basis up to 60% of their qualifying compensation to the Plan, subject to certain IRC limitations. Participants who are automatically enrolled are subject to an annual increase of 1% until a deferral rate of 4% is reached, unless they elect otherwise. The Plan also allows catch-up contributions for participants who have or will attain the age of 50 by the last day of the Plan year, subject to certain IRC limitations.

The Company makes a Safe Harbor matching contribution of 100% of the first 6% of eligible compensation deferred. The Company may also make discretionary non-elective contributions. For the year ended December 31, 2024, the Company made discretionary non-elective contributions totaling \$290,394.

All contributions are participant-directed into various investment options offered by the Plan.

#### *Rollovers*

Participants are allowed to transfer funds to the Plan from eligible retirement plans, as defined.

### ***Participant Accounts***

Each participant's account is credited with the participant's elective deferral contributions, rollover contributions, Safe Harbor matching contributions, discretionary non-elective contributions, and an allocation of Plan earnings or losses, and debited with benefit payments and administrative expenses. The investment earnings or losses are allocated daily to each participant's account in the proportion that the balance of each participant's account bears to the total balance of all participants in each investment option. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are immediately vested in their elective deferral contributions, rollover contributions, Safe Harbor contributions, and discretionary contributions, plus actual earnings thereon.

### ***Notes Receivable from Participants***

Participants may borrow money from the vested value of their account with a minimum loan of \$1,000 and a maximum loan of the lower of (a) \$50,000 reduced by the excess (if any) of the highest outstanding balance of loans during the one-year period ending when or before the loan is made, over the outstanding balance of loans from the Plan on the date the loan is made, or (b) 50% of the participant's vested account balance. The loan repayment terms are up to five years unless the loan is used to acquire a principal residence, in which case the maximum repayment period is 15 years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest as determined by the Plan administrator. The interest rate on outstanding notes as of December 31, 2024 ranged from of 3.50% to 9.50%.

### ***Payment of Benefits***

A participant may elect to receive a lump sum, receive installment payments, or roll over their account balance to another qualified retirement plan upon (i) termination of employment, (ii) death or disability, (iii) retirement, (iv) attainment of age 59½ for in-service withdrawal, or (v) on account of hardship. Distributions of \$7,000 or less are paid as a direct rollover to an individual retirement account in the name of the participant if the terminated participant did not actively select another distribution option. Immediate lump-sum distributions are made to terminated participants if the participant's vested account balance is \$1,000 or less and the participant did not actively select another distribution option.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

### ***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes

therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Contributions***

Participant contributions and related matching contributions are recognized in the Plan year during which the Company makes payroll deductions from the participant's compensation. Discretionary contributions are recognized in the Plan year to which the participant's compensation relates.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest was de minimis at December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

### ***Payment of Benefits***

Benefits paid to participants are recorded when paid.

### ***Investment Valuation and Income Recognition***

Investments of the Plan are stated at fair value as more fully described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends and capital gains are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments represents the Plan's realized and unrealized gains and losses on investments, as well as the reinvested capital gains received.

Earnings of \$246,964 related to the self-directed brokerage accounts are reflected within other income on the statement of changes in net assets available for benefits.

### ***Administrative Expenses***

The Plan engages an independent investment consultant, trustee, and recordkeeper on a fee-for-service basis. Participants pay certain loan, distribution, and administrative fees that are charged directly to the participant's account. Certain investment fees are also net with investment earnings or losses of the investments in the form of an expense ratio charged to each fund.

Revenue sharing, which mutual fund companies would normally pay to an investment broker, is rebated to the Plan and may be used to defray administrative costs. The Plan received \$88,498 in revenue-sharing rebates during the year ended December 31, 2024. The excess amount deposited into the participants' accounts of \$25,985 and \$62,513 was used to pay administrative expenses. These amounts are reflected within other income on the statement of changes in net assets for benefits.

All other administrative expenses are paid by the Company and are not included in the accompanying financial statements.

### 3. Certified Investment Information

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, a qualified institution, has certified that the following information included in the accompanying financial statements and ERISA-required supplemental Schedule of Assets (Held at End of Year) is complete and accurate:

- Investments and notes receivable from participants, as reported in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, interest and dividend income, and interest earned on notes receivable from participants, as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment amounts, as reported in the notes to financial statements.
- All investment information included in the ERISA-required supplemental Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedule, and reading the disclosures relating to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP and whether the ERISA-required supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

### 4. Fair Value Measurements and Disclosures

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

*Level 1* - This level consists of inputs that are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

*Level 2* - This level consists of inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - This level consists of inputs that are unobservable for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used during December 31, 2024 and 2023.

*Mutual Funds and Money Market Mutual Fund (Mutual Funds)* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily fair value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common Collective Trust (CCT)* - Units held in the CCT are valued at the net asset value (NAV) based on fair market value of the underlying investments of the account less its liabilities. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The CCT invests in stable value products, including traditional guaranteed investment contracts (GICs), synthetic GICs, separate account GICs, and money market instruments.

*Self-Directed Brokerage Accounts* - The Plan allows participants to self-direct their funds into a wide range of investment options available through self-directed brokerage accounts. The Plan's self-directed brokerage accounts consist of interest-bearing cash, non-interest-bearing cash, common stock, and mutual funds. These investments are valued at their carrying values that approximate fair value, or the closing prices reported on the active market on which the individual securities and funds are traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies and assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 6. Tax Status

The Plan adopted a pre-approved plan document offered by Fidelity Management & Research Company for which an opinion letter was obtained from the Internal Revenue Service (IRS), dated June 30, 2020, indicating the pre-approved plan document and trust are designed in accordance with applicable sections of the IRC. The Plan administrator believes that the Plan, as amended, is designed and currently being operated in compliance with the applicable provisions of the IRC and the Plan and related trust continue to be tax-exempt; therefore, no provision for income taxes has been included in the accompanying financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Related Party Transactions

Certain Plan investments are shares of mutual funds managed by Fidelity. Fidelity is the Trustee as defined by the Plan. During 2024, fees were paid to Fidelity and its affiliates for recordkeeping and investment management services. Notes receivable from participants also qualify as party-in-interest transactions. Fees paid by the Plan to the Trustee, recordkeeper, and other service providers amounted to \$67,187 for the year ended December 31, 2024.

The above transactions are party-in-interest transactions under ERISA and are exempt from the prohibited transaction rules.

### 8. Risks and Uncertainties

The Plan provides for various investments in mutual funds, a money market mutual fund, a self-directed brokerage account, and a CCT. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Additionally, the value, liquidity, and related income of the investment securities are sensitive to changes in economic conditions in interest rates. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 9. Subsequent Events

The Plan has evaluated all events and transactions subsequent to the statement of net assets available for benefits through September 16, 2025, the date on which the financial statements were available to be issued. There were no events or transactions discovered during this evaluation that required recognition or disclosure in the financial statements.
