### 1. Plan Description

The following description of Albertina Kerr Centers 401(k) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

#### General

The Plan was established January 1, 1998 and is a defined contribution plan covering eligible employees of Albertina Kerr Centers (the “Organization”) and certain adopting affiliates who have completed three months of service and are at least eighteen years of age. Employees who were eligible to participate in a prior plan sponsored by the Organization will be eligible to participate in the Plan without satisfying any additional age or service requirements. Employees who were employed by the Organization on January 1, 2010 or became an employee of the Organization upon its acquisition of, or merger with, certain qualified affiliated entities may also be eligible to participate in the Plan without satisfying any additional age or service requirements. Upon satisfying the eligibility requirements, employees become immediately eligible to participate in the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 as amended (“ERISA”). The Organization is the plan administrator as defined by ERISA. An administrative committee comprised of certain members of the Organization’s management is responsible for oversight of the Plan. The administrative committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

#### Contributions

Each year participants may contribute a portion of their annual compensation, as defined by the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from certain other qualified defined benefit or defined contribution plans.

The Organization has elected to operate the Plan as a safe harbor 401(k) plan. Accordingly, the Organization contributed matching contributions in the amount of 100 percent of the first 3 percent and 50 percent of the next 2 percent of eligible compensation deferred and contributed to the Plan by each eligible employee for the nine-month period ended December 31, 2024.

Eligible compensation is defined by the plan document. Nonelective contributions, if authorized by the Organization, are allocated to participant accounts based upon eligible earnings during the period for which such discretionary contributions are made. Participants direct the investment of their elective salary deferrals and allocation of employer contributions into any of the investment options offered by the Plan. Contributions are subject to certain IRS limitations.

#### Participant Accounts

Each participant’s account is credited with the participant’s contributions and employer matching contributions, as well as allocations of the Organization’s nonelective contributions and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### Vesting

Participants are vested immediately in their contributions, employer safe harbor and qualified matching contributions, and employer qualified nonelective contributions plus earnings thereon.

Employer profit sharing contributions of certain employees who terminated under a prior plan document vest according to a six year graded vesting schedule.

### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000. Loans may not exceed 50 percent of the participant's vested account balance. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms may not exceed five years except for the purchase of a primary residence.

### **Payment of Benefits**

Upon attaining normal retirement age of 65, death, or termination of employment, a participant, or his or her beneficiary, may elect to receive either a lump sum amount equal to the participant's vested account balance or receive partial payments.

### **Forfeited Accounts**

Under the Plan's safe harbor features, participants who terminate employment with the Organization will continue to be fully vested in the elective deferral and employer contributions portions of their respective accounts. Forfeitures of employer profit sharing contributions of certain employees who terminated under a prior plan document may be used to reduce future employer contributions or offset plan expenses. At December 31, 2024 and March 31, 2024, forfeited nonvested accounts totaled \$16 and \$15, respectively.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrative committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisers and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2024. If a participant ceases to make loan

repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### **Subsequent Events**

Management has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

### **3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and March 31, 2024, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the nine-month period ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company and Newport Trust Company, LLC, which are subsidiaries of Ascensus, LLC.

### **4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 are described as follows:

**Level 1.** Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2.** Level 2 inputs to the valuation methodology include (a) quoted prices for similar assets or liabilities in active markets, (b) quoted prices for identical or similar assets or liabilities in inactive markets, (c) inputs other than quoted prices that are observable for the asset or liability, and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3.** Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and March 31, 2024. Fair values are provided by the investment custodian for all of the Plan's investment assets as follows:

**Common/collective trusts:** Common/collective trusts are valued at the net asset value ("NAV") of units of the collective investment trust. The NAV, as provided by the trustee, is based on the fair value of the underlying investments held by the fund less its liabilities. This amount may not be used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions, including purchases and sales, are valued on a daily basis. Certain participant-initiated withdrawals may be executed subject to a 90-day redemption restriction period. Were the Plan to initiate a full redemption of the Morley Stable Value Fund, under the terms of the collective trust agreement the investment issuer reserves the right to temporarily delay withdrawal from the fund for up to one year. For the nine-month period ended December 31, 2024, the average yield and crediting rate earned by the fund were approximately 4.93 percent and 2.85 percent, respectively.

**Registered investment companies:** Investments in registered investment companies, including money market accounts and other mutual funds, are valued at the daily closing price as reported by the fund. Registered investment company instruments held by the Plan are open-end mutual funds registered with the Securities and Exchange Commission. The funds are required to publish their daily NAV per share and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Related Party and Party-In-Interest Transactions**

Certain plan investments are managed by affiliates of Ascensus, LLC, subsidiaries of which serve as investment custodian for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for certain investment expenses are included in net appreciation in the fair value of investments, as they are paid through fees charged at the investment level rather than direct payments by the Plan. Administrative expenses and investment advisory and management fees paid directly by the Plan totaled \$45,191 for the nine-month period ended December 31, 2024. The plan sponsor pays directly certain other expenses related to the Plan's operations.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would continue to be 100 percent vested in the employer contributions portion of their accounts.

**7. Tax Status**

A volume submitter agreement has been adopted as the plan document. The volume submitter agreement obtained its latest opinion letter, dated June 30, 2020, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events, such as pandemics or international conflicts, which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes
