### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Crossroads Youth & Family Services, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the investment information, as described in Note E to the financial statements, is complete and accurate.

#### NOTE A--DESCRIPTION OF THE PLAN

The following description of Crossroads Youth & Family Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution prototype plan with a cash or deferred arrangement covering all employees of Crossroads Youth & Family Services, Inc. (the "Organization") who have completed one year of service and are age twenty-one or older, as defined in the Plan agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees may enter the Plan on the first day of the following plan year quarter coinciding with the date on which the employee satisfies the applicable eligibility requirements.

Contributions: Participants may elect to contribute a percentage of their eligible compensation up to the lesser of the participant's eligible compensation or the maximum amount allowed by the Internal Revenue Service (IRS). The IRS' limit was \$23,000 for 2024. Plan participants age 50 and older were eligible to make catch-up contributions of an additional \$7,500 during 2024. The Plan also permits participants to make rollover contributions from other qualified plans. The participants eligible to make the catch-up contributions may do so only after making the total elective deferral contributions allowed by the IRS.

The Organization makes discretionary matching contributions. The Organization determines the matching formula each year. For the years ended December 31, 2024, the Organization matched participant contributions on pre-tax elective deferrals equal to 100% of a participant's salary reduction up to 4% of the participant's eligible compensation.

Participant Accounts and Investment Options: Each participant's account is credited with the participant's contribution, the Organization's contribution, and the income and appreciation or depreciation of the investments attributable to each type of investment. Allocations are based on a participant's account balance. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions and the Organization's safe harbor contributions and any earnings thereon. Profit sharing contributions are vested at a rate of 20% per year beginning after year one, with 100% vesting upon reaching five years of service.

Forfeitures: Forfeitures result from non-vested benefit payments remaining in the Plan for all terminated employees and are used to offset administrative costs and future contributions of the Organization. Forfeitures of non-vested portions of participants' accounts were approximately \$600 for the year ended December 31, 2024. As of December 31, 2024, approximately \$12,000 of unused forfeitures are held as cash.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant may only have one outstanding loan at any one time.

The notes receivable from participants are secured by the balance in the participant's account and bear interest at reasonable rates determined by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions. A loan is considered in default as of the last day of the calendar quarter following the calendar quarter in which an unpaid installment payment was due.

Payment of Benefits: Upon termination of employment for reasons other than death, disability, or retirement, the participant is entitled to receive a lump sum payment equal to his or her vested interest.

Upon retirement at age 65, retirement due to disability or the death of the participant, the participant or participant's designated beneficiary is entitled to receive the participant's entire account balance.

If the participant's vested benefit in the Plan exceeds \$1,000, the participant must consent to the distribution before it can be made. Participants that have a vested benefit that does not exceed \$1,000 will receive a lump sum payment as soon as practicable following the event entitling the participant to a distribution. Certain early distributions made upon termination of employment may be subject to a penalty. At December 31, 2024, net assets available for benefits included approximately \$863,000 relating to former participants who have elected, for the present time, to leave their balances intact with the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Basis of Accounting: The financial statements of the Plan have been prepared using the accrual method of accounting.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

As described in FASB ASC 962-325-50-3, investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The guaranteed investment contract (GIC) held by the Plan (the EB 40 MaGIC Stable Value Fund) has no stated maturity dates, has a contract value that is payable on demand, and has a variable interest rate which is reset on a monthly basis, during which a new interest rate is applied to the total outstanding balance of the investment. Based on this, the contract value of the GIC is considered to approximate its fair value and therefore the GIC is presented at its contract value in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Essentially all of the administrative expenses of the Plan are paid by the Organization.

Income Tax Status: The IRS has determined and informed the Organization in a letter dated March 31, 2008, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon terms of the Plan document.

Subsequent Events: Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued. There were no subsequent events requiring recognition or disclosure.

#### NOTE C--INVESTMENT CONCENTRATIONS, RISKS AND UNCERTAINTIES

As of December 31, 2024, approximately 46% of Plan assets consist of three mutual fund investments.

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

#### NOTE D--FAIR VALUE MEASUREMENTS

FASB ASC 820-10-35-39 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-35-39 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs consist of unobservable inputs which are used when observable inputs are unavailable and reflect an entity's own assumptions about the assumptions that market participants would use in pricing the assets or liabilities.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund:* The EB MaGIC 40 Stable Value Fund is a common collective trust stable value fund valued using the NAV, as provided by the administrator of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund (including guaranteed investment contracts issued by insurance companies, synthetic wrap contracts, and cash and cash equivalents), less its liabilities, and then divided by the number of shares outstanding. This practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV. Trusts participating in the fund are subject to restrictions on withdrawals from the fund. Withdrawals needed for benefit payments and loan advances of participating employee benefit plans are generally permitted daily. Withdrawals for other purposes require twelve-month advance notice to the fund. There were no unfunded commitments as of December 31, 2024 and 2023.
