Scope and Nature of the ERISA Section 103(a)(3)(c) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Synchron, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 Synchron, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

From January 1, 2024 – March 22, 2024 the Plan assets were held by the Plan Trust and American Century Investments served as the recordkeeper. The Plan Trust was not considered a qualified institution under the Employee Retirement Income Securities Act (ERISA). There was no activity during the blackout period of March 23, 2024 to March 24, 2024. On March 25, 2025, the Plan investments were transferred to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust, a qualified institution.

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Synchron, LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C).

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Synchron, LLC 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

DECEMBER 31, 2024 AND 2023

NOTE 1 PLAN DESCRIPTION

The following description of Synchron, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution plan covering substantially all employees of Synchron, LLC. (the Company) who are not covered under a collective bargaining agreement and who are not nonresident aliens. The Company is the plan sponsor and administrator that controls and manages the operation and administration of the Plan.

An employee becomes eligible to participate in the Plan on the first day of the quarter following the date the employee completes one (1) month of service. In addition, employees must be at least twenty-one (21) years of age to participate in the plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants can elect pre-tax or Roth deferrals of their compensation subject to certain Internal Revenue Code (IRC) limitations. The Plan also permits rollover contributions of retirement benefits received from other qualified plans. In addition, those participants who are age 50 or older may make catch-up contributions.

The Company makes non-elective safe harbor contributions equal to 4% of participants compensation. In addition, the Company may elect to make profit sharing contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, non-elective safe harbor employer contributions, profit sharing contributions, and allocations of plan earnings, and is charged with withdrawals and an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions, actual earnings thereon, and any contributions made on their behalf into various investment options offered by the Plan.

Vesting

Participants are immediately vested in their contributions and employer safe-harbor contributions plus actual earnings thereon. Vesting in the profit-sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of credited service. The vesting schedule is as follows:

<u>Years of Vesting Service</u>	<u>Percentage Vested</u>
Less than 3	0%
3 or more	100%

The Plan considers a year of vesting service any year that a participant is credited with at least 1,000 hours of service during the Plan year.

A participant will become 100% vested if they are employed on or after normal retirement age, die, or become disabled.

Notes Receivable from Participants

Loans are not permitted under the Plan.

Payment of Benefits

Distributions from the Plan may be made in cash upon termination of employment. Retiring participants may elect benefit distribution in a lump-sum payment amount equal to the value of his or her vested account. Required minimum distributions may also elect cash installments over the life of the participant and a designated beneficiary. If an account balance does not exceed \$5,000 then the participant will have the option of receiving a lump-sum payment. If the participant does not elect to receive a lump-sum payment, they will automatically receive one. If an account balance is greater than \$5,000 at the time of termination the Plan has the option of rolling the vested balance over to another qualified retirement account.

Participants may also elect to receive in-service distributions if they attain the age of 59 ½ or are experiencing a financial hardship.

Forfeitures

Forfeited amounts may be used to reduce future contributions made by the employer or to reduce administrative expenses. Forfeited non-vested account balances totaled approximately \$12,400 at December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a description of fair value measurements.

Net appreciation (depreciation) registered from the statement companies and common collective trust fund includes the Plan's dividends, capital, gains and losses on investments bought and sold as well as held during the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits payments to participants are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Company or the Plan, as provided by the plan document. Fees related to the administration of benefit payments from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 FAIR VALUE MEASUREMENTS

The Plan performs fair value measurements in accordance with Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, which defines fair value as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance. ASC 820 also establishes a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The hierarchy establishes three (3) levels of inputs that may be used to measure fair value:

- Level 1 – inputs are unadjusted quoted prices in active markets for identical assets or liabilities;
- Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or
- Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered investment companies: Valued at the net asset value (“NAV”) of shares held by the Plan at year end. Primarily made up of mutual funds.

Common collective trust: Valued at the NAV of shares held by the Plan at year end adjusted for any cash held for liquidity purposes and any fees imposed by the fund. The net asset value per unit is determined by dividing the net assets by the number of units outstanding on the day of valuation. The net asset value of the fund is determined daily. Units are issued and redeemed daily, at the daily net asset value.

Pooled Separate Accounts: The value of the pooled separate accounts is expressed in units as determined by dividing the value of the entire account by the total number of units in the plan account. Valued at the respective fair value of the underlying assets, which are principally marketable equity and fixed income securities. The pooled separate account invests mainly in commercial real estate which is stated at fair value as determined by an independent third-party appraiser.

Money market funds: Valued at cost, which approximates fair value, and classified within Level 1 of the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 CERTIFIED INVESTMENT INFORMATION

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA – required supplemental schedule is complete and accurate:

- Investments as shown in the Statements of Net Assets Available for Benefits as of December 31, 2024.
- Investment income as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedule.

NOTE 5 CHANGE IN SERVICE PROVIDER

During the year ended December 31, 2024 there was a change in the Plan's service provider.

From January 1, 2024 – March 22, 2024 the Plan assets were held by the Plan Trust and American Century Investments served as the recordkeeper. The Plan Trust was not considered a qualified institution under the Employee Retirement Income Securities Act (ERISA). There was no activity during the blackout period of March 23, 2024 to March 24, 2024. On March 25, 2025, the Plan investments were transferred to Delaware Charter Guarantee & Trust Company d/b/a Principal Trust, a qualified institution.

NOTE 6 GUARANTEED INVESTMENT CONTRACT

Principal Fixed Income Guaranteed Option

The Plan maintains an investment in the in the Principal Fixed Income Guaranteed Option Account – which is a fully benefit responsive traditional investment contract (GIC). The carrying value of the EI Fixed Account Investment was \$473,474 as of December 31, 2024. Under the contract, the participants principal and interest are fully guaranteed by the general account assets of Principal Life Insurance Company. The investment strategy employed seeks to achieve consistent returns to support a competitive credited rate.

The contract meets the fully benefit-responsive investment contract criteria and therefore were reported at contract value. Contract value is the relevant measure for the fully benefit-responsive investment contract because this is the amount received by the participant if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. Each quarter an interest rate is established for new deposits received in that quarter and that interest rate is guaranteed for the remainder of the current calendar year. A renewal interest rate is then established each subsequent calendar year

and is guaranteed for one calendar year. The contracts do not have a maturity date. The average yield earned by the plan for the benefit responsive fund can be derived by averaging the quarterly gross interest rates for the fund over the year. The guaranteed rate of return was 1.25%.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include, but are not limited to the Plan's failure to qualify under Section 401(a) of the Code or the failure of the trust to be tax-exempt under section 501(a) of the Code; premature termination of the contract; Plan terminations or merger; changes to the Plan's prohibition or competing investment options; and bankruptcy of the Plan Sponsor or other events of the Sponsor, such as divestitures, that significantly affect the Plan's normal operations. Plan management does not believe any of the above events are probable of occurring.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination participants will become one hundred percent (100%) vested in their accounts.

NOTE 8 TAX STATUS

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Principal Life Insurance Company which had received an opinion letter dated June 30, 2020, from the IRS which stated the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes the Plan is designed and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements. With few exceptions, the Plan is no longer subject to income tax examinations by the U.S. federal, state, or local tax authorities for years before 2021.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan transactions are handled by Principal, the recordkeeper and trustee and as defined by the Plan; therefore, such transactions qualify as party-in-interest transactions. Substantially all fees related to the Plan are paid for directly by the Company.

These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.
