We have performed audits of the accompanying financial statements of Homemakers Plaza, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Homemakers Plaza, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **NOTE 1 PLAN DESCRIPTION**

The following description of the Homemakers Plaza, Inc. 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan covers the employees of Homemakers Plaza, Inc. (the Company).

**General**

The Plan is a defined contribution plan covering all employees except union employees of the Company, who have reached the age of eighteen and completed six months of service. It is subject to the provision of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Participants may contribute a portion of their annual compensation, as defined in the Plan, up to the maximum limitations imposed by the IRS. Participants may contribute on either a pretax or post-tax basis through Roth 401(k) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

A discretionary amount of matching contributions is determined by the Company each year. For the years ended December 31, 2024 and 2023, the Company contributed up to 50 percent of the first 8 percent of base compensation. In addition, the Company may make a discretionary profit sharing contribution. For the years ended December 31, 2024 and 2023, the Company did not make a discretionary profit sharing contribution.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Contributions are automatically invested in a designated fund until changed by the participant. Contributions are subject to certain limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Allocations are based on participants' earnings or account balances, as defined. Forfeited balances of terminated participants' nonvested accounts are used to reduce future employer contributions or pay administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contribution plus actual earnings thereon. Vesting in the Company's matching and profit sharing contribution portions of their accounts plus actual earnings thereon is based on years of continuous service. Participants hired prior to July 1, 2022 are 100% vested after six years of credited service. Participants hired after July 1, 2022 are 100% vested after three years of service.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$75,254 and \$47,343, respectively. These accounts will be used to reduce future employer contributions or pay administrative expenses.

**Payment of Benefits**

Upon termination of service due to any reason, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

**NOTE 1 PLAN DESCRIPTION (continued)**

**Notes Receivable from Participants**

Participants may borrow from their vested account balance a minimum of \$1,000 and to a maximum of \$50,000. Loans are available to participants on a reasonably equivalent basis. The loan(s) may not exceed 50% of the participant's vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan's trustee.

**Investment Options**

The amounts contributed by the employee and employer are deposited into one or more of the various mutual funds, collective trust fund and employer stock at the participants' discretion. Participants may change their investment options daily.

**NOTE 2 SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America using the accrual method of accounting.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based on the terms of the Plan document. During the years ended December 31, 2024 and 2023, deemed distributions in the amount of \$2,601 and \$171, respectively, were reported in the accompanying statements of changes in net assets available for benefits. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

**Payment of Benefits**

Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan but have not yet been paid at December 31, 2024 and 2023.

**Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Administrative Expenses**

A portion of administrative expenses incurred on behalf of the Plan are paid by the employer, which also provides certain administrative services that have not been charged to the Plan. The amount of such expenses and cost of such services have not been determined. Certain other administrative expenses, including the third party administrator fees, are paid by the Plan.

**Uncertain Tax Positions**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) for an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated their material tax positions and determined there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 3 FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification (ASC) 820 are described as follows:

Level 1—Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

Level 2—Inputs other than quoted prices included within Level 1 that are observable for the asset, either directly or indirectly, such as:

- quoted prices for similar assets in active markets;
- quoted prices for identical or similar assets in inactive markets;
- inputs other than quoted prices that are observable for the asset;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

Level 3—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds*—Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust fund*—The collective trust fund is invested in a variety of investments intended to seek the preservation of principle and provide interest income reasonably obtained under prevailing market conditions while maintaining liquidity. The fund invests in U.S. treasuries, corporate bonds, mortgage-backed securities and other marketable securities but is not a publicly traded instrument. The fair value of the fund is measured at the net asset value of units of the issuer's collective trust.

*Berkshire Hathaway Inc. common stock*—These shares are valued at the daily closing price as reported by the stock. These shares are deemed to be actively traded.

The following tables set forth by level within the fair value hierarchy the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Excess contributions payable consists of payments to be made in 2025 and 2024 to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan for the years ended December 31, 2024 and 2023, respectively.

**NOTE 5 PLAN TERMINATION**

Participants may apply the amount in their individual account to purchase an immediate annuity or receive a lump sum distribution paid to the participants in cash.

The Plan has adopted a prototype plan agreement and is relying on the prototype sponsor's opinion letter from the Internal Revenue Service (IRS), dated November 14, 2022. The letter states that the prototype document satisfies the applicable provisions of the Internal Revenue Code (IRC). Although the prototype plan may be amended after receiving the opinion letter, the prototype sponsor and the Plan Administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

**NOTE 8 RISKS AND UNCERTAINTIES**

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 9 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. Certain administrative expenses for the Plan are paid directly by the Company. Administrative expenses paid directly by the Plan for 2024 and 2023 included contract administrative fees paid to Empower Annuity Insurance Company of America. In 2024 and 2023, the Plan also paid investment advisory, audit, and management fees.

The Plan offers participants the option to invest in Berkshire Hathaway Inc common stock. Berkshire Hathaway is the parent company of the Plan Sponsor and, therefore, is considered a party-in-interest to the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 10 SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 14, 2025, the date which the financial statements were available to be issued. There were no subsequent events required to be accrued or disclosed.
