NOTES TO FINANCIAL STATEMENTS December 31, 2024 And 2023

1. Description Of The Plan

The following description of Riverside Resort and Casino Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan provides health and death benefits to eligible employees (with 180 days of consecutive, full-time employment) and covered dependents of the following entities (the Company or Sponsor):

Riverside Resort & Casino (a proprietorship)
Riverside Resort and Casino, Inc. (a corporation)
Laughlin Transit, Inc. (a corporation)
Bullhead Warehouse, LLC (a limited liability company)

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Health Benefits

The Plan provides dental and health (hospital, surgical and major medical) benefits pursuant to the Consolidated Omnibus Budget Reconciliation Act of 1985 (COBRA). The Plan also provides health benefits to eligible terminated employees and/or their covered dependents for up to eighteen months after the employees' death or termination of employment.

Stop Loss Coverage

The Plan has obtained specific stop loss insurance to limit its exposure for self-insured claims. The insurance covers 100% of specific losses paid which are in excess of a plan specific deductible of \$224,000 and a participant specific deductible amount of \$275,000. Stop loss refunds totaling \$274,305 for the year ended December 31, 2024 have been netted against health claims.

Notes To Financial Statements (*Continued*)

Receivable-reinsurance represents amounts due to the Plan for claim payments over the deductible amounts. This balance is stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Death Benefits

The Plan also provides group life and accidental death and dismemberment insurance. These benefits are insured under a master policy and a premium is paid monthly to the insurer by the Plan.

Contributions

The Company makes necessary contributions to the Plan to provide benefits for employees.

Employees are required to make contributions to the Plan as determined annually by the Company. Employees may also contribute specified amounts, as determined by the Company, to extend coverage to eligible dependents.

Audit And Administration Expenses

Certain expenses of maintaining the Plan, including the annual audit, other accounting costs, and certain third party administration fees are paid directly by the Company and are excluded from these financial statements.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Payment Of Benefits (Health Claims)

Claim payments are recorded when paid by the third-party claims processor.

Benefit Obligations

Amounts due to providers for claims received by the third-party claims processor but not paid are recorded as health claims reported but not paid in the accompanying statement of net assets available for benefits and of benefit obligations. The Plan liability for health claims incurred but not reported as of December 31, 2024 and 2023 was estimated by the Plan's actuary in accordance with accepted actuarial principles and represents the expected cost to settle the outstanding claims.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

3. Income Tax Status

The voluntary employees' beneficiary association trust funding benefits of the Plan received a favorable exemption letter from the Internal Revenue Service (the IRS) dated April 23, 1991 that the trust established under the Plan was designed in accordance with the provisions of Section 501(c)(9) of the Internal Revenue Code (the IRC) as tax-exempt. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

The Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan Administrator and the Plan's counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

5. Risk And Uncertainties

The Plan has funds on deposit with a financial institution, which exceeded the federally insured amounts by approximately \$3,221,000 and \$2,335,000 as of December 31, 2024 and 2023, respectively.

6. Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.
