1. Description of Plan

The following description of the Unified Door and Hardware Group 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Unified Door and Hardware Group, LLC (the "Employer" or "Company"). An employee becomes eligible to make deferrals upon attainment of 21 years of age. An employee becomes eligible for Employer matching and non-elective contributions upon attainment of 21 years of age and completion of six months of service. Employees who are not eligible to participate in the Plan are those employees who are: a resident of Puerto Rico; employees covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan; or a nonresident alien. Other participating Employers in the Plan are Joffe Millwork & Supply, LLC, L.I.F. Industries, Inc. dba Long Island Fireproof Door, Liberty Door Systems, LLC, New Door Installation, LLC, Next Door Distribution, LLC, and Prevent Alarm Company, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, participants may contribute up to 100% of their eligible compensation to the Plan on a pre-tax or Roth basis, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the statutorily permitted amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching contributions to the Plan on behalf of each participant. The matching contributions may be limited to match only contributions up to a specified percentage of compensation or a specific dollar amount. The Company may also make discretionary non-elective contributions on behalf of eligible participants in a ratio that each eligible participant's compensation bears to the total compensation paid to all eligible participants. To be eligible for non-elective contributions, a participant must be employed as of the last day of the contribution period and have worked at least 1,000 hours of service. During 2024, the Company did not make any non-elective contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Employer contributions and (b) Plan earnings (losses). Allocations are based on a participant's earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is 100% vested in their contributions at all times. A participant will vest in Employer matching and non-elective contributions as follows:

Forfeitures

If a participant terminates employment and is less than 100% vested in their Employer matching and non-elective contributions, the participant will forfeit the non-vested portion of their account. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$22,529 and \$92,922. These accounts may be used to reduce future Employer contributions or administrative expenses. During 2024, forfeitures of \$164,338 was used to reduce Employer contributions and \$59 of forfeitures was used to reduce administrative expenses.

Plan Credit Account

The Plan and Fidelity Management Trust Company (the "Trustee") entered into a revenue sharing arrangement whereby a portion of the revenue earned by the Trustee from certain funds is passed through to the Plan for payment of permitted plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay plan expenses, the Company created the Revenue Credit Account under the Plan. The Revenue Credit Account is an account within the Plan and is used to record-keep the redistribution of Plan-generated fund revenue that exceeds the costs associated with Plan administration. The Revenue Credit Account balance was \$186,854 and \$123,445 at December 31, 2024 and 2023. During 2024, eligible credits received totaled \$56,046 and reduced administrative expenses on the statement of changes in net assets available for benefits.

Payment of Benefits

Participants are eligible to receive benefit payments when they terminate service or reach age 59 ½. On termination of service, a participant may elect to receive a distribution in the amount equal to the participant's vested interest in their account. Benefit payments are also permitted for death, disability and hardship. In-service withdrawals are not available upon participation in the Plan for 60 or more months, except for vested Employer contributions due to prior Plan protection.

Notes Receivable from Participants

Participants may borrow from their account balance a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at rates that are commensurate with local prevailing rates as determined by the plan administrator. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the term may not exceed 10 years. Principal and interest is paid ratably through payroll deductions.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP."), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient are not categorized within the fair value hierarchy.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The mutual funds and money market fund held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. These funds are deemed to be actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded as a deemed distribution.

Payment of Benefits

Benefits are recorded when paid.

Corrective Distributions

Corrective distributions consist of amounts relating to excess deferrals plus earnings that were distributed to affected participants.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment related expenses are included in the NAV of the respective funds and, consequently, those expenses are not separately reflected but are a component of net appreciation in fair value of investments.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 12, 2025.

3. Information Certified (Unaudited)

5. Common/Collective Trust

Participants have the option to invest in the Galliard Stable Return Fund M (the "Fund"), which is a common/collective trust. The Fund invests all of its assets in Galliard Stable Return Fund Core, a collective trust fund sponsored by SEI Trust Company. SEI Trust Company is the trustee of the Fund.

The net asset value of the Fund is calculated daily, and net investment income and realized and unrealized gains on investments are not distributed but rather reinvested and reflected in the net asset value of the Fund. Units of the Fund are issued and redeemed at the current net asset value. Redemptions by participating plans for large-scale withdrawals or plan termination occur at net asset value following a 12-month notice period. The Fund has no unfunded commitments at December 31, 2024 and 2023.

6. Plan Termination and Merger

Effective December 31, 2024, the Plan was frozen to no longer receive contributions, and subsequently, the Plan was merged into the Foundation Building Materials 401(k) Profit Sharing Plan and Trust (the “Surviving Plan”) in April of 2025. As a result of the merger, all assets of the Plan were transferred to the Surviving Plan and the Plan ceased to exist as of that date.

7. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer, Fidelity Management Research Co., dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the Internal Revenue Code (“IRC”). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by the taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

8. Exempt Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

9. Non-Exempt Party-in-Interest Transactions

During 2021, certain participants’ contributions totaling \$3,505 were remitted by the Employer to the Plan later than required by Department of Labor Regulation 2510.3-102. The Employer remitted these contributions with lost earnings to affected participants in March of 2024.

10. Risks and Uncertainties

Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.
