## Independent Auditor's Report

To the Plan Administrator of  
Kawasaki Motors Corp., U.S.A. 401(k) Profit Sharing Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kawasaki Motors Corp., U.S.A. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **Responsibilities of Management for the Financial Statements**

#### **1. Description of Plan**

The following description of the Kawasaki Motors Corp., U.S.A. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. Participating and affiliated employers include Kawasaki Motors Corp., U.S.A. ("AKM" or the "Company"), Kawasaki Motors Finance Corp. ("KMFC"), Kawasaki Precision Machinery, U.S.A., Inc. ("KPM"), Kawasaki Robotics, U.S.A., Inc. ("KRI"), and Kawasaki Heavy Industries, Inc. ("KHI").

#### **General**

The Plan is a defined contribution plan established effective February 1, 1986 and restated as of June 9, 2023. The Plan covers all employees, excluding union, leased, and on-call, of the Company who have completed their 90th day of work. Eligible employees can participate in the Plan on the first of the month immediately following ninety days of service. The Plan requires a participant to be employed as of year end to be eligible to receive discretionary employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### **Administration**

The Company has delegated most of the Plan administrative functions to the 401(k) Committee appointed by the board of directors. The Plan's contract administrator, trustee, and custodian is Principal Life Insurance Company ("Principal"). The Company has the discretion to appoint or remove any trustee or agent of the Plan.

With consultation from the board of directors, the 401(k) Committee has the power to administer the Plan and apply all of its provisions on behalf of the Company.

#### **Contributions**

Each year, participants may contribute up to 90% of pretax annual compensation, as defined in the Plan document, for up to the maximum limits of the Internal Revenue Code ("IRC"). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Automatically enrolled participants will have their deferral rate increase by 1% each January 1st until their deferral rate reaches 15%.

The Company may make matching contributions to the Plan on behalf of all participants who make elective deferrals. The Company shall contribute and allocate to each participant's matching contribution account an amount equal to a percentage of elective salary deferrals. Matching contributions are computed on a per pay period basis. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan. For the year ended December 31, 2023, there were no discretionary contributions to the Plan. Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

The Company implemented safe harbor matching contributions equal to 100% of elective deferral contributions that are not over 3% of compensation, plus 50% of elective deferral contributions that are over 3% of compensation but are not over 5% of compensation.

Matching contributions by the Company are invested in the participants' accounts according to their specified allocations of investment fund options as of the date of the contribution.

Employer contributions of \$2,890,701 were made to the Plan for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions and an allocation of the Plan's earnings. Participant accounts are reduced by withdrawals, losses on investments, administrative expenses of the Plan and any forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are immediately vested in their safe harbor matching contributions plus actual earnings thereon.

AKM, KMFC, KPM and KHI participants are 100% vested in discretionary employer matching contributions when made. Effective January 1, 2013, the Plan was amended to adopt a provision for discretionary matching contributions made for employees who are hired on or after January 1, 2013 to be subject to the vesting percentages noted below.

#### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$2,500 for up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined annually, is set at the rates available for similar loans from commercial lending institutions, as defined. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to 5 years or greater for the purchase of a primary residence.

#### Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment or IRA, depending on the balance. In addition, the Plan allows for hardship distributions if certain criteria are met.

#### Forfeited Accounts

Amounts forfeited from terminating participants' non-vested portion of their Company contributions and earnings on Company contributions can be used pay administrative expenses or to reduce future employer contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeitures that have not been used to pay administrative expenses or used to reduce employer contributions shall be allocated as of the last day of the Plan year. During 2024, employer contributions were reduced by \$1,093 from forfeited nonvested accounts, in accordance with Plan provisions.

## 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value or net asset value ("NAV"), which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expenses when they are incurred. Delinquent notes are reclassified as distributions based upon the terms of the Plan agreement.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

#### Subsequent Events

The Plan's management evaluated events that occurred after December 31, 2024 through September 16, 2025, the date when the financial statements were available to be issued. Based upon that evaluation, the Plan determined that there were no material subsequent events that required recognition or additional disclosure in these financial statements.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used as of December 31, 2024 and 2023.

*Registered Investment Companies (Mutual Funds):* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following is a description of the valuation methodologies used for assets measured at NAV as the practical expedient to estimate fair value:

*Pooled Separate Accounts:* Pooled separate accounts ("PSA") are valued at NAV which is based on the fair value of the underlying investments of the PSA, less any liabilities. The underlying investments of the PSA are mainly equity and fixed income securities and short term investments.

The investment strategies of the Plan's PSA vary generally based on the investment objectives of the asset class of which they are a part. Such investment strategies include investments in fixed income securities and investments in equity securities in domestic and international markets for growth and value objectives as well as to replicate market indexes and to invest in emerging markets. The Plan had no unfunded commitments related to PSA. The redemption of PSA is subject to the preference of individual Plan participants and contains no restrictions on the timing of redemption.

*Common/Collective Trusts:* Common/collective trusts ("CCT") are valued at the NAV which is based on the fair value of the underlying investments held by the fund less its liabilities. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. The underlying investments of the CCT are mainly equity and fixed securities and short-term investments. The investment strategies of the Plan's CCT vary generally based on the investment objectives of the asset class of which they are a part. Such investment strategies include to seek current income and, as a secondary objective, capital appreciation; and to seek total return consisting of long-term growth of capital and current income, consistent with the investment strategy of various investors who are expected to retire at various dates. The Plan had no unfunded commitments related to CCT. The redemption of CCT is subject to the preference of individual Plan participants and contains no restrictions on the timing of redemption.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its evaluation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Information Certified by Trustees**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Principal Life Insurance Company, the Trustee of the Plan, have certified the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**6. Tax Status**

The Plan adopted a pre-approved plan offered by Principal Life Insurance Company. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**7. Related-Party and Party-in-Interest Transactions**

Certain Plan investments are managed by Principal Life Insurance Company (“Principal Life”) and Principal Global Investors Trust Company (“Principal Global”). Principal Life, Principal Global and Principal Trust Company are all owned by Principal Financial Group, Inc. Principal Trust and Principal Life are the custodians as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan pays administrative expenses to parties-in-interest who provide services to the Plan and for whom a statutory exemption exists. Additionally, notes receivable from participants are considered party-in-interest transactions.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. For the years ended December 31, 2024 and 2023, four investments represented a concentration of greater than 10% of the Plan's assets available for benefits.
