INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator
Canadian Pacific U.S. Salaried Retirement Income Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Canadian Pacific U.S. Salaried Retirement Income Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Canadian Pacific U.S. Salaried Retirement Income Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audits of the Financial Statements section of our report. We are required to be independent of Canadian Pacific U.S. Salaried Retirement Income Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

1. SUMMARY DESCRIPTION OF THE PLAN

The following description of the Canadian Pacific U.S. Salaried Retirement Income Plan (the "Plan") is provided for general informational purposes only. Participants should refer to the Plan document for complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

General - The Plan was originally established on July 1, 2010, for all eligible employees of Soo Line Railroad Company; Dakota, Minnesota & Eastern Railroad Corporation; and Delaware and Hudson Railway Company, Inc. (collectively, the "Companies") not covered by either the Canadian Pacific Pension Plan for U.S. Management Employees or a collective bargaining agreement, unless specifically provided for by such agreement. The Canadian Pacific Kansas City Limited ("CPKC") 401(k) Savings Plan Investment Committee (the "Investment Committee") (formerly known as "the CP 401(k) Savings Plan and Canadian Pacific U.S. Salaried Retirement Income Plan Investment Committee") controls and manages the investments of the Plan. The Plan is a qualified retirement savings plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended, and the Internal Revenue Code (the "Code"), as amended. Principal Financial Group Inc. (the "Trustee") is the trustee and record-keeper of the Plan. Effective December 31, 2024 the Plan merged with and into the CP 401(k) Savings Plan. Plan assets of \$22,011,512 were transferred into the CP 401(k) Savings Plan.

Eligibility - Qualified employees may participate in the Plan if they have reached the age of 21 and have completed an hour of service with the Companies on or after July 1, 2010, and are not eligible to accrue additional benefits under the Canadian Pacific Pension Plan for U.S. Management Employees.

Contributions - The Companies make an annual retirement contribution each Plan year on behalf of eligible participants. The annual retirement contribution is equal to 3.5% of the eligible participant's eligible earnings. The Plan does not permit participant rollovers from other qualified plans. Participants are not permitted to make contributions to the Plan.

Participant Accounts - Participant accounts are established under the Plan for each participant that receives a contribution. Investment of amounts credited to the participants' accounts are at the direction of the Investment Committee. Each participant's account is credited with the Companies' contributions and an allocation of the Plan earnings from the selected investment funds. Earnings of each investment fund are allocated daily based on the participants' account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested account balance.

Vesting - Participants are fully vested in the Companies' contributions and related earnings and losses thereon after three years of service (100% three-year cliff vesting). Participants become fully vested if employment terminates as a result of retirement, death, or disability.

Forfeited Accounts - Forfeitures of nonvested account balances result from participants who withdraw from the Plan before becoming fully vested in the Companies' contributions and earnings and losses thereon. At the discretion of the Companies, forfeited nonvested accounts may be used to pay reasonable administrative expenses of the Plan; applied to reinstate the participant's account if the participant resumes employment at the Companies within 60 months; credited against the Companies' contributions; used to make any corrective contributions; or allocated among the accounts of the active participants. For the year ended December 31, 2024, the amounts used from forfeited nonvested accounts to reduce the employer contributions was \$50,000 (2023 - \$20,000), and to pay administrative expenses was \$46,249 (2023 - \$45,755). As of December 31, 2024, forfeited nonvested account balances totaled \$0 (2023 - \$64,325).

Notes Receivable from Participants - The Plan does not allow for participant loans.

Payment of Benefits - Benefits are distributed to participants or beneficiaries upon death, disability, retirement, or termination of employment. Benefit distributions under the Plan are made in either a lump-sum payment of the participant's account balance, a series of substantially equal installments over a specified period that may not exceed a participant's life expectancy or joint life expectancy of the participant and their beneficiary, or a combination thereof, at the discretion of the participant.

Plan Termination - Although the Companies have not expressed any intent to do so, they have the right under the Plan to discontinue their contributions at any time and to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, participants will be fully vested and the net assets of the Plan will be allocated among the participants or beneficiaries in accordance with the Plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies, which are in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with U.S. GAAP and Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of the Plan's investments, as reported in the statements of changes in net assets available for benefits, relates to the Plan's interest in securities that consist of realized gains (losses) and unrealized appreciation (depreciation) on those investments.

Contributions - Employer contributions are recorded in the period the participant earns the contribution.

Payment of Benefits - Benefit distributions are recorded when paid. The amount allocated to the accounts of participants who elected to withdraw from the Plan, but have not yet been paid was \$nil as of December 31, 2024 and 2023.

Investment-Related Expenses - Investment-related expenses are paid out of Plan assets and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments. Administrative expenses are paid by the Plan on a quarterly basis.

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. The Plan's management regularly reviews its estimates, including those related to pensions and other benefits based upon currently available information. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan provides for investments that, in general, are exposed to various risks, such as interest rates, market conditions, and credit risk. Due to the level of risk associated with certain investment securities, and the inherent uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risk factors in the near term will affect the amounts reported in the Plan's financial statements.

Subsequent Events - The Plan evaluates subsequent events for potential recognition and disclosure through September 19, 2025, the date the financial statements are available to be issued.

3. INFORMATION CERTIFIED BY THE TRUSTEES

The Plan's administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained certifications from the Trustee that all information provided by them is complete and accurate. Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, net appreciation in fair value of investments, and interest and dividends for the years ended December 31, 2024 and 2023, is presented in reliance solely upon those certifications.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification, *Fair Value Measurements and Disclosures* ("ASC 820"), provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are as follows:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Transfers between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023. There were no Level 2 or 3 valued investments as of December 31, 2024 and 2023.

5. TAX STATUS

The Plan received a determination letter from the Internal Revenue Service ("IRS") dated December 12, 2017, indicating that the Plan constitutes a qualified trust under Section 401(a) of the Code and is therefore exempt from federal income taxes under provisions of Section 501(a) of the code. The Company and Plan management believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Code, and the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition as a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.
