Independent Auditor's Report

To the Trustees
Bartlett & West, Inc. Employee Stock Ownership Plan

Opinion

We have audited the accompanying financial statements of Bartlett & West, Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Note 1 - Plan description and basis of presentation

The following description of the Bartlett & West, Inc. Employee Stock Ownership Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Bartlett & West, Inc. (Company) established the predecessor to the Plan effective as of January 1, 1972. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Advisory Committee appointed by the Company's Board of Directors administers the plan.

Eligibility

Employees of the Company are generally eligible to participate in the Plan upon their employment.

Contributions

The Company makes contributions to the Plan on a discretionary basis each year. The Company made cash contributions of \$9,500,000 and \$6,800,000 for the years ended December 31, 2024 and 2023, respectively.

Payment of benefits

Generally, no distributions from the Plan will be made until a participant retires, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), or otherwise terminates employment with the Company. However, a participant who reaches normal retirement age of 59 ½ after being employed 5 years, until he/she retires, may request one in-service distribution per Plan year.

Participant accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of the Company contribution. For the plan years ended December 31, 2024 and 2023, the hours of service required to receive an allocation of the Company's contribution was 500 hours. A participant must also be employed on the last day of the plan year to receive a contribution for that plan year. These allocation requirements are waived in the event that the participant incurs a separation of service because of death or disability or incurs a separation of service after attainment of normal retirement age in the current plan year or prior plan year.

The employer contribution is allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Plan earnings are allocated to each participant's account based on the ratio of the participant's balance at the beginning of the plan year to all participants' account balances at the beginning of the plan year.

Voting rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustees prior to the time that such rights are to be exercised.

Vesting

When a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company, according to the following schedule:

Plan termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Internal Revenue Code. Upon termination of the Plan, the Advisory Committee shall direct the Trustees to pay all liabilities and expenses of the Trust fund.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period, according to the following schedule:

Forfeitures are allocated in the same manner as employer contributions. Forfeitures of terminated non-vested account balances allocated to remaining participants at December 31, 2024 and 2023 totaled \$267,590 and \$297,246 respectively.

Put option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The

Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Operating expenses

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. The Plan sponsor absorbs certain administrative and auditing costs necessary to maintain the Plan.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. Participant loans for years ended December 31, 2024 and 2023 are \$520,795 and \$352,299, respectively. The interest rate charged is based on the current prime rate. The interest rate related to loans made in 2024 and 2023 was between 8.50% and 9.50%.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest rates on all outstanding loans shall be adjusted on January 1st of each calendar year to the Prime Rate in effect at that time plus 1% and the payment amount shall be adjusted accordingly for the remaining period of the loan.

Note 2 – Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment valuation and recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Note 3 – Tax status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated September 27, 2013, that the Plan, as amended, is qualified and the trust established under the Plan is tax-exempt, under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s ERISA counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and related trust was tax-exempt as of the financial statement date, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 – Related party transactions

The Plan’s assets, which consist principally of Bartlett & West, Inc. common shares, are held by the Trustees of the Plan.

Company contributions are held and managed by the Trustees, who invest cash received, investment income and dividend income and make distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

Note 5 – Risks and uncertainties

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

Note 7 – Fair value measurements

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three levels:

- Level 1 — Valuation is based upon quoted prices for identical instruments traded in active markets.
- Level 2 — Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- Level 3 — Valuation is generated from model-based techniques that use significant assumptions not observable in the market.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Plan sponsor common stock held by the Plan: Valued at the fair market value of a non-marketable, non-controlling interest based upon an independent valuation report. For 2024 and 2023, the valuation was based upon a combination of the public guideline company, market transactions and discounted future cash flow valuation methods. Techniques used were consistent with the prior year. The valuation took into account historical and projected cash flow and net income, return on assets, return on equity, comparable markets and estimated fair value of Company assets and liabilities. The valuation has concluded that a market participant would also recognize a discount for lack of marketability.

The valuation process involves plan trustee selection of an independent firm annually. Plan management accumulates the data for the valuation from the audited financial statements of the Company. The valuation firm prepares a preliminary report which plan management, along with the ESOP trustees, review in detail, discuss and approve. The results of this process are documented in minutes of the Plan fiduciary.

The preceding methods described may produce a fair market value that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair market value at the reporting date.

Unrealized gains from the plan sponsor's common stock are included in the net appreciation in fair value of investments in the statements of changes in net assets available for benefits. Note 8 - SECURE Act 2.0

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. The most significant changes impact existing plan provisions included updates to required minimum distributions, hardship distributions rules, expanded eligibility of part-time employees, and modifications to catchup contribution rules. SECURE Act 2.0 amendments must be adopted by December 31, 2025 for calendar year plans. Since the provisions include both required and optional elements, the Plan administrator will determine the optional provisions to elect.

Note 9- Plan amendments
