**Scope and Nature of the ERISA Section 103(a)(3)(c) Audit**

We have performed audits of the accompanying financial statements of AutoInc 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### NOTES TO FINANCIAL STATEMENTS

#### 1. Description of Plan

The following description of the AutoInc 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General – The Plan is a defined contribution multiple employer plan covering substantially all of the employees of Auto, LLLP dba AutoInc, the Employer, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was established on January 1, 1998. As of January 1, 2024, related employers also participating in the Plan were Abilene Motors, LLLP dba Kia of Abilene; Amarillo I-40 Motors, LLLP dba Tri-State Ford / Amarillo Hyundai; Autoplex Automotive, LLLP dba All Star Dodge Chrysler Jeep Ram Fiat; Bradley Holding, LLLP; Bradley Ranch, LLLP; Bradley Wilson W F, LLLP dba Toyota of Wichita Falls; BW Odessa Partners, LLLP dba Freedom Buick GMC; BWB Automotive, LLLP dba Frontier Dodge Chrysler Jeep Ram Fiat; Canyon Ford, LLLP dba All Star Family Ford; Midland Nissan, LLLP dba Nissan of Midland; Midland T, LLLP dba Toyota of Midland; Plainview Automotive, LLLP dba Plainview Chrysler Dodge Jeep Ram; San Angelo Automotive, LLLP dba Car Town Hyundai; San Angelo Motors, LLLP dba Kia of San Angelo; Slaton Motors, LLLP dba All American Chevrolet / All American Chrysler Dodge Jeep Ram; Soncy Motors, LLLP dba Kia of Amarillo; Spirit Automotive, LLLP dba Spirt Chrysler Dodge Jeep Ram; Texas Dodge, LLLP dba Texas Dodge Chrysler Jeep Ram; and West Texas Nissan, LLLP dba West Texas Nissan. As of March 1, 2024, Canyon Ford, LLLP dba All Star Family Ford ceased participation in the Plan.

Eligibility – The Plan is a defined contribution benefit plan covering eligible employees as defined in the Plan document. To become a participant in the Plan, an employee must be twenty-one years old and is eligible to contribute to the Plan after one year of service. Plan entry dates are immediate upon meeting eligibility.

Contributions – Under the Plan, the participant and the Employer are both allowed to make contributions. The participants are allowed to contribute a portion of their salary in pre-tax contributions to the Plan subject to those limitations provided for in Section 402(g) of the Internal Revenue Code. The Plan includes an auto-enrollment provision where all newly eligible employees are automatically enrolled in the Plan, unless they elect not to participate, with a default deferral rate set at 2% of eligible compensation. The Employer contributes 50% of the first 4% of base compensation that a participant contributes to the Plan.

Participant Accounts – Each participant has one account that will consist of sub-accounts designated for participant contributions, Employer contributions, and rollover contributions. Participant contribution accounts are credited with the participant's contributions, the earnings of the specific investment vehicles selected, and forfeitures of terminated participant's nonvested accounts, as defined. Participants may self-direct their contributions to several investment vehicles, including mutual funds.

Employer contribution accounts are credited with the Employer's contribution. Participants may also self-direct the Employer account to several investment vehicles, including mutual funds.

## AUTOINC 401(k) PLAN

### NOTES TO FINANCIAL STATEMENTS

Vesting – Participants are immediately vested in their voluntary contributions and rollover amounts plus actual earnings thereon. Employer contribution accounts vest at a rate of 20% per year after the second year of credited service until fully vested after six years.

If a participant dies or becomes disabled, the participant's accrued benefit derived from Employer contributions becomes 100% vested without regard to the above schedule. In the event of full or partial termination of the Plan, an affected participant's rights to the accrued benefit shall be 100% non-forfeitable.

Forfeitures – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures are allocated to remaining plan participants. Forfeited non-vested accounts for December 31, 2024 and 2023 totaled \$83,542 and \$88,619, respectively.

Payment of Benefits – Upon normal retirement age or death, a participant or beneficiary may elect to receive either a lump-sum amount equal to the vested balance of the participant's account, or substantially equal installments over a period not to exceed the participant's lifetime or the joint lifetime of the participant and spouse. Participants may receive distributions prior to separation of service after normal retirement age is reached. Certain in-service distributions are permitted, including hardship distributions. Distributions to terminated participants will be made as soon as administratively feasible and an automatic distribution will be made to those participants with a vested balance below \$5,000.

## 2. Summary of Accounting Policies

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Benefits are recorded when paid.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities

at the date of the financial statements and the reported amounts of revenue and expenses during the period. Actual results could differ from those estimates.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statement of net assets available for benefits.

**3. Administration of Plan Assets**

The Plan assets are held by the Trustee of the Plan. Employer and participant contributions are invested by the Trustee as directed by the participants. The administrative expenses associated with the third-party administrator for the Plan are paid directly by the Employer. Other expenses associated with the Trustee of the Plan are paid by the participants. Certain fees are paid by the participants' investment funds to their affiliated investment advisors, transfer agents and recordkeeper as further described in each fund prospectus, plan service agreements, or other published documents. These fees were deducted prior to allocation of the Plan's investment earnings activity and thus are not separately identifiable as an expense.

**4. Notes Receivable from Participants**

Participants may borrow from their fund accounts an amount no less than \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years, or more if used to acquire a principal residence. The notes are secured by the balance in the Participant's account and bear interest at a rate commensurate with local prevailing rates. Interest rates range from 4.25% to 9.50%. All notes must have a definite repayment period which provides for payments to be made through payroll deductions. Participants may not have more than one outstanding note at one time.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

**6. Fair Value Measurements**

Financial Accounting Standards Board (FASB), *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the Net Asset Value (NAV) of shares held by the Plan at year end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Concentrations of credit risk exist if a number of investments are engaged in similar activities and have similar economic characteristics that could cause their ability to meet contractual obligations to be similarly affected by changes in economic or other conditions. The Plan has invested in a variety of financial instruments and investments involving diverse industries and geographic areas to mitigate exposure to credit risks.

**8. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**10. Tax Status**

The Plan is operating under a non-standardized pre-approved profit sharing plan with CODA filed by July Business Services. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan adopted the "uncertain tax positions" provisions of accounting principles generally accepted in the United States of America. The primary tax position of the Plan is its filing status as a tax-exempt entity. The Plan determined that it is more likely than not, that its tax positions would be sustained upon examination by the Internal Revenue Service (IRS), or other State taxing authority. There were no penalties or interest recognized during the year ended December 31, 2024 and 2023. The Plan is no longer subject to U.S. federal income tax examinations by federal taxing authorities for years before 2021.

**11. Related Party Transactions**

Certain Plan investments are shares of mutual funds that are managed by Empower Trust Company, LLC, a subsidiary of Great-West. Empower Trust Company, LLC is the Trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. For the years ended December 31, 2024 and 2023, fees that were paid by the Plan for the investment management services amounted to \$83,211 and \$71,730, respectively.

**12. Subsequent Events**

The Plan's management has evaluated subsequent events through September 9, 2025, the date which the financial statements were available for issue.
