INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the Spring Education Group 401(k) Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Spring Education Group 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Plan management, having determined it is permissible in the circumstances, has elected to have the audits of the Spring Education Group 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. Description of Plan

The following description of the Spring Education Group 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The initial effective date of the Plan was January 1, 2020 and the Plan was most recently restated effective January 1, 2022. Empower Annuity Insurance Company is the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

General

The Plan is a defined contribution plan generally covering eligible employees of SEG Inc. (the “Company”) and eligible employees of other employers who have adopted the Plan, including Laurel Springs School and LePort Solana Beach, LLC. Employees covered by a collective bargaining agreement, nonresident aliens, leased employees, reclassified employees and Puerto Rican employees are not eligible for the Plan. Employees must be age 21 or over to participate in the Plan. Non-permanent employees whose regularly scheduled service is less than 1,000 hours in a twelve month period become eligible employees upon the actual completion of 1,000 hours of service in a twelve month period. Salary deferral eligibility requirements have been modified to reflect provisions required by the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019 and the SECURE 2.0 Act of 2022.

Eligibility

Employees are eligible to participate in the Plan’s salary reduction arrangement after completion of 30 days of service with monthly entry dates. Participants become eligible to participate in the Plan’s matching contribution provisions after completion of six months of service with monthly entry dates. Participants become eligible for the Plan’s nonelective contribution provisions after completion of six months of service with semi-annual (January 1 and July 1) entry dates.

Contributions

Participants may generally contribute up to 90 percent of their pre-tax annual compensation, as defined in the Plan document. Contributions may also be designated as Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Plan includes an automatic enrollment provision whereby newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Non-permanent employees and certain other employees are not subject to the Plan’s automatic enrollment provisions. Automatically enrolled participants have their deferral rate set at 2 percent of eligible compensation. The Plan also allows for deferral percentages for each active participant having automatic enrollment contributions made on his or her behalf to be increased annually by 1 percent of eligible compensation limited to 30 percent of eligible compensation, unless otherwise elected by the participant. Certain employees are excluded from the automatic increase provisions of the Plan.

The Plan provides for employer matching contributions. The employer matching contribution formula is based on the participant’s work group, eligible compensation and salary deferral rate. For the year ended December 31, 2024, total employer matching contributions were \$6,226,257.

The Plan provides for discretionary non-elective contributions using a group allocation methodology. No discretionary non-elective contributions were declared for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (“IRS”) limits. Participants direct their contributions into various investment options offered by the Plan including default investment alternatives if no investment selection is made by the participant. Participants may change their investment options at any time.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's account is credited with the participant's contributions, employer matching contributions, as well as allocations of discretionary non-elective contributions, when declared, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, including their elective pre-tax deferral contributions, Roth 401(k) contributions, and rollover contributions, plus actual earnings thereon. Certain participants hired prior to February 1, 2020 are immediately vested in all employer contributions.

Vesting in the employer matching contribution and the discretionary employer non-elective contributions contribution portion of accounts for other participants is based on years of service, as follows:

<u>Years of Vesting Service</u>	<u>Percent Vested</u>
Less than 1	0%
1 year	50%
2 Years or more	100%

A participant is 100 percent vested upon death, disability or attainment of normal retirement age (age 65).

Forfeited Amounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$21,767 and \$84,511, respectively. Forfeitures may be applied to payment of administrative expenses, to reinstate previously forfeited accounts or to reduce employer contributions. During the year ended December 31, 2024, previously forfeited amounts of \$178,372 were used to reduce employer contributions.

Payment of Benefits

In the case of retirement or termination of employment (including due to death or disability), a participant may elect to receive the value of their vested interest in his or her account, in accordance with the provisions of the Plan. Benefits are distributed to a participant or their designated beneficiary in a lump-sum payment, installments over a period of years or an ad-hoc basis of some or all of the participant's accounts subject to any reasonable limits regarding timing and amounts as the Plan administrator may impose.

In-service withdrawals of all or a portion of a participant's vested account balance may be made by participants who have attained the age of 59-1/2. Participants are also permitted to make hardship withdrawals from their vested portion of their accounts in certain cases of immediate and heavy financial need. In-service withdrawals of all or a portion of a participant's rollover account balance may be withdrawn at any time.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants may have only one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at one percent above the prime rate at the time of borrowing. Principal and interest are generally repaid ratably through payroll deductions over a period of five years or less, with the exception of loans made for the purchase of a primary residence, where the repayment period may be up to and including fifteen years. Interest rates on notes receivable from participants ranged from 4.25% to 9.50% as of December 31, 2024.

2. Summary of Significant Accounting Policies

The following are the significant accounting policies followed by the Plan:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for the fully benefit-responsive investment contract. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The financial statements include the fully benefit-responsive investment contract and its related activity on a contract value basis (see Note 5).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (exit price). The Retirement Plan Committee determines the Plan's investment policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants (participant loans for Form 5500 reporting purposes) are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit distribution is recorded, based upon the terms of the Plan document.

Contributions

Contributions from Plan participants and the employer matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable and other participant-specific fees are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

As of December 31, 2024 and 2023, the Plan had \$121,815 and \$73,025 of amounts in unallocated accounts which the Plan can use to pay for administrative expenses or allocate to participants. During the year ended December 31, 2024, \$107,197 was used to pay administrative expenses and no amounts were allocated to participants.

3. Information Certified by Qualified Institutions

The Plan administrator having determined that it is permissible in the circumstances elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, qualified institutions, and subsidiaries of Empower Annuity Insurance Company of America, also a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, fully benefit-response investment contract at contract value, cash and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all mutual funds (registered investment companies), pooled separate accounts, the guaranteed income fund and participant loans listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board ("FASB") Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Valued at the NAV or equivalent based on units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan provides two pooled separate accounts investment options. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a pooled separate account, the pooled separate account reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner. The small cap value fund's objective is to achieve superior relative and risk-adjusted returns versus the Russell 2000 Value Index over a three and five-year time horizon. The large cap growth fund's objective is to outperform the Russell 1000 Growth Index over a full market cycle while controlling risk.

5. Contract with Insurance Companies

The Plan participates in the Empower Annuity Insurance Company Guaranteed Income Fund, a traditional fully benefit-responsive guaranteed investment contract. As of December 31, 2024 and 2023, the Plan held \$ 9,261,884 and \$10,269,916, respectively, in the Empower Annuity Insurance Company Guaranteed Income Fund. Empower Annuity Insurance Company maintains the contributions in a guaranteed interest account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0.15%. Such interest rates are reviewed on a semi-annual basis for resetting.

Certain events may limit the Plan's ability to transact at contract value with Empower Annuity Insurance Company. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include the premature termination of the contract by the Plan or termination of the Plan. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

6. Related-Party and Party-In-Interest Transactions

Plan investments include pooled separate accounts and a guaranteed income fund managed by Empower Annuity Insurance Company, by Empower Trust Company, or by affiliates of these entities. Empower Annuity Insurance Company and Empower Trust Company provides services to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, for participants who have elected to take a participant loan, the loans are secured by the respective participant's account balance. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. Total direct administrative expenses paid by the Plan totaled \$530,465 during the year ended December 31, 2024.

During 2024, the Company failed to remit to the Plan's trustee certain employee contributions totaling \$1,360, within the period prescribed by the Department of Labor regulations. During 2024, the Company made contributions to the affected participants' accounts to compensate those participants for potential lost income due to the processing delays. The Company believes that these transactions do not affect the tax status of the Plan and took action prescribed by the regulations to remedy such errors.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, including any employer contributions for which they were not already vested.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Tax Status

Effective January 1, 2022, the Plan was amended and restated by adopting an Empower Retirement, LLC pre-approved plan. Due to the rebranding of Empower Trust Company, LLC, the IRS issued an opinion letter dated September 16, 2022 for the Empower Trust Company, LLC pre-approved plan stating that the pre-approved plan document as then designed was in accordance with applicable Internal Revenue Code ("IRC") requirements. Although the Plan has been amended since this date, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

10. Plan Amendments

Effective January 1, 2024, the Plan was amended to make administrative changes to the Plan. During 2024, the Plan was also amended to increase the statutory limit for mandatory cash-outs from \$5,000 to \$7,000 for distributions made after December 31, 2023.

Effective May 1, 2024, the Plan was amended to make available domestic abuse distributions in accordance with the SECURE Act 2.0.

11. Subsequent Events

Management evaluated subsequent events for the Plan through September 22, 2025, the date the financial statements were available to be issued.
