Opinion

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

1. Description of Plan

The following description of The Yaffe Companies, Incorporated Employee Stock Ownership Plan, (the "Plan"), provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

a. General

The Yaffe Companies, Incorporated, (the "Company"), established the Plan effective as of January 1, 2006. The Plan is designed to comply with Section 4975(e) (7) and the regulations there under of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

b. Eligibility

All employees of the Company are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during the Plan year. An employee is eligible to enter the Plan upon the first day of the Plan year in which eligibility requirements are met if the requirements are met in the first six months of the Plan year. If the requirements are met in the last six months of the Plan year, the entry date will be the first day of the Plan year following the date eligibility requirements are met.

c. Contributions

The Company may make an annual discretionary contribution to the Plan in an amount, if any, determined solely by the Company. Contributions are allocated in the same proportion that each participant's compensation for the year bears to the total compensation of all participants for the year. Participants who are not employed on the last working day of a Plan year are not eligible for an allocation of the Company's contributions for such year unless their termination was due to retirement, death or disability.

d. Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with forfeitures of terminated participants' non-vested accounts. Contributions, earnings, and fees are allocated in the same proportion that each participant's compensation for the year bears to the total compensation of all participants for the year or based on a ratio of the participant's account relative to total account balances.

1. Description of Plan (Continued)

e. Vesting

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants begin vesting 20 percent per year of service after their second year of service and are 100 percent vested after six years of service.

f. Payment of Benefits

Distributions on account of death, disability, or retirement are made in a lump sum payment.

Distributions for other separations from service are made in accordance with the distribution policy in effect at the time of the initial distribution. The distribution policies call for installment payments to be made over five years for account balances over certain threshold amounts.

g. Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is permitted to vote any allocated share for which instructions have not been given by a participant.

h. Forfeitures

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures of terminated non-vested account balances allocated to the remaining participants at December 31, 2024 and 2023 totaled \$37,208 and \$3,383 respectively.

i. Put Options

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

j. Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In the first year, a participant may diversify up to 25 percent of the number of shares allocated to his or her account. In the following four years, a participant may diversify 25 percent of the additional shares contributed. In the sixth year, the participant may diversify up to 50 percent of the total shares ever held, less any shares previously diversified.

k. Income Taxes

The Plan's income tax filings are subject to examination by various taxing authorities. The Plan's open examination periods are 2021 and forward.

2. Summary of Significant Accounting Policies

The following are the significant policies followed by the Plan:

a. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

b. Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

c. Investment Valuation and Income Recognition

The common shares of the Company are valued at fair value. See Note 7 for discussion of fair value measurements. Distribution income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Net depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

d. **Subsequent Events**

Subsequent events have been evaluated up to September 16, 2025, the date these financial statements were available to be issued.

3. **Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Company shall direct the Trustee to pay all liabilities and expenses of the trust fund.

4. **Administration of Plan Assets**

The Plan's assets, which consist of the Company common shares, are held by the Trustee.

Company contributions are held and managed by the Trustee, which invests cash received, interest, and dividend income and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Certain administrative fees are paid directly by the Company.

6. Tax Status

The IRS has determined and informed the Company by a letter dated October 31, 2014, that the plan is qualified and tax-exempt, under the appropriate sections of the IRC.

7. Fair Value of Financial Instruments

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, (level 1), and the lowest priority to unobservable inputs, (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy within is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Investment in sponsor company common stock: The fair value of The Yaffe Companies, Inc. common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, guideline public companies, and estimated fair value of company assets and liabilities.

Interest-bearing cash: Valued based on the performance of the underlying assets.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

8. Risk Concentrations

Included in investments at December 31, 2024 and 2023 are shares of the sponsor's common stock and interest bearing cash. Plan sponsor common stock represents approximately 99% and 98%, respectively of total investments at December 31, 2024 and 2023. A significant decline in the market value of the sponsor's stock would significantly affect the net assets available for benefits.

The Plan periodically has interest bearing cash deposits at a bank exceeding the insured limits provided by the Federal Deposit Insurance Corporation ("FDIC"). At December 31, 2024 and 2023, the balance exceeding of accounts in excess of FDIC insurance totaled approximately \$0 and \$790,000, respectively.
