**NOTE 1 PLAN DESCRIPTION**

The following description of the Employee Benefit Plan of Universal Nutrition (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan covering substantially all employees of Universal Nutrition (Company) who have attained the age of 21 years and have completed 6 months of service. Once the eligibility requirements have been satisfied, an employee may enter the plan on the first day of the month coinciding with or next following. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan is administered by Company management. Third Party Administrators serve as the trustee of the plan, maintain records of the participant data and hold the Plan assets.

**Contributions**

Participants may contribute up to the maximum dollar amount allowed under federal regulations for the Plan year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). The Plan contains an automatic enrollment feature whereby upon satisfaction of the Plan's eligibility requirements, the Company will begin to automatically deduct 3% on a pre-tax basis. Participants automatically enrolled in the Plan will be invested in a designated fund until changed by the participant. The Plan contains an automatic escalation feature whereby automatically enrolled participants will have their deferrals automatically increased by 1% annually to a maximum of 5%. The plan sponsor has the option to provide discretionary contributions. In 2024, the plan sponsor contributed 50% of the participants' salary reduction contribution for the Plan year not exceeding 2.5% of the participants' salary. Contributions are subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and the employer's contribution. Plan earnings are allocated based on participant account balances, as defined. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. The Plan allows for participant-directed investment programs for which separate funds are maintained. The value of each participant's account is determined daily.

**Participants' Investment Options**

Participants must direct their salary deferral contributions and Company discretionary contributions, if any, to selected investments as offered by the Plan. Participants may change their investment options throughout the year by contacting the Plan's third-party administrator.

**Vesting**

Participants are immediately vested in their deferral contributions, rollover contributions, plus actual earnings thereon. Company discretionary contributions and earnings are fully vested after six years of credited service.

**Payment of Benefits**

Upon termination of employment, death, disability, or retirement, a participant with a vested account balance of more than \$7,000 can receive a lump sum payment or installment payments equal to the value of the participant's vested interest. Distribution of benefits upon termination becomes automatic if the participant's account balance is less than \$7,000. Automatic distributions above \$1,000 made without the participant's consent are rolled into an individual retirement account designated by the Trustee. Generally, certain minimum distributions are required for participants who have separated from service and have reached required minimum distribution age. The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

**Forfeitures**

Forfeitures can be used to pay plan expenses, reduce employer contributions, or be re-allocated to participants. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$44,113 and \$27,173, respectively. Forfeitures used to reduce employer contributions for the years ended December 31, 2024 and 2023 amounted to \$0 and \$9,221, respectively.

**Notes Receivable from Participants**

Participants may borrow from the Plan in any amount greater than \$1,000 and less than \$50,000 or 50% of the participant's vested account balance, minus the highest outstanding loan balance in the last 12 months, whichever is lower. The loans are secured by the balance of the participant's account and bear an interest rate of 1% above the prime rate. Participants are limited to five outstanding loans at any point in time. The term of the loan cannot exceed 5 years, unless it is for the purchase of a principal residence, which must be repaid within 15 years. Principal and interest are paid ratably during the year through payroll deductions.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Basis of Presentation**

The accompanying financial statements are presented in accordance with accounting principles generally accepted in the United States of America, ("GAAP"), as codified by the Financial Accounting Standards Board.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain report amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Reconciliation**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee of the Plan. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are reflected on a trade date basis. Income is recorded as earned on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of Benefits**

Benefit distributions are recorded when paid.

**Administrative Expenses**

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. All such fees are charged directly against the fund's investment performance and thus are not separately disclosed in the accompanying financial statements. Participant loan accounts are assessed a separate fee for the administration of loans. Processing of force out distributions are also assessed a separate fee. Certain other administrative expenses were paid from the Plan's assets. Expenses that are paid by the Company are excluded from these financial statements.

**Income Taxes**

The Plan's policy is to evaluate the likelihood that its uncertain tax positions will prevail upon examination based on the extent to which those positions have substantial support within the Internal Revenue Code and Regulations, Revenue Rulings, court decisions, and other evidence.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2023 excess contributions to the applicable participants in 2024.

**NOTE 4 FAIR VALUE MEASUREMENTS**

FASB ASC Topic 820, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under Topic 820 are described below:

- Level 1    Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2    Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3    Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual Funds (including money market mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 6 INCOME TAX STATUS**

The Plan is a Pre-Approved Plan sponsored by the trustee and adopted by the Company. The Internal Revenue Service informed the trustee by an opinion letter dated June 30, 2020, that the Pre-Approved Plan is acceptable under section 401 of the internal Revenue Code. The Plan has been amended since the last opinion letter; however, the Company and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and the Plan continues to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken a significant uncertain tax position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 7 EXEMPT TRANSACTIONS WITH PARTIES-IN-INTEREST**

Alerus Financial N.A. is the trustee as defined by the Plan. As such, transactions with the Trustee qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$8,182 and \$8,524 for the years ended December 31, 2024 and 2023, respectively.

Alerus Financial N.A. receives revenue from mutual fund service providers for services Alerus Financial N.A. provides to the funds. This revenue is used to offset certain amounts owed to Alerus Financial N.A. for administrative services Alerus Retirement and Benefits provides to the Plan. Any revenue sharing generated by the Plan in excess of the fees is carried over as a credit to be used following the end of the next calendar quarter.

**NOTE 8 NON-EXEMPT TRANSACTIONS**

During the year ended December 31, 2022, the Company failed to timely remit to the Plan withheld employee contributions in the aggregate amount of \$32,676, in accordance with the plan asset provisions of the Department of Labor (“DOL”) Regulation 2510.3-102, resulting in prohibited, or nonexempt, transactions. The accompanying Schedule of Delinquent Participant Contributions discloses this transaction in accordance with the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. The Company corrected the late remittances as of December 31, 2024.

**NOTE 9 RISKS AND UNCERTAINTIES**

Participants direct the investment of their accounts into various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amount reported in the statement of net assets available for benefits.

**NOTE 10 AMENDMENT AND TERMINATION OF PLAN**

Although it is not expressed any intent to do so, the Company reserves the right at any time to amend or terminate the Plan subject to the provisions of the Plan and ERISA. If the Company terminates contributions or the Plan is terminated, all participants will become fully vested.

**NOTE 11 SUBSEQUENT EVENTS**

No significant events occurred subsequent to the Plan’s year end. Subsequent events have been evaluated through September 16, 2025, which is the date these financial statements were available to be issued.
