## Independent Auditor's Report

Plan Administrator and Plan Participants  
Local Government Corporation Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Local Government Corporation Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### **Auditor's Responsibilities for the Audit of the Financial Statements**

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of US GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

**Other Matter**

*Supplemental Schedule Required by ERISA*

The supplemental schedule of assets held at year-end - schedule H, line 4i, as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1. Description of Plan**

The following description of the Local Government Corporation Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions. The Plan was established in 1990.

**General**

The Plan is a tax deferred annuity contract plan under Internal Revenue Code (IRC) Section 403(b) covering eligible employees of Local Government Corporation (the Employer), a tax-exempt organization under Code Section 501(c)(3). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for the oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The Plan is funded with a group annuity contract (the Contract) issued by American United Life Insurance Company (AUL). The Plan includes a second custodian, Lincoln National Life Insurance Company (Lincoln), which holds some investments (group variable annuity contracts) for long time participants who have not transferred their investments to the current provider or take a distribution. No contributions are allowed to be made to Lincoln. At December 31, 2024, no investment balances remained with Lincoln. At December 31, 2023, less than 1% of plan assets were held by Lincoln.

**Eligibility**

Employees who normally work greater than 20 hours per week and are not non-resident aliens are eligible to participate in deferral contributions upon hire. Employees are eligible to receive an employer matching contribution upon completing 12 months of employment with at least 1,000 hours of service during the year. Union employees do not participate in employer contributions.

Effective June 5, 2024, employees normally working less than 20 hours per week are eligible to participate in the Plan but are not eligible to receive an employer matching or discretionary nonelective contribution.

**Contributions**

Eligible employees may contribute under pre-tax or after-tax Roth salary deferral arrangements up to 100% of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Employer may elect, at its discretion, to contribute matching contributions equal to a maximum of 3% of an employee's eligible compensation. In addition, the Employer may contribute a discretionary nonelective contribution each year. During plan years 2024 and 2023, the Employer contributed matching and nonelective contributions of 3% each for a total possible employer contribution of 6% of compensation.

Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRC limitations.

Note 1. **Description of Plan**

**Participant Accounts**

Participant contributions are held in group annuity accounts. Each participant's account is credited with the participant's contribution and plan earnings and is charged with an allocation of administrative expenses and plan losses. Allocations are based on participant earnings, account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions and Employer contributions plus actual earnings thereon.

**Participant Loans**

Participant loans are not permitted by the Plan.

**Payment of Benefits**

Upon termination of services due to death, disability, or retirement, a participant may elect to receive the value of their account in the form of a lump-sum. Partial or installment benefits are permitted to satisfy the required minimum distribution rules of the IRC. In-service distributions are allowed at normal retirement age of 59 ½, disability, and for hardship reasons in accordance with plan provisions.

Effective October 26, 2023, the Plan was amended to allow partial distributions as a default distribution option. The Plan was amended effective June 5, 2024, to allow hardship distributions from all vested contribution sources of a participant's account.

**Forfeited Accounts**

Forfeited nonvested accounts are used to pay administrative expenses or reduce future employer contributions. There were no forfeited nonvested accounts as of December 31, 2024 and 2023 and no forfeitures used during the plan year.

Note 2. **Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are presented in conformity with accounting principles generally accepted in the United States of America (US GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

**Note 2. Summary of Significant Accounting Policies**

**Investment Valuation and Income Recognition**

Investments are reported at fair value (except for fully benefit-responsive contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer determines the Plan's valuation policies utilizing information provided by the insurance companies.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefit Payments**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses paid by the Employer are excluded from these financial statements. Fees related to benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net change in fair value of investments.

**Note 3. Certification**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedule was obtained by management and agreed to or derived from information certified as complete and accurate by AUL and Lincoln, the custodians of the Plan.

- Investments at fair value and contract value
- Net change in fair value of investments
- Interest income

**Note 4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

**Note 4. Fair Value Measurements**

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Separate Accounts:* Valued at the net asset value (NAV) of units held. NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pursuant to Accounting Standards Update 2015-07, *Fair Value Measurements*, the separate accounts measured at NAV have not been classified in the fair value hierarchy.

Participants transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment adviser reserved the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The Plan holds various separate accounts. A majority of these accounts seek to mirror the investments objectives and strategies of the underlying mutual fund or category for which the separate account is named. Certain other separate accounts are target date funds which seek capital appreciation and current income consistent with asset allocations that become more conservative over time to the specified target retirement date.

**Note 5. Investments at Contract Value**

The Plan entered into two fixed investment options under a group annuity contract issued by AUL. AUL maintains the funds in its general account. The options are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The minimum guaranteed interest rate under the contract cannot be less than 1% to 3% as calculated by AUL based on contract provisions.

Interest rates are established and declared for new contributions that will be received in a calendar quarter. The rates are based on the return expected on new investments made and held within the general account and will always equal or exceed the contractually guaranteed rate. All contributions received during the quarter will earn that declared interest rate until the end of the calendar year next following the current year. Each quarter's contributions and the corresponding interest rate are tracked together administratively in a separate quarterly interest rate pocket (Quarterly Pocket). At the end of the calendar year next following the current year, the Quarterly Pockets established in the current year are converted to an annual interest rate pocket (Annual Pocket). At the beginning of each year, a new interest rate is established and declared for each Annual Pocket. This rate is based on past general account investments, adjusted for portfolio turnover and withdrawals for benefit payments.

These investments meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by AUL, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

**Note 5. Investments at Contract Value**

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer or may allow the issuer to terminate the contract and settle at an amount different from contract value. Such events include (1) full or partial plan termination, (2) insolvency of the plan sponsor, or (3) aggregate termination in any contract year exceeding 20% of the full contract value as determined on the first day of that contract year. Total liquidation is a contingent event which cannot be initiated by plan participants and can only be initiated by the plan administrator upon termination of the Plan or complete termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would receive their account balance in accordance with plan provisions.

**Note 7. Related Party and Party-in-interest Transactions**

Parties-in-interest are defined under the United States Department of Labor Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Plan investments are managed by the Custodians and transactions with these parties qualify as party-in-interest transactions. Fees related to the management of investments are recorded against investment returns. Fees paid by the Plan for administrative recordkeeping services amounted to \$325 during the 2024 plan year. These transactions are exempt from the prohibited transaction provisions of ERISA and the IRC.

**Note 8. Income Tax Status**

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan has adopted a volume submitter pre-approved plan document sponsored by OneAmerica Financial Partners, Inc. The volume submitter sponsor has received an opinion letter dated November 22, 2017, from the Internal Revenue Service (IRS) as to the volume submitter plan's qualified status. The volume submitter opinion letter had been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan maintains the tax-exempt status for plan participants under Section 403(b).

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions that have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to IRS examination for years prior to 2021.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Note 10. Subsequent Events**

Management has evaluated subsequent events through September 17, 2025, the date on which the financial statements were available for issuance.
